

Should it not be possible to reconstruct the round:

- the casino operator shall declare the hand or hands affected by the error void; and (a)
- unless all of the players' hands are voided pursuant to this rule, the dealer's hand shall be reconstructed to (b) the extent possible and (if necessary) completed by the drawing of further cards.

Where a hand is voided under this rule the cards dealt to it shall be removed to the discard rack and any wagers on it shall be void and be returned to the player or players concerned.

All hands dealt subsequent to any such error shall stand as dealt."

Division 6 – Caribbean Stud Poker

Section 11 – Progressive Jackpot

- 41 Rule 11.6 of this division is deleted and the following rules 11.6 – 11.6C substituted:
 - "11.6 The jackpot prize pool to be distributed to players shall be established as provided by this part. The pool shall consist of:
 - all jackpot wagers, less such portion of such wagers as the casino operator, with the approval of the (a) Authority, retains; and
 - such further sum or sums as the casino operator may from time to time contribute to the pool or any part of (b) it.

- 11.6A The casino operator may (with the Authority's approval) divide the jackpot prize pool into two separate sub-pools:

 - (b) rule 3.5 (b) is amended by substituting "the amount of the Major Prize Pool" for "the amount of the jackpot";
 - (c) rules 11.9 (a) and (b) are each amended by substituting the words "Major Prize Pool" for "jackpot";
 - (d) rule 11.10 is deleted and the following rule substituted:
 - "11.10 If 2 or more hands qualify for a progressive jackpot payout from the Major Prize Pool during a round of play at the same table:
 - (a) all Straight Flushes (if any) shall first be paid in accordance with subparagraph (b) of rule 11.9;
 - (b) all Royal Flushes (if any) shall receive the greater of either:
 - (i) \$10,000, or





- (b) unless all of the players' hands are void pursuant to this rule, the dealer's hand shall be reconstructed to the extent possible and (if necessary) completed by the drawing of further cards.

Where a hand is voided under this rule the cards dealt to it shall be removed to the discard rack and any wagers on it shall be void and be returned to the player or players concerned.

All hands dealt subsequent to any such error shall stand as dealt."



 - 6.3 An electronic gaming machine shall be deemed, in the absence of it being established to the contrary, to have malfunctioned where the same hand, set of numbers or combination of symbols is displayed during three or more consecutive games on the machine.
 - 6.4 Players are required to notify the casino operator in the event of any and all machine malfunctions. Failure to do so, and the retention of any prize or free plays as a result of machine malfunction, may be considered a contravention of these rules.
 - 6.5 Should an electronic gaming machine malfunction while a player's credits remain displayed on the machine, the credits remaining shall be paid out manually.
 - 6.6 In the event of a malfunction of a jackpot meter, jackpot controller or electronic gaming machine forming part of a linked jackpot arrangement, the casino operator reserves the right to adjust the value of the jackpot prize in accordance with approved procedures.
 - 6.7 In the event that a mystery jackpot attached to a bank of gaming machines reaches its ceiling value without being triggered, the casino operator shall allocate the jackpot prize evenly among the players on the bank at the time the jackpot ceiling was reached. In the case of a mystery jackpot involving a merchandize prize, the cash equivalent of that prize shall be allocated accordingly.
 - 6.8 In the event that a stand-alone mystery jackpot reaches its ceiling value without being triggered, the casino operator shall award the jackpot to the player on the machine at the time the jackpot ceiling was reached."

- 1. That the levy rate for avocado fruit sold into the domestic market be set at 3% for the period 22 September 2001 to 30 April 2002.
- 2. That the levy rate for avocado fruit sold into the domestic market be set at 3% for the period 1 May 2002 to 30 April 2003.
- 3. That the levy rate for processed avocado fruit sold be set at 0% for the period 22 September 2001 to 30 April 2002.
- 4. That the levy rate for processed avocado fruit sold be set at 0% for the period 1 May 2002 to 30 April 2003.
- 5. That the levy rate for avocado fruit sold into the export market be set at 0 cents per 5.5kg trays for the period 22 September 2001 to 30 April 2002.

6. That the levy rate for avocado fruit sold into the export market be set at 15 cents per 5.5kg trays for the period 1 May 2002 to 30 April 2003.

1. Board levy.

1.1 Under Regulation 17 (3) of the Game Industry Board Regulations 1985, the Game Industry Board ("the board") fixes the rates of board levy (which levy rates are exclusive of goods and services tax imposed by the Goods and Services Tax Act 1985) as follows:

(a) On each deer, other than fallow deer, slaughtered in deer slaughtering premises, on the basis of hot clean carcass weight after removal of condemned parts:

16.9 cents per kilogram.

 - 9.2 For the Animal Health Board:
 - Venison 6.9 cents per kilogram.

(b) On each fallow deer slaughtered in deer slaughtering premises, on the basis of hot clean carcass weight after removal of condemned parts:

13.9 cents per kilogram.

- (c) On each killed game deer carcass received at a game packing house, zero cents per kilogram cold clean carcass weight after removal of condemned parts.
- (d) On each piece of antler from fallow deer received at a game packing house for processing or packing, on a green weight basis:

124.6 cents (one hundred and twenty-four point six cents) per kilogram.

- (e) On each piece of antler from deer other than fallow deer received at a game packing house for processing or packing, on a green weight basis:
 - 374.6 cents (three hundred and seventy-four point six cents) per kilogram.

1.2 No levy is payable when the value of the velvet grade, as defined by the Industry Agreed Grading Guidelines, is less than or equal to \$15/kg (G.S.T. exclusive).

1.3 If the Deer Slaughtering Premises ("DSP") or Game Packing House ("GPH") fails to keep accurate records relating to the board levy or to file accurate returns relating to the board levy, then the levy payable will be assessed by the board with reference to such information as the board considers fit.

2. DSPs are not required to collect levies on Tb reactors but will be required to report the number of reactor deer slaughtered to the board in their monthly returns. The levy will be waived for those Tb reactors which are identified with an official reactor tag and where they arrive at the DSP accompanied by an official permit to move.

3. A nil rate of levy applies to any farmed deer or killed game deer carcasses which are wholly condemned for any reason following slaughter or receipt into a GPH.

4. No levy is payable in respect of any one farmed deer carcass or piece of antler more than once.

5. These rates of levy come into effect on and from 1 October 2001 and apply during the 2001-2002 season and subsequently until such time as new levy rates are fixed and come into force.

6. Under Regulation 17A (1), notice is given that the board fixes the rate of additional levy payable in respect of failure to pay, or late payment of, amounts of board levy payable on or after 1 October 2001 at 10 percent of the amount of levy unpaid.

7. The additional levy for failure to pay or late payment may be applied by the board at a rate of 10 percent on the outstanding balance following expiration of the period within which payment is required to be received by the board, and is payable by the DSP or GPH concerned.

8. For the purpose of Regulation 17 (5) of the Game Industry Board Regulations 1985, the Minister of Agriculture has given express consent in writing to all rates of board levy that are higher by more than 20 percent than the rate last fixed for the levy.

9. Of the board levy, a portion will be paid to the Animal Health Board as the deer industry's contribution to the Animal Health Board's activities under the national bovine tuberculosis pest management strategy. The board levy will be broken down as follows:

9.1 For the Game Industry Board:

• Venison (fallow) 7 cents per kilogram.

• Venison (other) 10 cents per kilogram.
