## Public Trust Act 2001

### The Public Trust Common Fund Interest Rates Notice 22 August 2002

Pursuant to sections 50 (1) and 50 (5) of the Public Trust Act 2001 (“the Act”), the following notice is given.

#### Notice

**1. Title and commencement**—This notice may be cited as the Public Trust Common Fund Interest Rates Notice 22 August 2002.

(2) The determinations and revocation notified in this notice take effect from and including 17 August 2002.

**2. Interpretation**—(1) Unless the context otherwise requires:

“agency deposit” means a deposit (not being an investment deposit) held as agent or attorney;

“call deposit” means a deposit (not being an agency deposit, an investment deposit, a special deposit or a trust deposit) held in the ordinary course of administration, and determined by Public Trust to be held at call;

“deposit” means a sum of money held by Public Trust belonging to any estate, which money for the time being forms part of the Common Fund;

“investment deposit” means a deposit held at call or otherwise as an investment under section 51 of the Act;

“special deposit” means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;

“trust deposit” means a deposit held on trust:

- (i) for persons not of full age or capacity; or
- (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call (not being a special deposit).

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

**3. Rates of Common Fund interest**—(1) The rate of Common Fund interest payable on a deposit (other than an investment deposit repayable at the end of a fixed term) shall be that specified in Schedule 1 for the appropriate type of deposit.

(2) The rate of Common Fund interest payable on an investment deposit repayable at the end of a fixed term shall be that specified in Schedule 2 for the appropriate term and dollar range.

(3) Despite subparagraph (1), the rate of Common Fund interest payable on a deposit made pursuant to an enactment shall be the rate (if any) specified in the enactment.

(4) Despite subparagraph (1), in particular cases or classes of case, Public Trust and the depositor may agree on a rate of interest payable on a special deposit that is different from the rate specified in Schedule 1 and the agreed rate then applies.

**4. Revocation of notice and transitional provisions**—(1) The Public Trust Common Fund Interest Rates Notice 15 August 2002 is revoked.

(2) The rates of interest specified in Schedule 1 to this notice do not apply to any period that ends with 16 August 2002 but otherwise operate as from 17 August 2002.

(3) The rates of interest specified in Schedule 2 to this notice:

- (i) do not apply to investment deposits repayable at the end of a fixed term that commenced prior to 17 August 2002; but
- (ii) do apply to investment deposits repayable at the end of a fixed term that commenced on or after 17 August 2002.

# Authorities and Other Agencies of State Notices

## Securities Commission

### Securities Amendment Act 1988

#### The Authorised Futures Dealers Notice (No. 2) 2002

Pursuant to section 38 of the Securities Amendment Act 1988, the Securities Commission gives the following notice.

#### Notice

**1. Title, commencement and expiry**—(1) This notice may be cited as the Authorised Futures Dealers Notice (No. 2) 2002.

(2) This notice comes into force on the day after the date of its publication in the *New Zealand Gazette*.

(3) This notice expires on the close of 1 September 2003.

**2. Interpretation**—(1) In this notice, unless the context otherwise requires:

“Act” means the Securities Amendment Act 1988.

“Agreed upon procedures engagement terms” means a written agreement, in terms of the *Explanatory Foreword to Reporting Engagement Standards and Guidelines* issued by the Institute of Chartered Accountants of New Zealand, between the compliance reporter and the company to perform specific procedures with respect to the company’s compliance with rules contained in the company’s compliance manual.

“Compliance reporter” means a qualified auditor who has entered into agreed upon procedures engagement terms with the company.

“Qualified auditor” has the same meaning as in section 2C of the Securities Act 1978.

“Recognised exchange” means an authorised futures exchange or any exchange in a country other than New Zealand which is authorised by the laws of that country to operate as a futures exchange

“Regulations” means the Futures Industry (Client Funds) Regulations 1990.

“Specified futures contract” also referred to as off exchange traded futures contract, means a futures contract other than one that is made on or effected through a recognised exchange.

“The company” means **Intercontinental Financial Services Corporation Limited**.

(2) Any term or expression that is defined in the Act or the Regulations and that is used, but not defined, in this notice has the same meaning as in the Act or the Regulations.

**3. Authorisation**—(1) The company is authorised to carry on the business of dealing in specified futures contracts

(2) The authorisation is subject to the conditions that:

(a) the company does not carry on the business of dealing in specified futures contracts on behalf of any person other than a person who has entered into a client services agreement with the company, and then only in accordance with the terms of that agreement.

(b) before the company carries on the business of dealing in specified futures contracts on behalf of any person, the company has provided that person with copies of the following:

- (i) A document that clearly describes, for the prudent but non-expert investor, the risks associated with trading in specified futures contracts, including any specific risk factors that apply to trading in any of the particular contracts or classes of contracts dealt with by the company;
  - (ii) one or more documents that clearly describe, for the prudent but non-expert investor, the class or classes of specified futures contracts in which the company intends to deal on behalf of that person; and
  - (iii) an investment broker disclosure document including the information listed in section 3 of the Investment Advisers (Disclosure) Act 1996.
- (c) no employee, director, or agent of the company may give investment advice to any client unless that director, employee or agent has first provided investment adviser disclosure to that client in terms of the Investment Advisers (Disclosure) Act 1996, including the request disclosure under section 4 of the Act.
- (d) any company document that states the company has been authorised by the Securities Commission to carry on the business of dealing in futures contracts includes a statement to the effect that:
- (i) the Securities Commission’s role in authorising futures dealers is limited and does not imply approval or endorsement of the business, trading, or solvency of the company; and
  - (ii) the Securities Commission has not approved the client services agreement or any disclosure documents of the company.
- (e) the company maintains proper records:
- (i) to record dealings in respect of specified futures contracts with or on behalf of the client;
  - (ii) to record client money, funds and property held or received in connection with dealings in specified futures contracts; and
  - (iii) which are audited or reviewed, and reported on, in accordance with the Regulations and the Financial Reporting Act 1993.
- (f) the company has current agreed upon procedures engagement terms.
- (g) the company has appointed a compliance reporter.
- (h) copies of the current agreed upon procedures engagement terms, the company’s compliance manual and any amendments to these documents have been deposited with the Securities Commission.
- (i) the company’s financial statements are prepared and registered on the basis that the company is an issuer in terms of the Financial Reporting Act 1993 and are audited at least once a year by a qualified auditor under the Financial Reporting Act 1993.
- (j) the agreed upon procedures engagement terms provide for (without limitation):
- (i) the client money, funds and property records in respect of specified futures contracts to be reviewed and reported on by the compliance reporter at least once a year;

- (ii) the review of, and reporting on, the dealing practices and systems of the company against the practices and procedures set out in the company's compliance manual by the compliance reporter (including on-site inspections of the company's records and procedures), such review and reporting to be undertaken at least once in every six months;
  - (iii) a copy of the compliance reporter's reports to be sent to the Securities Commission by the compliance reporter;
  - (iv) the company to provide the compliance reporter with copies of its annual report, and monthly financial statements including a statement of financial position, a statement of financial performance, a statement of cash receipts and payments that includes receipts and payments of client monies, funds and property for the month, and a statement of its position with regard to client funds;
  - (v) the compliance reporter to give notice to the Securities Commission before or immediately upon it resigning or retiring from its position as compliance reporter.
- (k) the company sends a copy of its audited financial statements to the Securities Commission not more than three months after the end of each financial year.
  - (l) the company maintains adequate professional indemnity insurance for its business at all times.
  - (m) the company immediately notifies the Securities Commission in writing of any of the following events:
    - (i) The insolvency of the company or the bankruptcy of any of its directors.
    - (ii) If the company, or any of its directors, is convicted of an indictable offence.
    - (iii) Where a receiver, provisional liquidator, liquidator or a similar officer is appointed, or any resolution is passed or order made for the winding up or dissolution of the company.
    - (iv) Any regulatory action taken against the company whether in New Zealand or elsewhere.
    - (v) If any director or member of the senior management leaves the company or if any new director or member of senior management is appointed to the company.

#### Meat Board Act 1997

##### Quota Allocation Systems Amendment

###### Pursuant to Section 33 of the Meat Board Act

In accordance with section 30 of the Meat Board Act 1997, the New Zealand Meat Board ("Board") has completed an amendment of the Quota Allowance Allocation Systems ("Allocation Systems") administered by the Board in respect of the European Union (EU) Sheepmeat and Goatmeat Tariff Rate Quota, (EU) High Quality Beef Tariff Rate Quota, and United States (US) Beef and Veal Tariff Rate Quota.

The Board has approved amendments to New Entrant criteria provided for in the three Allocation Systems, a summary of which follows:

###### **EU Sheepmeat and Goatmeat Tariff Rate Quota, EU High Quality Beef Tariff Rate Quota, and US Beef and Veal Tariff Rate Quota**

- (1) The definition of "New Entrant" is amended in respect of a company that makes its first year application for a portion of Reserved Quota Allowance for the 2003 Quota Year or a subsequent Quota Year by removing the 25% shareholding provisions and requiring the applicant company to be genuinely independent of any holder of General or Reserved Quota Allowance during the three years prior to or during the applicable new entry period.
- (2) The New Entrant Allowances Allocation System is amended to require the three-year business plan to include details of the applicant's full time staff and the functions of that staff.
- (3) The criteria for allocations to New Entrants are specifically amended to satisfy the Board that the applicant is genuinely independent of any holder of General Quota or Reserved Quota Allowance by providing information:
  - as to any association between the applicant and any holder of General or Reserved Quota Allowance;

- as to how the granting of Reserved Quota Allowance to the applicant may benefit any holder of General or Reserved Quota Allowance.

- (4) The conditions to the allocation of Reserved Quota Allowance are expanded so that Reserved Quota Allowance allocation is conditional on the applicant being a New Entrant at the commencement of and continuing to be at all times during the applicable New Entry Period, that all information contained in the application and/or supplied to the New Entrant Allowances Committee or the Board is true and correct and no relevant information was omitted, and for the applicant to comply with its three year business plan including the quantity of qualifying product to be processed and sold by it.
- (5) Reserved Quota Allowance application forms are amended to include the amendments identified under points (1) to (4) above and to require a statutory declaration.

All amendments came in to effect as at **7 August 2002** and apply to Reserved Quota Allowance applications in respect of the 2003 Quota Year for the EU Sheepmeat and Goatmeat, and US Beef and Veal Tariff Rate Quotas (application closing date is **1 September 2002**).
