JOURNAL OF PROCEEDINGS IN THE

LEGISLATIVE COUNCIL.

WELLINGTON, MONDAY, MAY 28, 1849.

Present-

His Excellency the Lieutenant-Governor and all the Members, excepting the Hon. Dillon Bell, and W. O. Cautley.

The Council met pursuant to adjournment.
The minutes of last meeting were read

and confirmed. Dr. Greenwood presented a petition from Jonas Woodward, Congregational Minister, of Wellington, "praying the honorable Council to exclude from the Estimates all and every sum, or sums of money, intended as payment of any spiritual persons, or for any spiritual persons, or for any religious or educational purpose whatsoever."

Petition read and laid on the table. The Attorney-General moved, and Colonel M'Cleverty seconded, the second reading of the Constabulary Force Bill.

Mr. Hickson moved as an amendment seconded by Mr. Ludlam,

That the Council do now proceed with the Estimates in Committee.

Amendment put and negatived.

Original motion put and carried, and Bill read a second time accordingly.

The Attorney General gave notice that on Monday next, the 4th day of June, he should move that Council do go into Committee on this Bill.

The Colonial Treasurer, agreeable to notice, moved the further consideration of his Address to his Excellency the Lieutenant-Governor on the subject of education.

On the motion of Dr. Greenwood, seconded by Dr. Monro, a select Committee appointed to consider the question. The Committee to consist of :-

Wellington, May 31st, 1849.

I hereby protest against the appointment of a Colonial Chaplain, and against the salary of that officer being placed upon the Civil List of the Province for the following reasons:—

the Province for the following reasons:

Firstly—Because the Charter of the colony, founded upon an Act of Parliament, expressly declares that the Civil List shall be applied to the purposes of "the administration of justice and of the principal civil officers of the Government." And as the office of Colonial Chaplain cannot be included under either of the above mentioned heads, I conceive that in placing his salary upon the Civil List, the Charter of the colony is violated.

Secondly—I protest against the appointment

Secondly—I protest against the appointment because its effect is to place one religious deno-mination in connexion with the State and thus to produce sectarian jealousies and discord.

Thirdly—I protest against the appointment because I conceive that unless the principle be practically admitted, that all classes of Christians are to be supported by the State, it is unjust to take a sum out of the revenue contributed by all and apply it to the support of any one denomination.

Address of the Legislative Council of New Munster to His Excellency the Lieutenant-Governor :-

"This Council being of opinion that some le-"This Council being of opinion that some legislative enactment is necessary upon the subject of repairing Public Roads in the rural districts of this Province, respectfully request your Excellency to lay upon the table a bill to authorise the levying and collection of tolls, within the Province of New Munster, based upon the general principle, with respect to the mode of electing commissioners, determining the amount of tolls, and securing their payment, as already adopted in an ordinance of this session for levying a rate for the repairs of roads in any town."

Debate ensued.

Address adopted and presented.

His Excellency the Lieutenant-Governor gave notice that on Monday next, he should be prepared to give a reply to it.

His Excellency laid on the table a petition from Richard Driver, pilot for Otago, setting forth a statement of expenses incurred and of monies received by him in that capacity, and praying the honorable Council to raise the salary of pilot for Otago.

Petition read and considered, and salary raised accordingly.

Dr. Greenwood gave notice that on the first reading of "Road Bill" he should move

That under an economical and well regulated system of government, an import duty of £10 per cent. is sufficient not only to defray its ordinary current expenses, but to supply funds for the maintenance of roads, and the encouragement of education

On the motion of the Colonial Treasurer Council in Committee on the Estimates. Sections, comprising estimates for Otago, Wanganui, Akaroa, also for the Legislative Council and for General Charges, were con-

sidered, amended, and agreed to.
On the motion of the Colonial Treasurer Committee adjourned.

Dr. Monro gave notice that on Monday next, he should move—

"That the sum of £6000, reserved by the Charter of the colony as a Civil List for each Province, is a much larger amount than is required for the maintenance of the Administration of Justice and the Principal Civil Officers of the Government, these being the objects for which the Imperial Parliament empowered her Majesty to make such a reservation: and this

Council is further of opinion that the reservation of so large a sum effectually debars it from exercising an efficient control over the expenditure of the Province."

Mr. Ludlam gave notice that on Monday next, the 4th of June, he should move the adoption, by the Council, of the following resolution:—

That this Council is of opinion that the portion of the Parliamentary Grant spent in this Province on public roads has not been productive of so much benefit to the colony as under a different system of application it might have been, and this Council recommends to his Excellency the Lieutenaut-Governor that for the future, wherever practicable, the system of contracts should be resorted to in the construction of all public works.

Dr. Greenwood gave notice that on Monday next, he should move—

"That it is desirable in future Estimates to separate the items chargeable on the ordinary revenue from those which are to be defrayed from the Parliamentary Grant."
