JOURNAL OF PROCEEDINGS IN THE

LEGISLATIVE COUNCIL OF THE ISLANDS OF NEW ZEALAND.

Wellington, Tuesday, June 3, 1851.

Present-

His Excellency Str George Grev, K.C.B., Governor-in-Chief.

His Excellency EDWARD JOHN EYRE, Lieu. tenant-Governor of New Munster.

And the Members as on Friday, also The Hon. Francis Dillon Bell.

The Council met pursuant to adjournment. The Rev. the Colonial Chaplain read

prayers.

The following gentlemen, having taken the prescribed oath, took their seats:

The Minutes of the last meeting read and confirmed.

His Excellency laid on the table sundry letters, addressed to the Government, on the subject of the "Land Claimants Bill.

Also a Memorial from certain sheepowners and others in the district of Nelson, on the subject of the duty on tobacco used in sheep-dressing, and praying for a remission of the same.

The Colonial Secretary presented a Memorial from certain Auckland residents, on the subject of "Land Claimants Bill."

Mr. Cautley presented a petition from certain inhabitants of the district of Nelson praying that a sum of money be granted for the completion of a bridge over the Maitai River in the said town.

Also a Memorial from residents in the same settlement, setting forth the inconvenience experienced by them from the state of certain roads, and praying attention of the Council thereto.

On the motion of His Excellency the Lieutenant-Governor, the Auckland Landowners memorial ordered to be printed.

On the motion of Mr. Hickson, Council in Committee on Customs Bill.

Title-Preamble-Clauses 1 and 2 read,

amended, and agreed to.

On the motion of Mr. Hickson, consideration of Schedule adjourned to the next meeting of Council.

On the motion of His Excellency the

Lieutenant-Governor, Council resumed.
On the motion of Col. M'Cleverty, seconded by the Attorney-General, "Land Fund Appropriation Bill" read a second

On the motion of the Colonial Treasurer, seconded by the Attorney-General, the "Hutt Fencing Bill" read a first time.

Col. M'Cleverty gave notice that, at the next meeting of Council, he should move that Council go into Committee on " Land Fund Appropriation Bill."

The Colonial Treasurer gave notice that, at the next meeting of Council, he should move the second reading of "Hutt Fencing Bill."

Capt. Smith moved the second reading

The Attorney-General of New Zealand seconded the motion.

Debate ensued.

Motion adopted and bill read a second

time accordingly.

On the motion of the Colonial Secretary of New Munster, Council in Committee on " Census Bill."

On the motion of Captain Smith, agreeable to notice, seconded by the Attorney-General of New Munster, Council in Committee on " Land Claimants Bill.'

Title—Preamble—Clauses 1 and 2, read, amended, and agreed to, Clauses 3 and 4 read, and further consideration of this Bill in Committee postponed to Friday next.

On the motion of Captain Smith, Coun-

cil resumed.

On the motion of the Colonial Secretary of New Munster, further consideration of "Census Bill" adjourned in order that the bill be reprinted.

The Attorney-General of New Munster moved the second reading of "Language Ordinance Bill.'

Motion seconded by the Attorney-General of New Zealand, and agreed to, and bill read a second time accordingly.

On the motion of the Attorney-General of New Munster, Council in Committee on this bill.

Title—Preamble—and Clauses 1, 2, 4, 5, 6, read, amended, and agreed to, further consideration of Clauses 3 and 7 postponed, and on the motion of the Attorney-General of New Munster, Council resumed.

Mr. Cautley gave notice that, to-morrow, he should move for the following Returns:

"Return of the quantity of land sold by the New Zealand Company in the settlements of Wellington and Wanganui, Nelson, New Plymouth, and Otago; with the price of the same per acre or allotment. Also of the names of the several districts in each settlement, in which such lands may have been selected, together with the distance of such district from the principal town of the settlement to which it belongs; and the gross amount of land originally surveyed, and the number of acres selected in each of such districts, Also

a zeturn of all lands in cultivation, or preparation for cultivation, in the above-mentioned districts; and the amount of Scrip awarded by the New Zealand Company, or their agents, in these above-named settlements."

The Attorney-General of New Zealand, gave notice that, on Thursday next, he should move the first reading of the "Provincial Councils Bill."

Sir,—In forwarding for the information of His Excellency the Governor-in-Chief a list of the Plans and Records relating to the land in this settlement, handed over to the Government by the late Resident Agent of the New Zealand Company, it is due to Mr. Bell as well as gratifying to us to put on record the very satisfactory state in which we found them—the books in particular being entirely prepared by Mr. Bell reflect the highest credit upon him, and must evidently have been made up at great personal labor and assiduity, setting forth as they do the detail of each claim so circumstantially and clearly that every information and facility exists for the preparation of the Crown Grants without any difficulty or delay, except of course the usual investigation which will be required by the Crown Solicitor.
