JOURNAL OF PROCEEDINGS

IN THE

LEGISLATIVE COUNCIL

OF THE ISLANDS OF NEW ZEALAND.

WELLINGTON, TUESDAY, JULY 15, 1851.

Present-

His Excellency SIR GEORGE GREY, K.C.B., Governor-in-Chief.

His Excellency EDWARD JOHN EYRE, Lieutenant-Governor of New Munater, and the Members as on Friday last.

The Conneil met pursuant to adjournment.

The Rev. the Colonial Chaplain read prayers.

The minutes of the last meeting read and confirmed.

Captain Smith presented a petition from James Storah, of the district of the Hutt,

settler, on the subject of compensation for losses sustained in 1846, during the disturbances in that district.

Petition received.

Mr. Bell brought forward his question.

Whether the Land Fund Appropriation Ordinance be not repugnant to the Act 10 and 11

Vic. c. CXII, intituled an "Act to promote colonization in New Zealand, and to authorize a loan to the New Zealand Company."

The Attorney General of New Zealand replied.

On the motion of the Colonial Treasurer, seconded by Col. M'Cleverty, "Marriage Amendment Ordinance" read at hird time and passed.

The Colonial Secretary of New Zealand moved for the following returns:---

Comparative statement of the European population of the principal districts of New Zealand, according to returns drawn up at the end of each of the years 1848, 1849, and 1850.

Comparative statement of the estimated value of the Exports and Imports of New Zealand during the years 1848, 1849 and 1850.

On the motion of the Attorney General of New Zealand Council in committee on "Crown Lands Amendment Bill."

Clauses 2, 3, 7 reconsidered, smended and agreed to.

Clauses 9, 10, 11 and 12 read, emended and agreed to.

Mr. Cautley moved an addition, as entered in minutes of Council for Jay 1st, to clause 6.

Further consideration of this Billin committee postponed, and Council resumed.

His Excellency laid on the table a Bill to Appropriate the Revenue, together with Estimates, and delivered an address.

The Attorney General of New Zealand gave notice that, at the next meeting of Council "he should put a question to the Chairman of the committee appointed to report upon the amendments proposed to be made in the New Zealand Company's Land Claimants Bill, whether he can inform the Council when it is probable that the committee will be able to make a report upon the matters referred to them, also that he should move Council in committee on Crown Lands Amendment Bill."

The Colonial Tressurer gave notice that on Thursday next he should move the first reading of "Appropriation Bill."

Mr. Cutfield gave notice that when the Estimates should come under discussion he should move:—

That it is expedient that the Militia at New Plymouth be called out and trained, and that the Gevernor-in-Chief be respectfully requested to insert an item in the Estimates providing for the payment of the same at the rate of not less than two stillings per diem whilst so serving.

Also that he should move - \*\*\*

That this Council respectfully request that his Excellency the Governor in this will be pleased to place an item in the Estimates providing for the making of two or more main roads into the New Plymouth forest with a view of inducing persons to settle there.

S1R.---

I HAVE to acknowledge the receipt of your despatch No. 105, of the 26th of September last, with the copy of a letter from Mr. M'Lean reporting his proceedings in the purchase of land from the natives in the district between Wellington and Wanganui. The instructions which you inform me you had given to that officer with a view to the carly settlement of the question of the ownership of land in the district to which he alludes were, I have no doubt, judicious, and I hope it will have been found practicable to effect the contemplated arrangements. It will, however, be unavoidably necessary that the expenses thus incurred should be provided out of the general revenue of the colony, unless you happen to have any fund in hand for their liquidation. For it appears that all money derived from land sales in the colony, since the 4th July of this year, is appropriated under the 10 & 11 Victorize cap. 112, sec. 20, to the payment of the sums therein mentioned to the New Zealand Company, except so much as may be applied to surveys and emigration. Until you receive further instructions on this subject it will be heressary that you should bear this caution in mind in all negotiations with a view to the extinction of native titles in land.

My DEAR SIR,-

I ENCLOSE you the analysis of the specimen of New Zealand coal.

I consider it to be of a very good quality, the composition being nearly the same as the Midlothian and Fifeshire Parrot coals; the proportion of sulphur is about the average, certainly not greater, than in many of our own coals. I have no doubt, therefore, that it will answer the purpose of smelting copper ores, or those of any other metal.
