PROCLAMATION.

By His Excellency EDWARD JOHN EYRE
Esquire, Lieutenant-Governor of the
Province of New Munster, in the
Islands of New Zealand, &c., &c.,
&c.

WHEREAS, by an Ordinance enacted by the Lieutenant Governor of New Munster, with the advice and consent of the Legislative Council thereof, intituled the Town Roads and Streets Ordinance, Session 1, No. 7, it is declared that it shall be lawful for the Lieutenant Governor, with the advice of the Executive Council, to proclaim from time to time the Towns within which the provisions of the aforesaid Ordinance shall come into operation, upon a requisition to that effect from a majority of the Magistrates of the district in which such Town is situated.

And whereas, a majority of the Magistrates of the district of Wellington, have made a request that the said Ordinance should be brought into operation within the limits of the Town of Wellington.

Now therefore I, the Lieutenant Governor of the Province of New Munster, with the advice of Executive Council thereof, do hereby declare that the said Ordinance shall, from and after the date hereof, be brought into operation within the limits of the Town of Wellington as the same are laid down in the certified copy of the Plan of the said Town, filed in the Office of the Colonial Secretary of New Munster.

PROCLAMATION.

By His Excellency SIR GEORGE GREY, a Knight Commander of the most Honorable Order of the Bath, Governor and Commander-in-Chief in and over the Islands of New Zealand, and Governor of the Provinces of New Ulster and New Munster, and Vice Admiral of the same, &c., &c., &c.

WHEREAS, by an Ordinance passed by the Lieutenant-Governor of New Zealand, by and with the advice and consent of the Legislative Council thereof, intituled "An Ordinance to amend the Customs Ordinance, Session I, No. 3, and the Customs Amendment Ordinance, Session III, No. 6," No. 8 of Session VIII, 1846, it is amongst other things enacted that "it shall be lawful for His Excellency the Governor (or Lieutenant-Governor) from time to time by Proclamation to appoint and define proper places within the several ports of the colony to be legal Quays or Landing Places for the lading and unlading of goods."

Now therefore in pursuance of the power in me vested by the said in part recited Ordinance, I do hereby proclaim and declare that part of the Beach of Lambton Harbor, extending from the point on the said Beach at which Rhodes' Wharf begins to that point at which Plimmer's Wharf ends, to be a legal Quay or Landing Place for the lading and unlading of goods.

PROCLAMATION.

By His Excellency SIR GEORGE GREY, a Knight Commander of the most Honorable Order of the Bath, Governor and Commander-in-Chief in and over the Islands of New Zealand, and Governor of the Provinces of New Ulster and New Munster, and Vice-Admiral of the same, &c., &c., &c.

WHEREAS by an Ordinance passed by the Governor-in-Chief of the New

Zealand Islands, by and with the consent of the Legislative Council thereof, intituled, "An Ordinance for the Naturalization of certain persons in the Islands of New Zealand," it is enacted, "that all and singular the persons who shall be declared to come within the operation of this Ordinance by any Proclamation to be issued in that behalf by His Excellency the Governor-in-Chief, shall be deemed and taken until the next Session of the General Legislature, within the Islands of New Zealand, to be natural born subjects of Her Majesty, as fully to all intents and purposes as if their names had respectively been inserted in the Schedule," annexed to the aforesaid Ordinance.

Now therefore, I, the Governor-in-Chief in pursuance of the power and authority in me vested by the said in part recited Ordinance do hereby proclaim and declare that the persons whose names are underwritten shall be deemed and taken to be natural born subjects of Her Majesty from the date set opposite their names respectively until the next Session of the Legislative Council of the Islands of New Zealand.

NOTICE.

AT any Warehousing Port within the Islands of New Zealand, the Collector

or Sub Collector of Customs is authorized to issue certain quantities of Tobacco free of duty for Sheepwashing upon the application of any Sheepowner, or his known Agent, having first taken a declaration that he has a certain number of Sheep infected with the Scab; and for the purpose of washing them he requires lbs. of Tobacco. The Collector having ascertained from the Commissioner of Crown Lands that the declaration is correct may issue a warrant to the Locker to damage the Tobacco, by having it thoroughly saturated with Spirits of Tar or Turpentine, and then deliver it from the Warehouse free of Duty.

FORM OF DECLARATION.

I, A. B., do solemnly and sincerely declare that I have (or C. D. has) Sheep at , which require washing for the Scab, and for which purpose I require (or he requires) lbs. of Tobacco; and I make this solemn declaration conscientiously believing the same to be true.

IMPORTATION AND SALE OF GUN- POWDER.

HIS EXCELLENCY THE GOVERNOR-IN-CHIEF directs it to be notified for general information that the following Regulations have been established

with regard to the landing, sale, or removal of Arms, Gunpowder, or other Warlike Stores :—

No person is permitted to import, land, sell, or remove Arms, Gunpowder, Shot, or Warlike Stores, without a license previously obtained under the hand of the Colonial Secretary of the Province; or some other person duly authorised :

Any person desiring to purchase Arms, Gunpowder, or Shot, for sporting purposes *must previously* apply to the Resident Magistrate of the District, who will authorize, if he think fit, the purchase from the holder of a license above referred to, of such a quantity as may be stated in a certificate to be granted by such Resident Magistrate :

A Register of the persons obtaining such certificates, and the quantities of Gunpowder, &c. they may be authorized to purchase, will be kept by the Resident Magistrate in each district.
