WHEREAS, by an Ordinance passed by the Governor-in-Chief of the New Zealand Islands, by and with the consent of the Legislative Council thereof, intituted "An Ordinance for the Naturalization of certain persons in the Islands of New Zealand," Session XI, No. 9, it is enacted that all and singular the persons who shall be declared to come within the operation of such Ordinance by any Proclamation to be issued in that behalf by His Excellency Governor-in-Chief, shall be deemed and taken, until the next Session of the General Legislature within the Islands of New Zealand to be natural born subjects of Her Majesty:

Now therefore, I, the Governor-in-Chief, in pursuance of the power and authority in me vested by the said in part recited Ordinance, Do hereby proclaim and declare, that the persons whose names are underwritten shall be deemed and taken to be natural born subjects of Her Majesty from the dates set opposite their names respectively, until the next Session of the General Legislature of the Islands of New Zealand, as fully to all intents and purposes as if their names had been inserted in the Schedule annexed to the said Ordinance.
