PROCLAMATION.

By His Excellency Major-General George Dean Pitt, Knight of the Royal Hanoverian Guelphic Order, Lieutenant-Governor of the Province of New Ulster, &c. &c. &c.

HEREAS by an Ordinance enacted by the Lieutenant Governor of New Zealand with the advice and consent of the Legislative Council thereof, Session 8, No. 4, intituled 'The Savings' Bank Ordinance,' provision was made for the management of all Savings' Banks within the Colony which should be proclaimed to come within the op ration of the said recited Ordinance.

And, whereas, a Savings' Bank hath been established at Auckland, and it is expedient that the said Bank should be brought within the operation of the Savings' Bank Ordinance.

Now, I, the Lieutenant-Governor, do hereby proclaim and declare, that from and after the date hereof, the said Savings' Bank to be called the "Auckland Savings' Bank" shall be deemed and taken to come within the operation of the said recited Ordinance.

Land Commissioner's Office, Auckland, February 21, 1848.

HENRY MATSON, a Commissioner appointed for examining and reporting on all Claims to Compensation preferred according to the provisions of an Ordinance, Session 7, No. 22, intituled—"An Ordinance to authorise compensation in Colonial Debentures to be made to

certain Claimants to land in the colony of New Zealand," do hereby notify that I will investigate the undermentioned Claims at the Council Chamber, at 11 o'clock, a.m., on Wednesday, the lat proximo.

Case No. 54—Pre-emption certificate, No. 233— Peter Imlay, of Twofold Bay, settler.

990 acres. Nine hundred and ninety acres of land, situated on the Manukau, bounded on the west by land belonging to the chief Wetere, on the east by land purchased from the Natives, by Mr. W. Alleged to have been purchased from the na-tive chiefs Te Tara and Makuru, and Hone-

tana.

Consideration-£17 cash, 20 blankets, 1 double barrelled Gun, 1 Cloak, 1 superfine Coat, do pair of Trowsers, 1 Cap, 2 Muskets.
