HENRY MATSON, a Commissioner appointed for examining and reporting on all Claims to Compensation preferred according to the provisions of an Ordinance, Session 7, No. 22, intituled "An Ordinance to authorise Compensation in Colonial Debentures, to be made to certain Claimants to Land in the Colony of New Zealand," do hereby notify that I will investigate the undermentioned claims at the Council Chamber on Monday, 3rd April, 1848, at Ten o'clock in the forenoon, and the investigation will be continued until the 22nd April.

Case No. 65-Pre-emption certificate, No. 94-Adam Chisholm.

One thousand two hundred acres 1200 acres. of land, situated at Okuhukura, or Lucas Creek, on the east side, commencing at a place called Teanakotoraru on the Waitemata river, ascending the ridge of Kiriahura till it reaches the source of Kiriahuru, or Hellyer's creek, running thence along the ridge till it joins the source of the Otahu creek, through the said creek to Okahu-kura, or Lucas's creek, till it joins land being purchased by Mr. Langford, following the boundaries of Mr. Langford's land, until it again joins Lucas's creek, embracing the whole of Hellyer's creek, and following the windings of the same, until it reaches Te Tikoro, whence it continues to wind its course along the Wartemata river, joining the Anakorura.

Alleged to have been purchased from the native chiefs Taraia, Huki and others.

Consideration — 10 blankets, 2 coats, 2 pairs trowsers, 4 canisters powder, 4 fowling pieces, cash, £10.

Case No. 67-Pre-emption certificate, No. 170-

Robert White and George Willson. 1000 acres: One thousand acres of land, situated on the right bank of the river Okura, Kaurinui by name, bounded on one side by the above named river, on another by a creek named Huruhuru, on another, by the ridge Paparaurau, and on the other by land named Waipapa, being a line from Paparaurau to the river Okura.

800 acres. Eight hundred acres of land, situated at the head of the Waitemata, at a place called Whatiki, being bounded by the Kaipara road on the south, on the west and north by Maori land, and on the east by land belonging to Harris and Hatfield.

Case No. 71-Pre-emption certificate, No. 202-Thomas Russell, carpenter, Auckland.

1000 acres. One thousand acres of land situated on a small fresh water creek at the head of the Waitemata, and bounded on one side by land belonging to Mr. John Moore, on two other sides by Mr. John Fair, and on the other side by the natives.

Alleged to have been purchased from the native chiefs, Tamati, Reweti, Taipari, Tautari.

Consideration-£32, paid in goods.

Case No. 72 - Pre-emption certificate, No. 173 - William Hay.

990 acres. Nine hundred and ninety acres of land situated near the source of the Manukau, bounded on one side by a creek or swamp named Mangapikopiko, on another by a place named Mangapu, on another by land belonging to the chief Te Rau, named Tanatahi, and on the other by a line from Mangapu, nearly parallel to a place called Poponui.

Alleged to have been purchased from the

native chiefs Te Rau, Wiremu. Tenawe, Wiremu Haungohi, Ruatara, and others. Consideration—1 horse, 16 blankets, £17 cash, 50 figs tobacco.

Case No. 73 - Pre-emption certificate, No. 120-Adam Chisholm.

1000 acres. One thousand acres of land commencing at a place called Maungatahi, on the river Manukau, running thence through Waihouhai to Te Pukepuke, to a stake erected by the chiefs, striking thence in a straight line to a place called Whakarau, and thence to Ohiwairoa, on the Manukau river, being bounded on one side by the aforesaid river.

600 acres. Six hundred acres of land, situated in the district of Wahn, bounded on the east by government land, on the south by Manukau harbour, on the north and west by native lands.

George Hart. Eight hundred acres of land 800 acres. situated at Papakura, and called Kowahu, being immediately outside the government line, and bounded by the land of the native chief Te Roe.

600 acres. Six hundred acres of land, situated at Manukau, commencing at the creek Otetore, from theace to Titirangi, from theace along the Auckland road to a stake, thence to a stake bearing east by north, thence to the creek Outorou, and thence along the Manukau coast to the starting point.

Alleged to have been purchased from the cative chief Keene. Consideration—£15 cash.

1200 acres. One thousand two hundred acres of land, situated west of the Wahu on the Mannkan.

900 acres. Nine hundred acres of land, situated near Titirangi, bounded on the east by a line from a stake in the Auckland road to the Magurewa creek, on the south by land in possession of Mr. W Porter, called Oripia, on the west by a line from One Whero Whero, to the Wairoa creek, and on the nor h by land proposed to be purchased in favor of Mr. Porter.

Case No. 79—Pre emption certificate, No. 159—W. F. Porter.

800 acres. Eight hundred acres of land situated near the Wahn creek, bounded on the east by a line from a stake in the Auckland road to the Mangurewa creek, on the south by land in possession of Te Kawap, on the west by land in Possession of Te Kawap, and on the North by the Wahu creek.
