VICTORIA REGINA.

HEREAS, by various Acts now in force relating to the payment and enrolment of Chelsea and Greenwich Pensioners, it is lawful for Her Majesty from time to time, by Warrant under the Royal Sign Manual, to fix the number of men to be enrolled in our Colonies as a Local Force, Our Will and Pleasure therefore is, that, of the said Pensioners residing in the colony of New Zealand, there shall be enrolled as a Local Force, for the preservation of the Public Peace,

in pursuance of the provisions of the said Acts, Six Hundred Men; in addition to the number of men authorised to be enrolled in the United Kingdom.

> Given at our Court at St. James's, this thirtieth day of September, one thousand eight hundred and forty-seven, in the eleventh year of our Reign.

HENRY MATSON, a Commissioner appointed for examining and reporting on all Claims to Compensation preferred according to the provisions of an Ordinance, Session 7, No. 22, intituled "An Ordinance to authorise Compensation in Colonial Debentures, to be made to certain Claimants to Land in the Colony of New Zealand," do hereby notify that I will investigate the undermentioned claims at the Council Chamber on Thursday, 1st June, 1848, at ten o'clock in the forenoon, and the investigation will be continued until the 23rd June.

The cases will be heard in the order in which they stand in the following list, and all parties are hereby summoned to be in attendance, with their documents and witnesses, original deeds, (and translations thereof, if in the Maori language,) relating to their claims, with copies of the same, the latter to remain with the Commissioner.

Claimants are also hereby informed, that if they do not by themselves, or an authorised agent, exhibit evidence in support of their claims to the Commissioner, at the above mentioned place, during the period stated, the said claims will be reported upon, and no grants recommended.

HENRY MATSON, Commissioner Case No. 82—Pre-emption certificate, No. 212
Thomas Jackson.

1000 acres. One thousand acres of land, situated at Manukau, called Pukake, bounded on the north by land purchased by Mr. Peter Imlay, on the south by land still retained by the natives, on the east by Mr. Fairburn's land, and on the west by land belonging to Wetere, and by the sea.

Alleged to have been purchased from the native chief Mohi.

Consideration—two horses, ten blankets, one steel mill.

Case No. 83—Pre-emption certificate, No. 123
Maurice Kelly.

800 acres. Eight hundred acres of land situated near the head of the river Waitemata, commencing at a creek called Paremarema, from thence along the front of the river as far as the place known by Europeans as the saw mills fall, named by the natives Kotewai, from thence in a straight line to Paremarema creek, from thence along the creek, making up the quantity.

Alleged to have been purchased from the native chiefs Tautari and Whangaroa.

Consideration—£30 worth of planks.

Case No. 84—Pre-emption certificate, No. 230
Mary Fair.

800 acres. Eight hundred acres of land, named Hokowhetu, bounded on one side by land purchased by the late John Fair, by the

land of Messrs. Langford and Gardiner, upon situated above the river Wahu, bounded on one another side by the land of Maurice Kelly, and on the other side by land belonging to the natives.

Alleged to have been purchased from the native chiefs Tautari and Whangaroa. Consideration—One vessel with all appurtenances.

Case No. 85-Pre-emption certificaté, No. 157 John Brigham.

999 acres. Nine hundred and ninety nine acres of land, situated on the south east bank of the island of Waiheke, bounded on one side by the Bay Okuhu, on another by land belonging to Mr. Chisholm, on another by the ridge Kumukumu, and on the other by a line from a pohutukawa, to a stake erected by native

Alleged to have been purchased from the native chiefs Matiu, Te Mapu, Tahu, Tauru, Te Kokohau, Te Whararau, Tamati Waka.

Consideration-One vessel with two masts and all appurtenances, together with a boat.

Case No. 86-Pre-emtion certificate, No. 198 John Brigham.

950 acres. Nine hundred and fifty acres of land situated on the north-east bank of Waiheke, bounded on one side by the ridge Kumu Kumu, on another by a line from the said ridge to a place named Kopakarore on the sea shore, and on the other by the sea of Waiheke.

Alleged to have been purchased from the native chiefs Ruinga Kahukoti, Wiremu Hoete, Raniera Matuiti, Te Kaihe.

Consideration-One boat, sails and all other appurtenances complete, four double guns, two muskets, four canisters of powder, four boxes of gun caps, £10 cash.

Case No. 87-Pre-emption certificate, No. 82 Thomas M'Gauran.

20 acres. Twenty acres of land, situated about sixteen miles from Auckland, at the head of a salt water creek or inlet of the Waitemata River towards its source, and intersected by a fresh water stream, and called by the native chiefs Paremarema.

Alleged to have been purchased from the native chiefs Tautari, Whanganui.

Consideration-One gun, two pairs trowsers, one coat, and five shillings.

Case No. 88-Pre-emption certificate, No. 171 Robert Thomson.

980 acres. Nine hundred and eighty acres of land, situated on the river Wahu, bounded on one side by land belonging to Mr. Henderson, on two other sides by land belonging to the chief Reweti, and on the other by the river

Alleged to have been purchased from the native chiefs Kawau, Reweti, Hira, Paora. Consideration—1 boat with oars and sails, 10 blankets, 10 cartouche boxes, 5 boxes, 4 casks powder, 1 bag shot, 1 cloak, £10

Case No. 89-Pre-emption certificate, No. 154 Robert Thomson.

800 acres. Eight hundred acres of land,

side by land belonging to Mr. Thomas Henderson, and on the other by the range of mountains running parallel to the said Mr. Henderson's line, on the other two sides by Maori land called Horotou.

Alleged to have been purchased from the native chiefs Kawau, Reweti, Hira, Paora. Consideration—not stated.

Case No. 90-Pre-emption certificate, No. 209 J. A. Langford and F. Gardiner.

700 acres. Seven hundred acres of land, situated on the left of Lucas Creek, the boundaries as follows: commencing at a kauri tree on the margin of the creek running from thence to a fresh creek called Te Horo, and from thence in a westerly direction to the top of the range until it reaches a mark in the gound, and from thence along the top of the said range running north-east to another mark in the ground, and from thence in a line running east by south down the aforesaid kauri tree, on the bank of the creek.

Alleged to have been purchased from the native chiefs.

Consideration-

Case No 91-Pre-emption certificate, No. 115 Florence Gardiner and John Alfred

Langford. Three hundred acres of land, 300 acres. situated at the head of Lucas Creek, or Okahu Kura, and called Whanau Kawariki, on the river Waitemata, commencing on the west bank of the Okahukura, at a kauri tree from thence by a line running north-west to a mark in the ground from thence to a marked kahikatoa tree, then by a direct line along several marked trees down to a fresh water creek, from thence following the course of the creek until it disembogues into the Okahu-

Alleged to have been purchased from the native chiefs.

Case No. 92-Pre-emption certificate, No. 80 Clement Partridge and Joel Samuel Polack. 800 acres. Eight hundred acres of land, situated ten miles or thereabouts from Auckland up the river Waitemata on the left hand side of a creek commonly called "Lucas Creek," the native name of which is Okahukura and having about  $1\frac{1}{2}$  or 2 miles or thereabouts frontage to the creek, and having small runs of water into the said creek known by the native names of Kikitungiao, Te Marama, Kaiaka, &c., &c., and extending back inland to certain land-marks erected thereon at a suitable distance of from  $\frac{1}{2}$  to  $\frac{3}{4}$  of a mile or thereabouts.
