#### PROCLAMATION.

By His Excellency Major-General, GEORGE DEAN PITT, Knight of the Royal Hanoverian Guelphic Order, Lieutenant-Governor of the Province of New Ulster, &c., &c., &c.

W HEREAS by an Ordinance enacted by the Lieutenant Governor of New Zealand, with the advice and consent of the Legislative Council thereof, Session 7, No. 17, intituled "An Ordinance to repeal the Cattle Trespass Ordinance, and to provide for the summary recovery of compensation for damage done by cattle trespassing,"—it is amongst other things enacted that "if any cattle shall be found wandering at large in any street or public place within the limits of any Town or Village, which shall be proclaimed by the Governor to come within the operation of this present provision, the owners thereof, shall forfeit and pay for every head of cattle so wandering, any sum not exceeding five shillings, to be recovered in a summary manner."

And whereas it is expedient that the said provision of the said recited Ordinance should be extended to the Villages of Howick, Panmure, Otahuhu and Onehunga.

Now, therefore, I, the Lieutenant-Governor, do hereby proclaim and declare that on and after the 1st day of February, 1849, the said Villages of "Howick," "Panmure," "Otahuhu," and "Onehunga," the boundaries whereof respectively are hereafter particularly described, shall come within the operation of the said provision of the said recited Ordinance. Boundaries of Howick.

The northern boundary commences at the junction of Ridge Road and Picton Place, and thence follows the northern sides of allotments Nos. 31, 30, 29, 27, 26, 25, 24, and 23, of Section No. 1, to a stream forming the northern boundary of the eastern portion of section No. 1. Thence it follows the course of the said stream to the northern side of Uxbridge Street, at allotment No. 1, of section No. 1, and thence continues along the northern side of Uxbridge Street to the shore of the Gulf of the Thames. From the point last described it follows the shore of the Gulf, eastward, to the north-eastern angle of allotment No. 7, of section No. 6.

The eastern boundary commences at the point last mentioned, and proceeds thence along the eastern boundary of section No. 6, and the exterior boundaries of sections Nos. 5 and 4 to the south-west angle of allotment No. 17 of section No. 4. Thence it follows the eastern sides of Sale Street and Papakura Road to the junction of Papakura Road with Union Road.

The southern boundary commences at the junction of the roads last mentioned, and follows the southern side of Union Road to its junction with Ridge Road.

The western boundary commences at the junction of the last-mentioned road, and follows the western side of Ridge Road to its junction with Picton Place first mentioned.

Bounded on the north by the northern side of a road forming the northern boundary of sections of Nos. 1, 2, and 9.

Bounded on the east by Crown land, being the eastern boundary of sections Nos. 9, 10, 11, and 12.

Bounded on the south by the southern side of a road forming the southern boundaries of sections Nos. 7, 8, and 12.

Bounded on the west by the western side of a road leading from Panmure to Pukaki.

Boundaries of Onehunga.

Bounded on the north, by the northern side of a road running north of Sections Nos. 1, 2, 3, 4, 32, and 34.

Bounded on the east by the eastern side of a road forming the eastern boundary of Sections Nos. 4, 8, 12, 16, and 27.

Bounded on the south by the shore of Manukau harbour.

Bounded on the west by the western side of Section No. 32.

#### DEPASTURING LICENSES WITHIN PROCLAIMED HUNDREDS.

The above articles are to be delivered at the Hospital at the expense of the Contractor, in uch quantities as may be ordered by the Colonial Surgeon ; the fresh meat, bread and milk daily, but the other articles may be furnished in larger quantities, not exceeding a month's supply at a time, as may be arranged between the Colonial Surgeon and the Contractor. The quality of the articles to be subject to the approval of the Colonial Surgeon, who will have the power of refusing such articles as he may deem unfit for use; and in the event of the Contractor failing to replace them with other articles of a proper quality, the Colonial Surgeon will have the option of purchasing others at the risk of the Contractor. Payment for the supplies to be made monthly. Security will be required for the due fulfilment of the contract; and the tenders must be ac-companied by a notification of the consent of the parties nominated as sureties. Any tender deficient in this respect, or not made out on the proper printed forms will be rejected by the Board of Officers appointed to open them.

CONDITIONS :

Samples of the various articles will have to be submitted for inspection.

The contractors will be required to deliver the different supplies from time to time, at such places, and in such quantities, as may be indicated by the Colonial Secretary.

The Government does not bind itself to accept the lowest or any of the tenders sent in.

Payment for any of the above supplies will be made at the end of each month.

Tenders to be in duplicate, sealed and endorsed, "Tender for Supply of Stores." In the event of a difference of opinion between the contractor and the officer receiving, the supplies, as to the quality, the same is to be decided, in cases where the article is not of a perishable nature, by a board of survey, composed of persons named by the Government, according to the practice of the service. If the board shall decide that the article is not of a proper quality, it must be immediately replaced by the contractor; failing which, it will be procured by the department requiring it, and the expense charged to the contractor.

In cases where the article is of a perishable nature, or in which from some other cause injury would be sustained by waiting for a board of survey, the head of the department or officer in charge for whom the supplies are to be received, shall have power to reject such article or articles as are of inferior quality to the samples approved, and to purchase others at the expense of the contractor.

The tenders to contain the names of the tenderers and their places of residence at length, and to be accompanied by a letter signed by two respectable sureties, engaging to become bound in a penalty of £100 for the due fulfilment of the contract, if the tender be accepted.
