EXTRACT FROM BRIGADE ORDERS.

Anckland, 4th April, 1850.

THE first Inspection of the New Zealand Enrolled Pensioners having been concluded, under the Superintendence of Lieutenant-Colonel WYNYARD, C.B., Commanding the 58th Regiment, and the result having been

submitted to His Excellency the Major Co Commanding in New Zealand, in a most favourable and satisfactory report, Major-General PITT feels it his duty to express both to the Officers, Non Commissioned Officers, and men, his unqualified approbation and warmest thanks for their steady behaviour and soldierlike demeanour during the time that they have been called out for exercise.

Considering the very limited period the force has had for training for the last three years, (only eight days in all), great credit is due to the Commanding Officers of both Battalions, since they must have exerted much circumspection, and judicious encouragement to have enabled them to bring their corps into the field, in such a high state of military discipline.

The Staff Officers of Divisions are also entitled to much praise for the great zeal displayed by them during the training days at Squad Drill, &c., &c., which attention contributed so much to the steady and soldierlike appearance of the Battalions under arms.

In conclusion, the Major-General directs that the Commanding Officers will assure the Officers, Non-Commissioned Officers and Men of their respective Battalions, that the entire satisfaction of His Excellency at the result of this inspection, has been duly reported to the highest authority.

A LL unlicensed owners of unenclosed land within any Proclaimed Hundreds, desirous of enjoying, under the provisions of the 29th clause of the Crown Lands' Ordinance (No. 1, Sess. 10), a proportionate right of pasturage upon the Crown Land, are requested to send in written applications for the same to the Wardens of their respective Hundreds.

These applications to be accompanied by the written consent of the applicants to add such unenclosed land, for pastoral purposes, to the General Stock of Common Waste Land in the Hundred, and to submit to such rules, in reference thereto, as the Wardens may duly make.

In addition to the right of pasturage referred to, the applicants will be enabled to have, under the authority of the Wardens, all unlicensed Cattle trespassing upon such unenclosed land, impounded according to law.
