### PROCLAMATION.

By His Excellency Sir George Grav, K.C.B., Governor-in-Chief in and over the Islands of New Zealand, and Governor of the Provinces of New Ulster and New Munster, and Vice Admiral of the same, &c., &c., &c.

HEREAS, by an Ordinance enacted by the Lieutenant-Governor of New Zealand, with the advice and consent of the Legislative Council thereof, Sess. 8, No. 4, intituled "The Savings Bank Ordinance" provision was made for the management of all Savings Banks within the Colony which should be proclaimed to come within the operation of the said recited Ordninace: and whereas a Savings Bank hath been established at New Plymouth, and it is expedient that the said Bank should be brought within the operation of the Savings Bank Ordinance:

Now, I, the Governor of the Province of New Ulster, do hereby proclaim and declare that from and after this date the said Savings Bank, to be called the "New Plymouth Savings Bank," shall be deemed and taken to come within the operation of the said recited Ordinance.

Given under my Hand and issued under the Public Seal of the Province of New Ulster, at Auckland, this 3rd day of June, in the year of our Lord one thousand eight hundred and fifty.

SIR—I have the honor to acknowledge your despatch, No. 84, of the 7th of July last, accompanied by Petitions to Her Majesty from the European Inhabitants of the district of Auckland, and also from various Natives, against the introduction of Exiles, or Convicts with tickets of leave, into New Zealand

I have to inform you that these Petitions have been duly laid before the Guren.

I am enabled to state that the wishes of the Petitioners are anticipated, for, as you will have learned from my other despatch, No. 77, of the 26th instant, there is no intention of sending any Convicts to New Zealand.

Port Ross, Auckland Island, February 21, 1850.

Sir,—I have the honor to inform Your Excellency of my arrival at this port, in the ship "Samuel Enderby," and of my having subsequently been joined by the "Fancy," and "Brisk," belonging to the Southern Whale-Fishery Company, bringing together to this settlement, 51 persons, including women and children.

I am well satisfied with these Islands as a station, from whence to prosecute the Whale Fishery, and I find the soil, climate, and harbours better than I had anticipated.

It will afford me much pleasure to welcome any vessels which may visit this port, and to maintain, as frequently as circumstances may admit, a communication with the neighbouring colonies.

# BYE LAWS AND NOTICES FOR THE HUNDRED OF ONEHUNGA.

HEREAS it appears to the Wardens of Onehunga that the Regulations issued by them for depasturing the Crown Waste Lands therein described cannot be satisfactorily enforced without a knowledge of the stock, their description and brands, which belong to licensed persons (very few of whom have made to them any return), they deem it now needful to issue the following Notice and Bye Laws, to enable them to exact the required information.

#### BYE LAWS:

- 1. That all persons whose names appear in the published list as holders of licenses for the hundred of Onehunga shall make a correct return of their stock in writing to the Wardens of said hundred, and according to the following Schedule, within (35) thirty-five days after publication hereof in the Government Gazette, under penalty of (20) twenty shillings.
- 2. All persons holding a Depasturing License, upon a demand made in writing by any two of the Wardens of said hundred-(on any day to be fixed by said person or persons to whom such demand be issued not exceeding (7) seven days from time of such demand) -shall muster, or cause to be mustered, in his or their stockyard, or other convenient paddock for that purpose, all such stock to him or them belonging as are depastured, or may be depastured, on any of the Waste lands of said hundred, to the intent and purpose that the said stock be examined by some one of said Wardens or other person thereto deputed by any two of them, under penalty of (20) twenty shillings, payable for each refusal or neglect thereof. Provided that such person or persons shall not be made to comply with such demand more than once in every three months.
- 3. That any or all stock, the property of licensed persons, prohibited from depasturing on the Northern portion of the hundred of Onehunga, or authorized depasturing stock unbranded, or the brands whereof have not been registered as required, or on which the assessment or assessments made have not been duly paid, shall be impounded and pay a fine of one shilling and sixpence per head on each impounding to the funds of the hundred, in addition to such pound fees and charges payable in such pound wheresoever they may be impounded.
