The sittings of my Court will be continued at Auckland, for the purpose of receiving Evidence upon the under-mentioned Claims, until the 1st day of July next, after which date no further investigation of the said Claims will take place.

The Claimants are also hereby informed, that if they do not, by themselves or an authorised agent, exhibit Evidence in support of their Claims to the Commissioner, during the period above-stated, the said Claims will be reported upon, and no Grants recommended.
