By His Excellency ROBERT FITZROY, Esquire, Governor of the Colony of New Zealand and its Dependencies, and Vice Admiral of the same, &c., &c., &c.

THE GOVERNOR, do hereby advertise, and proclaim that, at Eleven o'clock, on Tuesday, the 30th day of January, 1844, the Colonial Treasurer will put up to Auction at the Treasury, the undermentioned Lots, on the terms and conditions and under the provisions of an Act of Parliament, passed in the fifth and sixth years of the reign of Her Majesty Queen Victoria, chap. 36, entituled "An Act for regulating the Sale of Waste "Lands belonging to the Crown in the Australian "Colonies."

GOD SAVE THE QUEEN!

PROCLAMATION.

By His Excellency ROBERT FITZROY, Esquire, Captain in Her Majesty's Royal Navy, and Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice Admiral of the same, &c.,

HEREAS, by an Ordinance enacted by the Governor of New Zealand, with the advice and consent of the Legislative Council, Session 3, No. 1, intituled "An Ordinance for establishing a Supreme Court," the Governor of New Zealand is empowered, with the advice of the Executive Council, by Proclamation, from time to time, to divide the Colony into Districts for the purposes of the said recited Ordinance, and the limits of such Districts from time to time to alter, as occasion may require.

Now I, the Governor, with the advice of the Executive Council, in pursuance of the authority aforesaid, do hereby proclaim and declare, that for the purposes of the said Ordinance, the Colony shall be divided into two Districts, to be called the Northern and Southern Districts.

And that the Northern District shall include all that portion of the Northern Island of New Ulster lying to the northward of a line, commencing from a point on the coast, two miles, in a straight line, southward of the mouth of the river Wairoa, in Hawke's Bay, thence in a straight line to the highest summit of the mountain usually called Tongarero, thence along the highest ridge tween that mountain and the summit of Mount Egmont, from the summit of Mount Egmont to the source of the Otumates, and along the middle of the Otumatua to the sea, and also so much of the sea adjacent thereto as lies within the jurisdiction of the Vice-Admiral of New Zealand, and further that the said District shall comprise and include all those Islands contiguous to the Colony of New Zealand, and commonly known by the name of the "Chatham Islands.'

And that the Southern District shall include all that portion of the said Island of New Ulster which lies to the southward of the aforesaid line, and also the whole of the Islands of New Munster and New Leinster, together with so much of the sea adjacent thereto as lies within the jurisdiction of the Vice-Admiral of New Zealand.

And whereas by the said recited Ordinance the Governor is also empowered to assign to each of such Districts a Judge, or Judges, who shall have within the same all the powers and juris-

diction thereby given to the Supreme Court. Now therefore I, the Governor, in pursuance of such authority, do hereby proclaim and declare that I have assigned to the Northern District,

WILLIAM MARTIN, Esquire, Chief Justice of the said Court; and to the Southern District,

HENRY SAMUEL CHAPMAN, Esquire, a Judge of the said Court.

And whereas it is provided by the said recited Ordinance, that there shall be holden Circuit Courts for the despatch of civil and criminal business of the Court, before one of the Judges thereof, at such places and at such times as the Governor shall, with the advice of the Executive Council, by Proclamation from time to time appoint.

Now THEREFORE I, the Governor, with the advice of the Executive Council, do hereby proclaim and appoint, that twice in every year, that is to say, on the first day of October in this present year, and on the first of April, and on the first day of October, in every succeeding year, or as soon after each of the said days respectively, as conveniently may be, a Circuit Court shall be holden at Nelson, before the said Henry Samuel Chapman, Esquire.

VITH reference to the Proclamation under this date, notifying an intended Sale of Town and Suburban Lots, on the 29th day of January instant, His Excellency the Governor has been pleased to direct the publication, for general information, of the following Extract of a Letter from Mr. Under Secretary Hope to Joseph Somes, Esq., Governor of the New Zealand Company, dated Downing Street, 12th May, 1843.

"The Company propose :-

1st. "To purchase £50,000 worth of Land in Auckland, and its vicinity; £10,000 worth, at least, to be in the Town, and £25,000 worth. at least, to be in the Country; the Company taking the remaining £15,000 worth of Land in Town, Suburban, or Country Lots, provided they do not take more altogether in Suburban than Town Lots.

2nd. "That the Town Lots be purchased yb auction, and that they be offered at the upset price of £100 per acre; as far as practicable, however, such Lots to be put up together in parcels of 10 acres each, and the whole Lands applied for in the Town by the Company at any one time to be sold on the same day, unless otherwise settled at the request of their Agent, and with the assent of the Governor.

4th. "That the Country Lots should follow the Rule established by the Land Sales' Act.

5th. "That credit be given to the Company, by the Land and Emigration Commissioners. for the sum of £50,000, in consideration of their abandoning their claim to 50,000 acres of Land, out of the whole quantity to which they are already entitled."
