PROCLAMATION.

By His Excellency ROBERT FITZROY, Esquire, Captain in Her Majesty's Royal Navy, Governor and Commander-in-Chief in and over the Colony of New Zealand and its Dependencies, and Vice Admiral of the same, &c., &c., &c.

THEREAS by an Ordinance enacted by the Governor of New Zealand, with the advice and consent of the Legislative Council, Session 2, No. 9, intituled "An Ordinance "to provide for the Registration of Deeds and "Instantants affecting Real Property," it is enacted). "that there shall be established in every County or District; at the case thay be, within the Golory, an office which shall be called the "Register Office," for registering in manner the spinsfter directed the Deeds, Wills, and Memorials thereby authorized to be registered." And Whereas it is thereby further enacted, "that the said Ordinance shall come into operation within any County or District at such time as Elis Excellency the Governor with the advice of that Excentive Council, shall by Proclamation appoint."
