II IS Excellency the Lieutenant-Governor feels much concerned that it has become his duty to notify, that a Despatch has been received from the Secretary of State for the Colonies, announcing that Her Majesty has been pleased to disallow an Ordinance enacted by the Governor of New Zealand, with the advice and consent of the Legislative Council of that Colony, Session III, 7 Victoria, No. 4, initialed "An Ordinance to authorize the Governor of "New Zealand to issue Debentures, and to "make the same a legal tender."

The Lieutenant-Governor will lose no time in making the best arrangements that the means at his disposal will admit of, for obviating the difficulties and inconvenience which, in the present state of the circulating medium of the Colony, may result from the disallowance of the abovementioned Ordinance.
