1st June, 1846.

SIR, - I have received your Despatch, No. 4, of the 23rd November last, reporting the measures which you had adopted in consequence of the disallowance of the local Ordinance, authorizing the Governor of New Zealand to issue Debentures, and to make them a legal Tender.

- It does not appear to Her Majesty's Government, that there were any better measures open to your adoption, understhe embarassing circumstances in which you were placed ; and Lapprove of the Proclamations which you issued on the occasion. etr

I take this opportunity of acquainting you that Her Majesty's Government have decided to submit an Estimate to Parlies of which a copy is enclosed, for a vote of £30,000, for the service of New Zealand, for the year 1846-7.
