#### PROCLAMATION.

By His Excellency Lieutenant-Colonel ROBERT HENRY WYNYARD, Companion of the Most Honourable Order of the Bath, the Officer Administering the Government of New Zealand, &c., &c., &c.

WHEREAS by an Ordinance enacted by the Lieutenant-Governor of New Zealand, Sess. 7, No. 8, intituled "An Ordinance to amend the Customs Ordinance Sess. 1. No. 3, and the Customs amendment Ordinance Sess. 3, No. 6." it is amongst other things enacted that it shall be lawful for the Governor from time to time by Proclamation to appoint and define proper places within the several Ports of the Colony to be legal Quays or Landing Places for the lading and unlading of goods. And to appoint the hours within which such Goods shall be so laden or unladen.

Now, therefore, I, the Officer administering the Government, in pursuance of the authority vested in me in that behalf do hereby proclaim and declare that the legal Quay or Landing Place at Port Victoria in the Province of Canterbury shall be the jetty on Norwich quay at the end of Oxford Street Lyttelton, as the said jetty is defined on the maps of the Canterbury Association, and that at Port Victoria aforesaid and at the Port of Akaroa. Goods under Bond shall be unladen

within the hours of 9 a.m.
and 2 p.m.
and Goods duty paid shall be unladen
within the hours of 9 a.m.
4 p.m.

WHEREAS, by an ordinance passed by the Governor-in-Chief of the New Zealand Islands, by and with the consent of the Legislative Council thereof, intituled "An ordinance for the Naturalization of certain persons in the Islands of New Zealand," Sess. 11, No. 9, it is enacted that all and singular the persons who shall be declared to come within the operation of such Ordinance by any Proclamation to be issued in that behalf by His Excellency the Governor-in-chief shall be deemed and taken until the next Session of the General Legislature within the Islands of New Zealand, to be natural born subjects of Her Majesty.

Now therefore, I, the Officer administering the Government of the Islands of New Zealand, in pursuance of the power and authority in me vested by the said in part recited Ordinance, do hereby proclaim and declare that the person whose name is underwritten shall be deemed and taken to be a natural born subject of Her Ma-

jesty from the date set opposite his name until the next Session of the General Legislature of the Islands of New Zealand as fully to all intents and purposes as if his name had been inserted in the Schedule annexed to the said Ordinance.

Six—I have to acknowledge the receipt of your Despatch No. 27, of the 22nd of February last, forwarding an amended Proclamation which you had issued, in pursuance of my predecessor's Despatch No. 26, of the 28th of June, 1852, for regulating the

conveyance and Postage of letters, &c. in New Zealand, and having laid this Proclamation before the Queen, I have to acquaint you that Her Majesty has been graciously pleased to approve the same.

Having referred a Copy of your Despatch to the Lords Commissioners of the Treasury, I transmit for your information a copy of a letter which has been received in reply from that Board, from which you will perceive that measures have been taken for extending to New Zealand the benefit of the General Regulations of the Colonial Book Post.
