PROCLAMATION.

By His Excellency Colonel THOMAS
GORE BROWNE, Companion of the
(L.S.) most Honorable Order of the Bath,
Governor of the Colony of New
Zealand, &c., &c., &c.

HEREAS, by an Act of the Imperial Parliament, passed in the fifteenth and sixteenth years of the Reign of Her present Majesty, cap. 72, intituled, "An Act to grant a Representative Constitution to the Colony of New Zealand," the several Provinces of Auckland, New Plymouth, Wellington, Nelson, Canterbury, and Otago are thereby established; and it is enacted that for each of the said Provinces there shall be a Superintendent and Provincial Council.

And whereas by the said Act it is further enacted that every Provincial Council shall continue for the period of four years from the day of the return of the Writs for choosing the same, and no longer. Provided always that it shall be lawful for the Governor of New Zealand, by Proclamation or otherwise, to dissolve the same whenever he shall think it expedient so to do.

Now, therefore, I, the Governor of the Colony of New Zealand, do, by this Proclamation, *Dissolve* the Provincial Council of the said Province of Auckland accordingly.
