PROCLAMATION.

By His Excellency Colonel THOMAS
GORE BROWNE, Companion of
the most Honorable Order of
the Bath, Governor of the Colony
New Zealand &c., &c.

WHEREAS by an Ordinance passed by the Lieutenant Governor of New Zealand, with the advice and consent of the Legislative Council thereof, intituled "An Ordinance for establishing Courts of Sessions of the Peace," it is enacted that it shall be lawful for the Governor, by Proclamation, from time to time, to constitute and define certain Districts within which there shall be holden Courts of Sessions of the Peace, at such times and places as the Governor shall by Proclamation from time to time appoint.

And whereas Sessions of the Peace for the District of the Province of Canterbury were by Proclamation dated the thirty-first day of March, 1857, appointed to be held at the Town of Christchurch in the said Province, on the days therein in that behalf mentioned, and it is expedient that the said Sessions should be held at the Town of Lytselton, in the said Province, instead of at the Town of Christchurch aforesaid.

Now therefore I, the Governor, in pursuance of the powers vested in me in that behalf, do hereby appoint that Sessions of the Peace for the District of the Province of Canterbury shall be held at the Town of Lyttelton, in the said Province, instead of at the Town of Christchurch, on the first days of March, June, September and December, in every year, or when any of the said days shall fall on a Sunday, or Good Friday, then on the following day.

Given under my hand and issued under the Public Seal of the Colony of New Zealand, at Auckland, in the Colony aforesaid, this fourteenth day of May, in the year of Our Lord. One thousand eight hundred and fifty-seven.
