PROCLAMATION.

By His Excellency Colonel Thomas Gore Browne, Companion of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand, and Vice Admiral of the same, &c., &c., &c.

By His Excellency Colonel Tromas Gore Browns, Companion of the Most Honourable Order of the Bath, Governor of the Colony of New Zealand, &c., &c.

HEREAS by an Act of the Imperial Parliament passed in the fifteenth and sixteenth years of the Redge, of Her present Majesty, Cap. 72, intituled "An act to grant a Representative Constitution to the Colony of New Zealand," the several Provinces of Auckland, New Plymouth, Wellington, Nelson, Canterbury and Otago, are thereby established; and it is enacted that for each of the said Provinces there shall be a Superintendent and Provincial Council.

And whereas by the said Act it is further enacted that every Provincial Council shall continue for the period of four years from the day of return of the Writs for choosing the same, and no longer.
