REGULATIONS FOR THE LEVEE, 24TH INST.

Gentlemen proposing to attend the Levée will assemble in the Hall, except those gentle-men who have received cards for the entrée, who will enter at the West entrance.

All gentlemen attending the Levée to be dressed in evening costume.

Each gentleman to be provided with two cards, with his name legibly written thereon, one card to be left on the table at the entrance, and the other to be given to the Private Secretary.

CIVIL SERVICE OF THE EAST INDIA COMPANY.

1. In July, 1858, an examination wil take place of candidates for appointments to the Civil Service of the East India Company. Notice will be hereafter given of the days and place of examination.

2. Any natural-born subject of Her Majesty, who shall be desirous of entering the Civil Service of the East India Company, will be entitled to be examined at such examination, provided he shall, on or before the 1st of May. 1858, have transmitted to the Indian Board, Cannon Row, Westminster:

(a) A certificate of his birth, showing that his age, on the 1st May, 1858, will be above eighteen years and under

twenty-three years.

(b) A certificate, signed by a physician or surgeon, of his having no disease, constitutional affection, or bodily infirmity, unfitting him for the Civil Service of the East India Company.

(c) A certificate of good moral character, signed by the head of the school or college at which he last received his education; or such proof of good moral character as may be satisfactory to the Board of Commissioners for the affairs of India.

(d) A statement of those of the branches of knowledge hereinafter enumerated in which he desires to be examined.

3. The examination will take place only in the following branches of knowledge :-English Language and Literature. Composition English Literature and History

including that of the Laws and Constitution **- 1.00**0

4. The merit of the persons examined will be estimated by marks, according to the ordimary system in use at several of the Universities; and the number set opposite to each branch in the preceeding paragraph denotes the greatest number of marks than can be obtained in respect of it.

5. No candidate will be allowed any marks in respect of any subject of examination, unless he shall obtain, in respect of that subject, onesixth of the number of marks set against that particular subject.

6. The examination will be conducted by means of printed questions and written answers,

and by viva voce examination.

7. After the examination shall have been completed, the marks obtained by each candidate, in respect of each of the subjects in which he shall have been examined, will be added up, and the names of the twenty candidates who shall have obtained a greater aggregate number of marks than any of the remaining candidates will be set forth in order of merit; and those twenty candidates will be appointed to the Civil Service of the East India Company, in the Presidency of Bengal, provided they comply with the regulations in to be a Resident Magistrate force at the time for the said Service.

8. The Commissioners for the affairs of India will be ready to receive, at any time previous to the 1st of May, 1858, the testimonials of persons desirous of being appointed to the office of Examiner: but no such appointment will be made until after the date above mentioned.
