### PROCLAMATION.

By His Excellency Colonel THOMAS GORE BROWNE, Companion of the Most Honorable Order of the Bath, Governor and Commanderin-Chief in and over Her Majesty's Colony of New Zealand, and its Dependencies, and Vice-Admiral of the same, &c., &c.

W HEREAS by an Act of the General Assembly of New Zealand, intituled "The Customs Regulation Act, 1858." it is of by the Collector, or other proper Officer of enacted that the Governor may, from time to Customs at the Port of Shipment, which time, by Proclamation, require that Exporters of Gold other than Gold Coin, or their Agents, shall notify, in such manner and form as shall in that behalf be prescribed, their intention to export the same, and that the Governor may also in like manner from time to time make provision for the examination of exported Gold, not being Gold Coin, and respecting the mode of packing and securing the same, and may prohibit the exportation thereof, except from specified Ports, and generally may regulate and restrict, as may seem meet, the Export of Gold other than Gold Coin. And that every person who shall knowingly contravene any provision of any such Proclamation, shall for every such offence forfeit a sum not exceeding the sum of one hundred pounds, in addition to any other punishment or penalty to which he may become liable by reason of such contravention.

Now, therefore, I, Thomas Gore Browne,

the Governor as aforesaid, in exercise of the power in me in this behalf vested by the recited Act, do hereby proclaim and declare as follows:-

1. No Gold shall be shipped, or be waterborne to be shipped, for exportation from the Colony, from any Port except the Ports of Nelson, Wellington, and Auckland, without the special license of the Commissioner of

2. All Gold for expertation shall be securely packed in boxes, or other packages approved packages shall contain no other articles, and shall have on the outside thereof distinctive marks and numbers, legibly and properly cut or written thereon for the identification thereof.

3. Persons intending to export Gold shall give notice of such their intention to the Collector, or other proper Officer of Customs, at the Port of Shipment, at least twenty-four hours before the ship, by which they respec-tively intend to export, obtains a clearance at the Customs, and shall bring the packages of Gold ready for shipment to the Custom-house for examination, in charge of themselves or their agents, at a time to be fixed for the purpose by the Collector, or other proper Officer of Customs.

4. Every such package of Gold shall be opened at the Custom House, in the Collector's Room, or such other secure place as shall be appointed for the purpose by the Collector, or other proper Officer, and the contents o every such package shall be weighed, and the weight of such contents, in Troy weight, ascertained by the exporter or his agent, in the presence and to the satisfaction of such Officer, and the exporter or his agent shall thereupon securely repack the contents of every such package to the satisfaction of such Officer, and shall legibly and properly inscribe the weight of such contents on the outside of the package. The Collector, or other proper Officer, shall then seal the package with the Official Custom's Seal, and may place any additional mark thereon for the better identification thereof. And no such package shall be opened or seal broken, or mark altered or defaced, before the final departure of the export ship on her foreign voyage.

- 5. After the completion of such examination and other proceedings, the exporter of any such package, or his agent, shall pass an export entry for the same, and the proper duty shall be paid thereon before the same is taken from the Custom House for shipment, and the Collector, or other proper Officer, shall thereupon deliver to the exporter or his agent a duplicate of such entry, with a certificate signed by such Collector of the payment of duty thereon.
- 6. No Gold shall be shipped, or waterborne to be shipped, or be received on board of any vessel for exportation until a duplicate of such entry, with such certificate of payment of duty as aforesaid written thereon, shall have been delivered to the Master; and the Master of every vessel bound on a foreign voyage shall produce such entry and certificate for any Gold on board of his vessel to any Officer of Customs on demand, and such entry shall be appended under the Seal of the Customs to the clearance outward of such ship.
- 7. Gold, and packages of Gold, shall for all the purposes of the Customs Regulation Act, 1858, be deemed and taken to be goods the exportation of which is restricted, and shall be specified as such in the Content or Outwards Manifest of the export ship.
- 8. For the purposes of this Proclamation the term Gold shall mean such Gold only as by the Gold Duty Act, 1858, is made subject to a duty of Customs on the exportation thereof from the Colony.

WHEREAS by an Act of the General Assembly of New Zealand, intituled "The Naturalization Act, 1858," it is enacted that every person who shall be declared to come within the operation of this Act by any Proclamation to be issued in that behalf by His Excellency the Governor, shall, as from the time in such Proclamation specified, be deemed and taken, until the termination of the next Session of the General Assembly, to be and to have been, from such specified time, a natural-born subject of Her Majesty within the Colony of New Zealand, as fully to all intents and purposes as if his name had been inserted in the Schedule hereunto annexed. Provided always, that every such Proclamation shall contain the description, occupation, or calling of every person therein named, and his place of residence at the date of such Proclamation.

Now, therefore, I, the Governor of the Colony of New Zealand, in pursuance of the power and authority in me vested by the said Act, do hereby proclaim and declare that the persons hereinafter mentioned, shall come within the operation of the said Act, from the dates hereinafter specified, viz.:

### JOSEPH NOYER,

From the first day of January, One thousand eight hundred and sixty, Native of Portugal, Mariner; residence Auckland, Province of Auckland

### CHRISTOPH KASTEN,

From the first day of January, one thousand eight hundred and sixty, Native of Hanover, Musician, residence Auckland, Province of Auckland.

## EXAMINATION FOR THE CIVIL SERVICE OF INDIA.

### REGULATIONS.

1. In July 1860, an Examination of Candidates will be held in London.\*—Notice will hereafter be given of the days and place of examination.

2. Any natural-born subject of Her Majesty, who shall be desirous of entering the Civil Service of India, will be entitled to be examined at such Examination, provided he shall on or before the 1st May 1860, have transmitted to the Civil Service Commissioner, Dean's Yard, London, S.W.—

(a) A certificate of his birth, showing that his age on the 1st May 1860 will be above eighteen years and under twenty-

two years;

(b) A certificate, signed by a physician or surgeon, of his having no disease, constitutional affection, or bodily infirmity, unfitting him for the Civil Service of India;

(d) A statement of those of the branches of knowledge hereinafter enumerated in which he desires to be examined.

3. In any case in which a doubt may arise as to the eligibility of a candidate in respect of age, health, or character, such inquiries as may be necessary will be instituted by the Civil Service Commissioners.

5. The merit of the persons examined will be estimated by marks, and the numbers set opposite to each branch in the preceding regulation denote the greatest number of marks that can be obtained in respect of it.

6. No candidate will be allowed any marks in respect of any subject of Examination unless he shall be considered to possess a competent knowledge of that subject.

7. The Examination will be conducted by means of printed questions and written answers, and by viva voce Examination, as may be deemed necessary.

8. The marks obtained by each candidate, in respect of each of the subjects in which he shall have been examined, will be added up, candidates who and the names of the

In this, as in the preceding Examination, the merit of the candidates examined will be estimated by marks, and the number set opposite to each subject denotes the greatest number of marks that can be obtained in respect of it. The examination will be conducted by means of printed questions and written answers, and by vivâ voce Examination, as may be deemed necessary.

10. No candidate will be permitted to proceed to India until he shall have passed the Further Examination, or after he shall have attained the age of twenty-four years.

11. The selected candidates who at the Forther Examination shall be found to have a competent knowledge of the subjects specified in Regulation 9, shall be adjudged to have passed, and to be entitled to be appointed to the Civil Service of India.

12. The seniority in the Civil Service of India of the selected candidates shall be determined according to the order in which they stand on the list resulting from the Further

Examination.

13. No person will, even after passing the Further Examination, be allowed to proceed to India unless he shall comply with the regulations in force, at the time, for the Civil Service of India, and shall be of sound bodily health and good moral character.—The Civil Service Commissioners will require such further evidence on these points as they may deem necessary before granting their Certificate of Qualification.

14. Applications from persons desirous to be admitted as candidates are to be addressed to the Secretary to the Civil Service Commission

Commissioners to state that, with the view of meeting the expenses to be incurred by selected candidates during the interval which must elapse before they can proceed to India, it is his intention to allow the sum of £100 to each selected Candidate who shall have passed the Further Examination in July 1861 to the satisfaction of the Commissioners, and shall have complied with such rules as may be laid down for the guidance of selected candidates.

NOTICE TO MARINERS FREQUENTING ST. VINCENT'S GULF.

On and after December 1st, 1859, a Red and White Light placed vertically (the Red Light being uppermost) will be exhibited nightly from the outer end of the Glenelg Jetty, in lat. 34° 59' 30" S., long. 138° 33' E. from the 1st of every month until thear-rival of the English stail, which ge erally occurs on or about the 4th of the month.

The lights will also be exhibited on the night of the 18th of each month or on such nights as follow the dispatch of the English Homeward Mail from Ade aide.

Mariners will take notice that the Lights may be exhibited on other dates than those above mentioned.

The upper or Red Light stands 29 feet above high water mark with the Bright Light 9 feet below it. The Red Light will be seen about 6 miles in clear weather. The Lights exhibit themselves in all directions included in the arc of the sea horizon.

Vessels anchoring off the Glenelg Jetty should bring the Lights to bear E. by N. and bring up in not less than (5) five fathoms.

Coasters may approach the end of the Jetty very closely, but care should be taken to avoid a shoal patch on an oyster bank lying about a mile to the southward of the Town-
