PROCLAMATION.

By His Excellency Colonel THOMAS
GORE BROWNE, Companion of the
Most Honorable Order of the
Bath, Governor and Commanderin-Chief in and over Her Majesty's
Colony of New Zealand and its
Dependencies, and Vice-Admiral
of the same, &c., &c., &c.

W HEREAS the Lands hereinafter mentioned have been acquired by purchase from the aboriginal inhabitants of New Zealand, and it is expedient that the acquisition thereof should be notified by Proclamation accordingly:

Now, therefore, I, the Governor, do hereby proclaim and notify that the Native Title has been extinguished over the Blocks of Land whereof the boundaries are mentioned or described in the Schedule hereunto annexed.

Given under my hand, and issued under the Public Seal of the Colony of New Zealand, at Government House, at Auckland, this twenty-second day of February, in the year of our Lord, One thousand eight hundred and sixty.

SCHEDULE.

PROVINCE OF AUCKLAND.

DISTRICT OF KAIPARA.

Kaukapakapa Reserve. Area, about 100 acres.

BOUNDARIES.

The boundary commences at the Kaukapakapa River and follows the winding of the River to the reck, it then crosses the neck to the River where the boundary joins being the portion of Land which was reserved for Te Keene at the sale of Kaukapakapa West.

DISTRICT OF KAIPARA.

Whakatiwai Reserve. Estimated to contain about 100 acres.

The boundaries commencing at Whakatiwai, following Mr. Blake's survey line bearing 299 ° 0', distance 7365 links to Waikiekie, and following the Kaipara in a South-Easterly direction, and arriving at Kaukapakapa River, thence following that River to Whakatiwai where the boundaries join.

WHEREAS by an Ordinance of the Lieutenant-Governor and the Legislative Council of the Colony, intituled "An Ordinance for establishing Standard Weights and Measures and for the prevention of the use of such as are false and deficient," Session 7, No. 10, the Governor is empowered from time to time by proclamation to appoint and define the Towns and Districts to which the operation of the said Ordinance should extend. Now, therefore, I, Thomas Gore Browne, the Governor, as aforesaid, of the said Colony, in exercise of the said power and authority, do hereby proclaim and appoint that from and after the thirtieth day of April, One thousand eight hundred and sixty, the operation of the said in part recited Ordinance shall extend to all that territory situate in the Province of Auckland in the said Colony, known and defined as the Electoral Districts of the "City of Auckland," the "Suburbs of Auckland," and the "Pensioner Settlements."
