## MILITIA.

**B**Y virtue and in exercise of the authority in me vested, I, Thomas Gore Browne, Governor of the Colony of New Zealand, do make the following Regulations for securing the efficiency of the Officers of the Auckland Regiment of Militia :—

1. All appointments and promotions will be made with a view to the exigencies and efficiency of the Militia Service, without reference to rules applicable to other Services.

2. Every Commissioned Officer, except Officers who have held commissions in Her Majesty's Army, or in the East India Company's Service, before he can be appointed to a Battalion or Company, must procure from an Officer appointed for the purpose of granting such Certificates, a Certificate to the effect that he is fully competent to perform the duties required of him.

3. No Officer will be appointed to a Battalion or Company whose age exceeds that fixed for service by the Militia Act, viz., 60 years.

**B**Y Virtue and in exercise of the authority in me vested, I, Thomas Gore Browne, Governor of the Colony of New Zealand, do hereby appoint and declare that the 1st or Auckland Battalion shall be formed into Five Companies as follows, viz :—

### No. 1 Company

To comprise all those liable to serve as Militiamen whose places of abode for the time being are—

Within a line commencing at the centre point of Queen street at its seaward termination, thence running along the centre of Queen street to its junction with Victoria street, thence eastward along the centre of Victoria street to its junction with Victoria Quadrant, thence along the centres of Victoria Quadrant,

of Waterloo Quadrant, and of Symonds street respectively, as far as the Northern boundary of suburban section No. 16, thence along the Northern boundaries of suburban sections Nos. 16 and 3 to the Grafton road, thence Northward along the centre of the Grafton road to its junction with the road leading into the Government Domain, thence along the centre of that road to its junction with Stanley street, thence along the centre of Stanley street to the Sea, thence along high-water mark to the Eastern end of the Custom House street, and thence along the seaward side of Custom House street to the commencing point.

*No. 2 Company*

To comprise all those liable to serve as Militiamen whose places of abode for the time being are—

Within a line commencing at the centre point of Queen street at its seaward termination, thence running along the centre of Queen street to its junction with Victoria street, thence westward along the centres of Victoria street and of Victoria street west respectively, to the Sea, and thence along high-water mark to the commencing point.

*No. 3 Company*

To comprise all those liable to serve as Militiamen whose places of abode for the time being are—

Within a line commencing at the centre point of Hobson street at its junction with Victoria street, thence Southward along the centres of Hobson street and Pitt street respectively, to the junction of Pitt street with the Karangahape road, thence westward along the Karangahape road to its junction with the Ponsonby and Newtown roads, thence Southeast along the Newtown road to its junction with the Mount Eden road, thence along the south and east sides of the property of the Honbl. J. A. Gilfillan to the Kyber Pass road, thence along the Kyber Pass road to its junction with the Grafton road, thence along the Grafton road to the northern boundary of suburban section No. 3, thence along the northern boundaries of suburban sections Nos. 3 and 16 to Symonds street, thence north westerly along the boundary of the Military Reserve to the junction of Victoria street with Victoria Quadrant, thence westward along the centre of Victoria street to the commencing point.

*No. 4 Company*

To comprise all those liable to serve as Militiamen whose places of abode for the time being are—

Within a line commencing at the centre point of Stanley street at its seaward termination, thence along the centre of Stanley street to the entrance to the Government Domain, thence along the centre of the road leading to the Grafton road, thence southward along the centre of the Grafton road to its junction with the Kyber Pass road, thence westward along the centre of the Kyber Pass road to the eastern boundary of the property of the Hon.

J. A. Gilfillan, thence along the eastern and southern boundaries of that property to the Mount Eden road, thence along the centre of that road to its junction with the Scoria Quarry road, thence along the centre of that road to the Kyber Pass road, thence eastward along the centre of that road to its junction with the Epsom road, thence southward along the centre of that road to its junction with the Tamaki road, thence south eastward along the centre of that road to the Remuera stream, thence northward along that stream to the sea, and thence southward and westward along high water mark to the commencing point.

*No. 5 Company*

To comprise all those liable to serve as Militiamen whose places of abode for the time being are—

Within a line commencing at the centre point of Hobson street at its junction with Victoria street, thence southward along the centres of Hobson street and of Pitt street respectively to the junction of the latter with the Karangahape road, thence south-westward along the centre of that road to its junction with the Ponsonby and Newtown roads, thence south-eastward along the centre of the Newtown road to its junction with the Mount Eden road, thence southward along that road to its junction with the Cabbage Tree Swamp road, thence westward along the centre of that road until it rejoins the Karangahape road, thence westward along the centre of that road till it crosses the Scoria Creek at Low and Motion's Mill, thence northward along that creek to the sea, thence northward and eastward along high water mark to the seaward termination of Victoria street west, and thence along the centres of Victoria street west and of Victoria street respectively to the commencing point.

To comprise all those liable to serve as Militiamen, whose places of abode for the time being are—

Within a line commencing at the cross roads in front of Kelly's public house, thence S. following the road along the Eastern side of Captain Symond's property and on in a straight line to high water mark on the Manukau, thence Eastward along high water mark to the bridge (St. Anne's Bridge) on the Great South road, thence along that road N.W. to Lunden's public house, thence along the road

leading to Onehunga S.W. to the commencing point.

**NO 2 COMPANY.**

To comprise all those liable to serve as Militiamen, whose places of abode for the time being are—

Within a line commencing at Kelly's public house, thence S. following the road along the Eastern side of Captain Symond's property and on in a straight line to high water mark on the Manukau, thence W. along high water mark to the Whau Portage, thence N. along the Portage road to the Whau Bridge, thence Northward along high water mark of the Whau River, Waitunata Harbour and the scoria creek to the Bridge on the Karangahape road, thence along that road to its junction with the Cabbage Tree Swamp road, thence E. along that road to the scoria quarry road, thence S. E. along that to the Three Kings road, thence S. along that road, and following the Eastern, Northern, and again the Eastern boundaries of the Wesleyan Mission Estate to the road leading Eastward to Kelly's public house, thence E. along that road to the commencing point.

**NO 3 COMPANY.**

To comprise all those liable to serve as Militiamen, whose places of abode for the time being are—

Within a line commencing at Kelly's public house, thence N.E. along the road to London's public house, thence N.W. along the Great South Road to Newell's public house, thence along the Epsom Road to its junction with the Kyber pass road, thence W. along that road to the scoria quarry road, thence S.W. and S. along that road and the Three Kings' road, thence South along that road, and following the Eastern, Northern, and again the Eastern boundaries of the Wesleyan Mission Estate, to the road leading Eastward to Kelly's public house, thence E. along that road to the commencing point.

**NOS. 4 AND 5 COMPANIES.**

To comprise all those liable to serve as Militiamen, whose places of abode for the time being are

Westward of the Whau Portage Road, Whau Bridge, Whau River and Waitemata Harbour, and within a circle having a radius of twenty miles from the Police Office at Auckland, and who are to assemble respectively either at Henderson's Mills, or at the Huia, as they may find either post most convenient to their own residences.

**3RD BATTALION.**

**NO. 1 COMPANY**

To comprise all those liable to serve as Militiamen whose places of abode for the time being are—

Within a line commencing at the end of the Portage Road nearest the Tamaki River at Otahuhu, thence Westerly along that road to high-water mark upon the Manukau, thence Westerly and Southerly along high-water mark to the seaward end of the road forming the Southern boundary of "Clendon's Grant," thence Easterly along the said road to its termination, thence North-West along the road bounding the same Grant on the North-East as far as section 27A of the Parish of Manurewa, thence following the roads on the boundaries of the sections numbered 27A, 34, and 28 of the Parish of Manurewa, and 129, 128, 127, 122, 121, 119, 108, 41, — (part of Styak's land), and 37 of the Parish of Pakuranga to the Wharau or Pakuranga Creek, thence following high-water mark upon the Tamaki River and its tributary creeks to the point of commencement.

**NO. 2 COMPANY.**

To comprise all those liable to serve as Militiamen whose places of abode for the time being are—

Within a line commencing at the end of the Portage Road nearest the Tamaki River at Otahuhu, thence West along that road to high-water mark upon the Manukau, thence North along high-water mark to "Anne's Bridge," thence North-West along the Great South Road to its junction with the College Road, thence North-East along that road to St. John's College, thence following the roads forming the outer boundaries of the country sections numbered 5, 6, 11, 12, 17, 18, 19, 21, and 22 of the Parish of Waitemata to the sea, thence following high-water mark, round the West head of the Tamaki River, and crossing that river to the Eastern bank, at the termination of a road dividing the sections numbered 4 and 8 of the Parish of Pakuranga, thence following the roads forming the outer boundaries of the sections numbered 8, 13, 17, 17A, 17B, 24, 28, and 30 of that Parish to the Wharau Creek, thence Westward along that creek, and crossing the Tamaki River, and up the creek leading to the Portage Road, to the point of commencement.

**NO. 3 COMPANY.**

To comprise all those liable to serve as Militiamen whose places of abode for the time being are—

Within a line commencing at the junction of the College Road with the Great South Road, thence North-East along the College Road to St. John's College, thence following the roads forming the outer boundaries of the country sections numbered 26, 25, 24, 23, 21, and 22 of the Parish of

Waitemata to the sea, thence West and South-West along high-water mark to the mouth of the Remuera Stream in Hobson's Bay, thence South along that stream to the Tamaki Road, thence Westward along that road to the Epsom Road, thence South along the Epsom Road to the Great South Road, thence South-East along the Great South Road to the point of commencement.

#### No. 4 COMPANY

To comprise all those liable to serve as Militiamen whose places of abode for the time being are—

Within a line commencing at the seaward termination of the road dividing the sections numbered 4 and 8 of the Parish of Pakuranga, thence E. and S. along the roads forming the outer boundaries of sections numbered 8, 13, 17, 17A, 17B, 24, 28, and 30, of that Parish, to the Wharau Creek, thence crossing that Creek to the termination of the road dividing the sections numbered 37 and 39 of the same Parish, thence following the roads forming the outer boundaries of the sections numbered 39, 102, 109, 110, 64, 66, 111, and 112 of the same Parish, thence Southerly along a road to the S. E. angle of the section numbered 34 of the Parish of Manurewa, thence Westerly along a road to the S. W. angle of the same section, thence Southerly along a road to the S. E. angle of the section numbered 27A, of the same Parish, thence S. Easterly along the road forming the N. E. boundary of "Clendon's Grant," to the Eastern angle of that block, thence in a right line N. E. to the junction of two roads within the section numbered 164 of the Parish of Pakuranga, thence N. W. along the road crossing sections numbered 134 and 164, bounding the Parish, and again crossing section numbered 132 of the Parish of Pakuranga, to a point opposite the N. W. angle of the section numbered 32 of the Parish of Maraetai, thence in a right line N. E. to the point last named, thence following the road forming the N. W. boundary of the sections numbered 32 and 36 of that parish, to the northern angle of section 36, thence in a right line N. E. to the sea at the South-Eastern angle of the Native Reserve at Umupuia near the mouth of the Wairoa River, thence along high-water mark to the East head of the Tamaki River, thence up that river to the point of commencement.

#### No. 5 COMPANY.

To comprise all those liable to serve as Militiamen whose places of abode for the time being are—

Within a line commencing at the seaward termination of the road forming the South-east boundary of "Clendon's Great," thence N. E. along that road to the E. angle of that block, thence in a right line N. E. to the junction of two roads within the section numbered 164 of the Parish of Pakuranga, thence N. W. along the road crossing sections numbered 164 and 134, bounding the Parish, and again crossing the section numbered 132 of the Parish of Pakuranga to a point opposite the N. W. angle of sections numbered 32 of the Parish of Maraetai, thence in a right line N. E. to the point last named, thence following the road forming the N. W. boundary

of the sections numbered 32 and 36 of that Parish to the Northern angle of the section numbered 36, thence in a right line N. E. to the sea at the South-eastern angle of the Native reserve at the Umupuia near the mouth of the Wairoa river, thence Southerly along that river to the point where it is cut by a circle having a radius of twenty miles from the Police office at Auckland, thence following that circle South-westerly till it strikes the Slippery Creek at Drury, thence Northward and Westward along that Creek and the Pahurehure Creek to the Manukau harbor, thence Northward along high-water mark to the point of commencement.

**I**N pursuance of the authority in me vested by the "Militia Act 1858," I, Thomas Gore Browne, Governor of the Colony of New Zealand, do hereby make and ordain the following regulations respecting the formation, training, and exercise of a Company of Volunteers enrolled in the District of Auckland, under an Order in Council dated the twelfth day of November, one thousand eight hundred and fifty eight, named the "Auckland Volunteer Coast Guard."

1. The Company shall consist of Two (2) Lieutenants, Five (5) Petty Officers, and Fifty five (55) men.

2. The Arms shall consist of Five (5) great Guns for the Company, and a Rifle or Revolver Pistol with Accoutrements, and a Cutlas for each man.

3. The day and hours for training and exercise may be fixed from time to time by the Senior Lieutenant of the Company, subject to the approval of the Governor.

4. The Company will be trained and exercised for the present by instructors from one of Her Majesty's Ships of War, and afterwards by their own Officers.
