A PROCLAMATION

For the Naturalization of certain persons.

By His Excellency Colonel THOMAS GORE BROWNE, Companion of the Most Honorable Order of the Bath, Governor and Commanderin-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Ad-miral of the same, &c., &c.

WHEREAS by "The Naturalization Act, 1860," it is enacted that every person who shall be declared to come within the operation of that Act by any Proclamation to be issued in that behalf by His Excellency the Governor, shall as from the time in such Proclamation specified, be deemed and taken until the termination of the next Session of the General Assembly, to be, and to have been from such specified time, a Natural-born subject of Her Majesty within the Colony of New Zealand, as fully to all intents and purposes as if his name had been inserted in the Schedule to that Act annexed. Provided always that every such Proclamation shall contain the description, occupation or calling, of every person therein named, and his place of residence at the date of such Proclamation:

Now, therefore, I, the Governor of New Zealand, in pursuance of the power and au-thority in me vested by the said Act, do hereby proclaim and declare that the persons hereinafter mentioned, shall come within the opera-

tion of the said Act from the dates hereinafter specified, viz. :-

GOTTLIEB GOEBEL,

From the first day of April, one thousand eight hundred and sixty one; Native of Prussia; Farmer; Residence Rangitikei, in the Province of Wellington,

SIGISMUND SCHNEE.

From the first day of April, one thousand eight hundred and sixty one; Native of Prussia; Wheelwright ; Residence Rangitikei, in the Province of Wellington.

FRIEDERICH POPPE.

From the first day of April, one thousand eight hundred and sixty one; Native of Prussia; Gardener; Residence Rangitikei, in the Province of WellIngton.

HEINRICH GOILE,

From the first day of April, one thousand eight hundred and sixty one; Native of Prussia; Farmer; Residence Rangitikei, in the Province of Wellington.

A PROCLAMATION,

Appointing Circuit Courts to be held at Dunedin.

By His Excellency Colonel THOMAS GORE BROWNE, Companion of the Most Honorable Order of the Bath, Governor and Commanderin-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETING:

WHEREAS by an Act of the General Assembly of New Zealand, intituled, " The Supreme Courts Act, 1860," it is provided that there shall be held Circuit Courts for the despatch of civil and criminal business of the Court before one of the Judges thereof at such places and times as the Governor in Council may from time to time appoint. And whereas by a Proclamation dated the 26th day of February, 1861, Circuit Courts were appointed to be held for the Southern District of the said Colony at the Town of Christchurch on the days therein mentioned, and it is expedient that Circuit Courts shall be also held for the said District at Dunedin:

Now therefore I, the Governor, with the advice and consent of the Executive Council of New Zealand, do hereby proclaim and appoint that Circuit Courts shall be held at Dunedin in the Southern District of the said Colony on the 15th day of January and the 15th day of July, in every year, or so soon after each of the said days as conveniently may be. And in case any one of the said days so fixed as aforesaid shall happen to be a Sunday or holiday, then the Court appointed for such day shall be held on the day following.

And whereas by Warrant under the hand of the Governor bearing date the first day of June, one thousand eight hundred and fifty-nine, Mr. Beale's House of Accommodation, Hawkesbury Bush, and the premises of H. C. Hertslett, Esquire, Oamaru, were ap-pointed Polling Places for the Northern District for the election of the Superintendent and of Members of the Provincial Council of the Province of Otago.

And whereas it is expedient to abolish the same :

Now know ye that I, Thomas Gore Browne, the Governor of the said Colony, in pursuance of the power and authority in me vested by the said Act, do hereby abolish the above named Polling Places for the Northern District for the election of the Superintendent and of Members of the Provincial Council of the Province of Otago, and appoint in lieu thereof -Mr. James Mitchell's Store at Waikouatie, and the Provincial Government Store at Oamaru.

Warrant constituting Electoral District of Picton a Petty Sessional District under "Petty Sessions Act, 1858."

> By His Excellency Colonel THOMAS GORE BROWNE, Companion of the Most Honourable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand, and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

WHEREAS by the "Petty Sessions Act, 1858," the Governor is empowered from time to time by notice in the New Zealand Gazette to constitute Petry Sessional Districts in any part of the Colony, and such Districts to abolish and the boundaries thereof to define and alter as he shall think fit : Now I, Thomas Gore Browne, the Governor of the Colony of New Zealand, do hereby constitute that portion of the Province of Marlborough which forms the Electoral District of Picton for the Election of Members of the House of Representatives to be a Petty Sessional District under the said Act. and I do hereby notify the same accordingly.

WHEREAS it is enacted by "The Militia W Act Amendment Act, 1860," that nothing therein contained shall apply to any Battalion or Company of Militia then enrolled under "The Militia Act, 1858," until the Governor shall by warrant under his hand have declared the same to be applicable, and such warrant shall have been published in a Newspaper circulating in the Militia District to which such Company belongs.

Now, I, the Governor, in pursuance of the recited provision do hereby declare that the said "Militia Act Amendment Act, 1860," shall apply to the several Companies or Battalions of Militia throughout the Colony enrolled under the "Militia Act, 1858," at the time of the passing of "The Militia Act Amendment Act, 1860."

ORDER IN COUNCIL

Constituting Tokamariro and Clutha Militia Districts.

AT THE GOVERNMENT HOUSE. AT AUCKLAND, THE SIXTH DAY OF MAY, 1861.

Present :-

HIS EXCELLENCY THE GOVERNOR, IN COUNCIL.

WHEREAS by an Act of the General Assembly of New Zealand, intituled the "Militia Act, 1858," it is enacted that it shall be lawful for the Governor in Council from time to time to constitute throughout the Colony or in any part thereof Militia Districts, and such Districts from time to time to vary and to designate the Militia of any such Dis-tricts by the name of a Regiment, Battalion, Corps, or Company :

Now, therefore, His Excellency the Gover-nor, by and with the advice and consent of the Executive Council in exercise of the above power doth by this present Order constitute the following several Militia Districts to be called and known by the names following, viz. :-

The Tokomairiro District

Is bounded on the North by an East and West line (true bearing) from the Waitahuna Hill to the Waipori River; on the East by Dunedin District and the ocean; on the South by a direct line from Coal Point to the South end of the Kaitangata Lake ; on the GORE BROWNE, Companion of West by the Kaitangata and Tuakitoto Lakes,

Stuart Banges to Waitahuna Hill.

The Clutha District

Is bounded on the North by the Dull Burn; on the East by Tokomairiro District; on the South by the South boundary of the East and West Clutha Hundreds; and on the West by the Waiwera, Clutha, and Waitahuna Rivers.

ORDER 1N COUNCIL

Reconstituting Wellington, Nelson, and Auckland Militia Districts.

AT THE GOVERNMENT HOUSE, AUCKLAND, THIS SIXTH DAY OF MAY, 1861. Present :-

His Excellency the Governor in Council.

WHEREAS by an Act of the General W Assembly of New Zealand, intituled the "Militia Act, 1858," it is enacted that it shall be lawful for the Governor in Council from time to time to constitute throughout the Colony, or in any part thereof, Militia Districts, and such Districts from time to time to abolish, and the boundaries thereof to vary, and to designate the Militia of any such District by the name of a Regiment, Battalion, Corps, or Company, as he shall think fit : And whereas by an Order in Council, dated the 13th day of January, 1259, and published in the New Zealand Gazette on the 14th of the same month the Wellington Militia District was constituted. And whereas by an Order in Council, dated the 27th day of February, 1860, and published in the New Zea-land Gazette on the 1st day of March, 1860, the Nelson Militia District was constituted. And whereas by an order in Council, dated the 5th day of April, 1860, and published in the New Zealand Gazette on the same day, the Auckland Militia District was constituted : And whereas inconvenience has arisen from the constitution of the said Districts, and it is expedient that the same should be abolished and that new Districts respectively should be constituted in lieu thereof :

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, in exercise of the above recited power, doth by this present order abolish the said Militia Districts, and doth constitute three several Militia Districts, to be called and known by the several names following, namely:

Wellington,

Nelson, and

Auckland;

and doth define the respective boundaries of the said districts as follows :

Of the Wellington District the circumference of a circle having a radius of fifteen miles from the point where the Hutt River enters Wellington Harbour.

Of the Nelson District the circumference of a circle having a radius of fifteen miles from the point where the Western mouth of the

thence by Lovel's Creek and the Mount Waimea River enters the sea at the Western point of Rabbit Island.

Of the Auckland District the circumference of a circle having a radius of fifteen miles from the point where the Great South Road intersects the Western boundary line of "Clendon's Grant," between Otahuhu and Papakura, except so much of the area within the said circle as lies to the North of the Waitemata. And doth designate the Militia within each of the said Districts, respectively, by the name of a Regiment.
