A PROCLAMATION

For the Naturalization of certain persons.

By His Excellency Sir GEORGE GREY, Knight, Commander of the most Honorable Order of the Bath, Governor and Commanderin-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice Admiral of the same, &c., &c.

WHEREAS by "The Naturalization Act, 1861," it is enacted that every person who shall be declared to come within the operation of that Act by any Proclamation to be issued in that behalf by His Excellency the Governor, shall, as from the time in such Proclamation specified, be deemed and taken until the termination of the next Session of the General Assembly, to be, and to have been from such specified time, a Natural-born subject of Her Majesty within the Colony of New Zealand, as fully to all intents and purposes as if his name had been inserted in the Schedule to that Act annexed. Provided always that every such Proclamation shall contain the description, occupation or calling, of every person therein named, and his place of residence at the date of such Proclamation:

Now, therefore, I, the Governor of New Zealand, in pursuance of the power and authority in me vested by the said Act, do hereby proclaim and declare that the persons hereinafter mentioned, shall come within the

operation of the said Act from the dates hereinafter specified, viz. :---

ALEXANDER PHILLIPS,

from the twenty-ninth day of November, one thousand eight hundred and sixty-one, Native of the United States of America, Settler, residence, Christchurch, Province of Canterbury. HENRY DREXLER,

from the first day of January, one thousand eight hundred and sixty, Native of Hungary, Carpenter and Cabinet-maker, residence, Invercargill, Province of Southland.

JOHN THOMSON,

from the sixth day of December, one thousand eight hundred and fifty-nine, Native of Sweden, Settler, residence, Seaward Bush, Province of Southland.

JAHAN PAPENHAGEN,

from the first day of January, one thousand eight hundred and fifty-seven, Native of Germany, Sawyer, residence, Invercargill, Province of Southland.

"Execution of Criminals Act, 1858," to come into operation in the Province of Wellington.

> By His Excellency Sir GRORGE GREV, Knight, Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand, and its Dependencies, and Vice-Admiral of the same, &c., &c.

W HEREAS by the "Execution of Criminals Act, 1858," it is enacted that the seid Act shall come into operation in such part of the Colony of New Zealand as the Governor shall by Proclamation from time to time appoint to be Districts for that purpose:

Now I, George Grey, Governor of the said Colony, in pursuance and exercise of the said power, do hereby appoint and proclaim the Province of Wellington to be a District within which the said Act shall, from the date hereof, come into operation.

WARRANT

Delegating to J. A. R. Menzies certain powers under Waste Lands Act, 1858.

> By His Excellency Sir GEORGE GREY, Knight, Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same, &c., &c.,

W HEREAS by an Act of the General Assembly of New Zealand intituled "The Waste Lands Act, 1558," it is enacted that, subject to the several Acts, Ordinances, Regulations and Bills specified in the Schedule to the said Act, and in cases where no provision shall have been made in such behalf, it shall be lawful for the Governor in Council in the name and on behalf of Her Majesty to constitute such Offices and Boards, and appoint such Officers as may be necessary for the management and administration of the Waste Lands of the Crown, and for the survey thereof, within the several Provinces of the Colony, and from time to time to make such changes and alterations, and remove such Officers as he

may think fit: And it is further provided by the said Act that it shall be lawful for the Governor under his hand and the Public Seal of the Colony, from time to time to delegate to the Superintendent of any Province, or to such other person as the Governor may think fit (amongst other powers and authorities), the before recited power and authority, subject or not to any limitations or restrictions as he may think fit; and in like manner to revoke such powers:

Now therefore I, Sir George Grey, the Governor as aforesaid, of the said Colony, do hereby delegate to

JAMES ALEXANDER ROBERTSON MENZIES, Esquire,

the Superintendent of the Province of Southland in the said Colony (but so long only as he shall continue to hold the said office of Superintendent) all the powers and authorities vested in me by the said Act so far as the same are above recited to have, hold, and exercise such powers and authority, subject to the annexed Regulations, during the said period.

Regulations before referred to.

1. The powers delegated by the foregoing Warrant shall be exercised from time to time by written Instruments under the hand of the Superintendent, to be approved of by a Resolution of the Provincial Council of the said Province to be duly made in that behalf. Such Resolution to be certified to the Governor by the Speaker of the Council within one month from its date.

2. It shall be competent to the Governor at his pleasure to disallow any such exercise of the powers above delegated at any time within two months after the receipt by the Governor of such Resolution.

3. No exercise of such powers shall take effect till the Governor shall have expressly allowed the same, except that the same may be made to take effect provisionally, and until the Governor shall have declared his pleasure thereupon.

Governor's Order No. 17. Establishing Port of Riverton.

By His Excellency Sir GEORGE GREY, Knight, Commander of the Most Honorable Order of the Bath, Governor and Commanderin-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same, &c., &c.

IN exercise of the power in me for that pur-pose vested by the "Customs Regulation Act, 1858," I, George Grey, the Governor as aforesaid of the said Colony of New Zealand, do hereby appoint that on and from the day of the date hereof there shall be within the Province of Southland a Port to be called the Port of Riverton, the limits whereof shall be as follows :-

"From the mouth of the Waimatuka Creek, westward, along the bush to Jacob's river or Aparima estuary, thence to the Aparima including the township of Riverton, thence to the Omuti creek, thence to Reserve No. 4 on Howell's point and to include Howell's hill.

BOUNDABIES.

The boundary commences at Opapango, thence along the survey lines till it reaches Te Tukura stream, thence following the said stream till it reaches the Waiau river, thence up the course of that stream to Waiokura, thence along the survey lines to Tawhetikaitara, thence to Te Mohao, thence to Waitoetoe: it then follows the course of Awa Kanai to Otanimoeroa, thence up the course of that stream to a in-Chief in and over Her Ma- mark made by the Surveyor, thence along the

Situate near the Great Mercury Island, on the Eastern side.

> Mercury Bay District. MOTUREHU ISLAND. 256 acres.

Situate near the Great Mercury Island, on the South-eastern side.

Situated near Mercury Bay, on the Southeastern side of the Purangi Block.

> Mercury Bay District. PURANGI ISLANDS. 20 acres.

Situated in Mercury Bay.

Mercury Bay District. WAINUIOTOTO BLOCK. 1568 acres.

Situated near the Whangapoua Harbour, on the Northern side. BULES AND REGULATIONS RES-PECTING THE FIRING FOR FOUR RIFLES, WITH CASES,

PRESENTED TO THE VOLUNTEERS IN NEW ZEALAND BY MESSRS. HEBBERT & CO., OF LONDON.

Prizes.

1. First prize—A Rifle and case, bore No. 451, and 1,000 rounds Ammunition.

Time and place of firing.

2. The Firing to take place at such hours and places as the Officers Commanding at the different stations may deem convenient, commencing on Monday, the 3rd March. Should the weather prove unfavourable at any time appointed, the firing may be postponed at the discretion of the Officer Commanding at the Station.

Who eligible to compete.

3. The firing to be open to all Volunteers actually sworn in as such (Officers of the Force incluted). All intending competitors to send in their names on or before the 20th February next, to the Senior Officer of the Corps to which they belong, who shall forthwith cause lists to be compiled from the names sent in, but if he considers that any such person shall not have attended, when required, sufficiently regularly at drills, parades, training or exercise, he is authorised to *prevent* such person from firing for the prizes.

Lists of persons firing.

4. A list giving each competitor a number only, to be given to the Officer and Marker, another list to be made out with each competitor's name and corresponding number on it to be kept by the Officer Commanding and Officer stationed at the spot where the competitors fire from.

Competitors absenting themselves.

6. Should any competitor absent himself without leave when his turn comes to fire, he is to forfeit his chance, and a shot is to be fired in the air (which the marker will score as a miss), in order to keep the numbers on the lists correct.


Arms and Ammunition to be used,

6. Rifles supplied by Messrs. Hebbert & Co., and Ammunition supplied by the Goverment.

Mode of Firing.

7. Without artificial rest. 1st range, standing; 2nd range, kneeling; 3rd range, in any position.

Number of Rounds, Targets, and Score.



Wooden Targets when required to be ordered by the Officer Commanding, to be made at the different Stations, 6 feet by 2 feet, painted as shewn at the end. Feet

Ties.

9. Ties to fire five rounds at four hundred yards at one Target. In this case, shots to be measured from the centre of the Bull's eye. Ties to be fired for and decided previous to forwarding the lists, and names to be placed on the lists in their proper order, according to the number of points made.

Ring Shots.

10. Competitors to have the benefit of any shot on the Ring.

Ricochéts.

11. Any shots which touch the ground before hitting the Target (ricochéts) to be noted R in the column for misses.

Score.

12. All hits first count according to where the bullet "first" strikes the Target.

Award of Score.

13. All differences as to points, &c., to be decided by the Officer Commanding the Corps at the Station, before any returns of the firing are finally made up.

Commanding Officers.

14. Officers Commanding Corps to be on the ground. One Officer to be appointed to call the names of competitors at the *place of firing*, and another to remain near the Target.

Marker.

15. A marker to be appointed by the Officer Commanding at each Station, who will be under the Officer appointed to remain near the Target.

Medical Officer.

16. The Medical Officer to attend. Where there are no Surgeons of Militia appointed, a Medical Practitioner to be employed.

Returns of firing.

17. A return of the names of all competitors, with the number of points scored by each, to be forwarded by the Officer Commanding at each Station to the Deputy Adjutant General at Auckland, according to the accompanying Form, as soon as possible after the fining has ceased.

Caption against accidents.

18. The attention of the Commanding Officers is particularly called to the following rules to prevent accidents :---

No competitor is to *cap* or *cock* his rifle before coming to the *spot* from which he is to fire.

No competitor his to let the cock of his rifle down when an unexploded cap is on the nipple, but to keep it at half-cock.

Competitors before firing are to take a few paces in *front* of all lookers on, and to see that no objects are in the line of fire.

Time and place of firing.

2. The firing to take place at such hours and places as the Officers Commanding at the different stations may deem convenient, com-mencing on Tuesday, the 1st April. Should the weather prove uninvestable at any time appointed, the firing may be postponed at the discretion of the Officer Commanding at the Station.

Who eligible to compete.

3. The firing to be open to any person sworn in as a Militiaman since the 1st January 1860, and to all Members of Volunteer Corps, (Officers of both Forces included). All intending competitors to send in their names on or before the 20th March next, to the Senior Officer of the Corps to which they belong, who shall forthwith cause lists to be compiled from the names sent in, but if he considers that any such person, whether a Militiaman or Volunteer, shall not have attended, when required, sufficiently regularly at drills, parades, training or exercise, he is authorised to prevent such person from firing for the prizes.

List of persons firing.

4. A list giving each competitor a number only, to be given to the Officer and Marker, another list to be made out with each competitor's name and corresponding number on it to be kept by the Officer Commanding and Officer stationed at the spot where the competitors fire from.

Competitors absenting themselves.


5. Should any competitor absent himself without leave when his turn comes to fire, he is to forfeit his chance, and a shot is to be fired in the air (which the marker will score as a miss), in order to keep the numbers on the lists correct.

Arms and Ammunition to be used.

6. Rifles and Ammunition supplied by the Government. N.B.-Spare Rifles will be furnished on the days of firing, to those who may require them.

Mode of Firing.

7. Without artificial rest. 1st range, standing ; 2nd range, kneeling ; 3rd range, in any position.



Wooden Targets when required to be ordered by the Officer Commanding, to be made at the different Stations, 6 feet by 2 feet, painted as shown at the end.

Ties.

9. Ties to fire five rounds at four hundred yards at one Target. In this case, shots to be measured from the centre of the Bull's eye. Ties to be fired for and decided previous to forwarding the lists, and names to be placed on the lists in their proper order according to the number of poitns made.

Ring Shots.

10. Competitors to have the benefit of any shot on the Ring.

Ricochéts.

11. Any shots which touch the ground before hitting the Targets (ricochéts) to be noted R in the column for misses.

Score.

12. All hits to count according to where the bullet "first" strikes the Target.

13. All differences as to points, &c., to be decided by the Officer Commanding the Corps at the Station, before any returns of the firing are finally made up.

Commanding Officers.

14. Officers Commanding Corps to be on the ground. One Officer to be appointed to call the names of competitors at the *place of firing*, and another to remain near the Target.

Marker.

15. A marker to be appointed by the Officer Commanding at each Station, who will be under the Officer appointed to remain at the Target.

Medical Officer.

16. The Medical Officer to attend. Where there are no Surgeons of Militia appointed, a Medical Practitioner to be employed.

Returns of firing.

17. A return of the names of all competitors, with the number of points scored by each, to be forwarded by the Officer Commanding at each Station to the Deputy Adjutant General at Auckland, according to the accompanying Form, as soon as possible after the firing has ceased.

Caution against accidents.

18. The attention of Commanding Officers is particularly called to the following rules to prevent accidents :---

No competitor is to *cap* or *cock* his rifle before coming to the *spot* from which he is to fire.

No competitor is to let the cock of his rifle down when an unexploded cap is on the nipple, but to keep it at half-cock.

Competitors before firing are to take a few paces in *front* of *all lookers on*, and to see that no objects are in the line of fire.

Customs Agents to be licensed at Timaru.
