Appointing General Assembly to meet at Wellington in Jnne, 1862.

WHEREAS the General Assembly of New Zealand has been and now stands prorogued to Monday, the Seventh day of April, instant. And whereas it is expedient further to prorogue the same, and to fix the time and place for holding the next Session thereof. Now, therefore, I, Sir George Grey, the Governor of New Zealand, do hereby further prorogue the said General Assembly until Thursday, the Twenty-sixth day of June, now next ensuing. And I do also hereby appoint and proclaim that the next Session of the General Assembly of New Zealand shall commence and be holden for the despatch of business on Thursday, the Twenty-sixth day of June aforesaid, at two of the Clock in the afternoon, in the City of Wellington, and the Honorable the Members of the Legislative Council and the Members of the House of Representatives respectively are hereby required to give their attendance at the said time and place accordingly.
