A PROCLAMATION

For bringing the Weights and Measures Ordinance into operation within the Province of Taranaki.

> By His Excellency SIR GEORGE GREY, Knight, Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

W HEREAS it is expedient to bring into operation within the Province of Taranaki the "Ordinance for establishing Standard Weights and Measures and for the prevention of the use of such as are false and deficient," Session vii., No. 10,

Session vii., No. 10, Now, therefore. I, Sir George Grey, the Governor of New Zealand, in exercise of the power and authority in me vested in that behalf, do hereby proclaim and appoint that from the first day of September, one thousand eight hundred and sixty-two, the operation of the said Ordinance shall extend to the Province of Taranaki in the said Colony.

A PROCLAMATION

For the Naturalization of certain Persons.

By His Excellency Sir GEORGE GREY, Knight, Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand, and its Dependencies, and Vice-Admiral of the same, &c., &c.

W HEREAS by the "Naturalization Act, 1861," it is enacted that every person who shall be declared to come within the operation of that Act by any Proclamation to be issued in that behalf by His Excellency the Governor shall as from the time in such Proclamation specified, be deemed and taken until the termination of the next Session of the General Assembly to be and to have been from such specified time a natural born subject of Her Majesty within the Colony of New Zealand, as fully to all intents and purposes, as if his name had been inserted in the Schedule to that Act annexed. Provided always that every such Proclamation shall contain the description occupation or calling, of every person therein named, and his place of residence at the date of such Proclamation.

Now therefore, I, Sir George Grey, the Governor of New Zealand, in pursuance of the power and authority in me vested by the said Act, do hereby proclaim and declare that the persons hereinafter mentioned shall come within the operation of the said Act, from the date hereinafter specified, viz. :--

JEAN BAPTIST CHOISY,

From the seventh day of December, One

thousand eight hundred and fifty-nine, Native of Frauce, Tailor, residence Auckland, in the Province of Auckland.

JOSEPHINE CHOISY (wife of the above),

FELIX CHOISY (son of the above),

From the seventh day of December, One thousand eight hundred and fifty-nine, Native of France, Tailor, residence Auckland, in the Province of Auckland.

ERNEST CHOISY (son of the above),

From the seventh day of December, One thousand eight hundred and fifty-nine, Native of France, Carpenter, residence Auckland, in the Province of Auckland.

WARRANTS

Defining Districts under the "Coroners' Act, 1858."

> By His Excellency Sir GEORGE GREY, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand, and its Dependencies, and Vice-Admiral of the same, &c., &c.

W HEREAS by the "The Coroners' Act, 1858," the Governor is empowered in the manner therein mentioned, to appoint fit persons to be Coroners of the several Districts of the Colony of New Zealand, and from time to time to define the Districts within which such Coroners shall respectively have jurisdiction, and every such definition to revoke or amend, and the limits of such Districts to alter as occasion may require. Now, therefore, I, Sir George Grey, the Governor of the said Colony, in pursuance of the said power and authority, do hereby define

The District of Auckland,

in the Province of Auckland, to be all the territory bounded on the North by the boundary of the County of Eden, by Maurice Kelly's Road, by Lucas' Creek, and by the Waitemata River to the Kaipara Landing Place; on the West by the Western boundary of the Parishes of Waipareira and Waikomiti to Great Muddy Creek; on the South by the waters of Manukau Harbour; and on the East by Papakura Creek and Village inclusive, by the Wairoa Road and by the sea, except so much of the said District as is included in the "Gaol and Hospital District." Given under my hand at the Government House at Auckland, this Seventh day of June, One thousand eight hundred and sixty-two.

The District of Mangawai,

in the Province of Auckland to be all the territory bounded on the North by the Northern boundary of the Parishes of Waipu and Kaiwaka; on the West by the Otamatea River and Kaipara Estuary; on the South by the Tapora Creek, Hotea and Pakiri Rivers; and on the East by the Sea.

Similar Warrant defining

The District of Wangarei,

in the Province of Auckland to be all the territory bounded on the North by the Northern boundary of the County of Marsden; on the West by the Wairoa River to the Wairoa; on the South by the Tauginua Ranges, and the Southern boundary of the Parishes of Ruarangi and Waipu; and on the East by the Sea.

Similar Warrant defining

The District of Raglan,

in the Province of Auckland, to by all the territory bounded on the North by a line from Taranaki Point to the Wangape Lake, by the Wangape Lake and River; on the East by the Waikato and Waipa Rivers; on the South by

the Southern boundary of the County of Rutland; on the West by the Sea.

Similar Warrant defining

The District of the Bay of Islands,

in the Province of Auckland, to be all the territory bounded on the North by the Northern boundary of the County of Hokianga; on the West by the Mangamuka River, by the Hokianga Harbour, and by the Waima River; on the South by the Southern boundary of the Hokianga County, by the Eastern boundary of the Hokianga County, by the Eastern arm of the Kawa Kawa River, and by the principal river of Wangaruru; and on the East by the Sea.

Similar Warrant defining

The District of Mongonui,

in the Province of Auckland, to be so much of the North Island as lies to the North of a line from the head of False Hokianga Harbour to the summit of Maungataniwha Mountain, and thence to the mouth of the Pupuke River at the head of Wangaroa Harbour; including the adjacent islands.

The District of the City of Christchurch,

in the Province of Canterbury, to be the site of the City of Christchurch together with all the adjacent Reserves lying between the said town and Rural Sections fronting upon such Reserves.

The District of the Town of Lyttelton,

in the Province of Canterbury, to be all the territory bounded on the North by the ridge of the hill lying on the North side of Lyttelton; on the East by the spur of the hill running down to the Sea immediately, on the East side of Gollan's Bay; on the South by the Sea; on the West by a true North line drawn through the most Western point of the Town of Lyttelton as originally laid out by the Canterbury Association.

The District of Port Victoria,

in the Province of Canterbury, to be all the territory bounded on the North and West by the Sea and the Town of Lytrelton, Heathcote, and Lincoln Districts; on the South by Lake Ellesmere and the Sea; on the East by a line drawn from a point on the sea-coast halfway between the East head of Port Levy and the West head of Pigeon Bay to the head of the Little River, the Little River and Lake Forsyth, including the islands in Port Lyttelton. The District of the Town of Akaroa,

in the Province of Canterbury, to be the site of the Town of Akaroa as set forth in a Proclamation issued by the Superintendent of the Province on the 1st May, 1861, and published in the "Provincial Government Gazette," dated May 12, 1856.

The District of the Town of Kaiapoi,

in the Province of Canterbury, to be all the territory comprised within the limits following, that is to say:—The Town of Kaiapoi, as described in the Schedule to the town of Kaiapoi Fown Ordinance, Sess. viii, No. 7, and the remainder of Rural Section No. 320.

Similar Warrant defining

The District of the Town of Timaru,

in the Province of Canterbury, to be all the territory bounded on the North and East by the Sea; on the South by the North boundary of Section No. 1702, the North side of the road lying to the North of Section No. 2367, the Cemetery Reserve 1706, and the North boundaries of Sections 1706 and 1607, on the West by the East boundary of Section No. 1606, the East and North boundary of Section No. 707, the East boundary of Section 1652, till it meets Whales' Creek, to the Sea.

Similar Warrant defining

The District of Geraldine,

in the Province of Canterbury, to be all the territory bounded on the North by the Ashburton District; on the East by the Sea; on the South by the South bank of the Opehi to its source near Burke's Pass, and a straight line thence to the summit of Burke's Pass, on the West by the ridge of the hills dividing the waters of the Opihi and Rangitata from the waters of the Takapo.

in the Province of Canterbury, to be all the territory comprised within the limits following, that is to say, bounded on the North by the Ashburton District; on the East by the Ashburton, Geraldine, and Waitangi Districts; on the South by the Province of Otago; and on the West by the Sea.

Similar Warrant defining

The District of Waitangi,

in the Province of Canterbury, to be that part of the Province not included in the Town of Timaru, bounded on the North by the Geraldine District; on the East, by the Sea; on the South by the Province of Otago; on the West by the Hakateremea River to its source at the Hakateremea River Pass, and the ridge of the hills to Mackenzie Pass and Burke's Pass.

Similar Warrant defining

The District of Oxford,

in the Province of Canterbury, to be all the territory bounded on the North and East by the Province of Nelson, the Sefton District, and a true North and South line drawn through trig. pole C 80; on the South by the South bank of the river Waimakariri or Courtenay, to to the head waters of its Westernmost source, and a true West straight line drawn thence to the West Coast; on the West by the Sea.

Similar Warrant defining

The District of Rangiora,

in the Province of Canterbury, to be all the territory bounded on the North by the Sefton District; on the West by the Oxford District; on the South by the centre of the Harewood Road from a point where it intersects the West boundary of the District to a point where it meets a road lying on the South-West boundary of Sec-tion No. 1728, the middle of that road to the corner of Section 1631, the middle of the road lying on the boundaries of Sections 1631, 1539 and 1508 to the North-West corner of 1029, the West boundary of 1029 to a point where it meets South Brook, and the middle of South Brook to the West boundary of the Native Reserves; on the East by the boundary of the Native Reserve, the middle of a road lying on the South-West boundary of Sections 1655, 355, 355 a, and 431, the West boundary of 432 to the Harewood Road, the middle of that road to the South corner of 544, and the middle of the road lying on the East boundary of 544 to the point where the said road meets the River Ashley.

The District of Mandeville,

in the Province of Canterbury, to be all the leading to Putako territory (the Town of Kaiapoi not included) South by the se bounded on the North by the Sefton District Victoria District.

and the Rangiora District, on the West by the Oxford District, on the South by the South Bank of the River Courtenay, Waimakariri, and a line drawn from trig. pole C 19 on the South Bank of that river to trig. pole C 27 on the Sea coast; on the East by the Sea coast.

in the Province of Canterbury, to be all the territory bounded on the North by the Avon District, the middle of the Great South Road as far as the North-west corner of Section No. 967 and a direct line thence to the River Selwyn drawn through trig. pole L 15; on the East by the Heathcote District; on the South by the River Selwyn and Lake Ellesmere.

The District of Heathcote,

in the Province of Canterbury, to be all the territory bounded on the North by the Avon District and the City of Christchurch District; on the East by the Sea; on the South by the Town of Lyttelton District, the ridge of the Port Hills as far as the highest of Cooper's Knobs, and a stream rising in Cooper's Knobs and falling into the River Halsewell; on the West by the West boundary of the old river bed of the Courtenay and the middle of the Halsewell to its junction with the aforesaid stream.

in the Province of Canterbury, to be all the territory bounded on the North by the Province of Nelson; on the East by the sea; on the South and West by the South bank of the River Ashley to its source at Ashley Head, the ridge of the hills, thence to Esk Head and Snowy Peak, and a straight line thence to the saddle dividing the head waters of the Huranui from those of the Teremakau.

The District of Dunedin,

in the Province of Otago, to be all the territory bounded on the North by Allen Creek, the Silver-peak Mountains, Glenburne, Blueskin Bay, and the Ocean; on the East by the Ocean; on the South by the Taieri River and Waiperi Stream; and on the West by Verterburn, Traquhair-burn, and Taieri River.
