Warrant altering times for holding District Courts at Lower Hutt and Greytown

By His Excellency SIR GEORGE GREY, Knight Commander of the Most Honourable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same, &c., &c.

WHEREAS by the District Courts Act 1858, it is provided that there shall be, within the Colony, Courts of Record possessing Civil and Criminal Jurisdiction, to be called District Courts: and the Governor is empowered from time to time by notification in the New Zealand Gazette, to fix the times and places within the District at which every such Court shall be held, and in like manner such times and places to alter or abolish as he shall think fit.

Now therefore, I, Sir George Grey, the Governor of the Colony, do hereby in pursuance and exercise of the said power and authority, fix that Sessions of the District Court of the Hutt shall be held as follows, viz:—

At the LOWER HUTT on the Third Monday of September and of every alternate month thereafter.

At GREYTOWN on the Tuesday next after the day appointed for the Sitting of the Court at the Lower Hutt.

WHEREAS by an Act of the General Assembly of New Zealand, inti-tuled, "The Waste Lands Act, 1858," it is enacted that subject to the several Acts, Ordinances, Regulations and Bills specified in the Schedule to the said Act. and in cases where no provision shall have been made in such behalf, it shall be lawful for the Governor in Council in the name and on behalf of Her Majesty to constitute such Offices and Boards, and appoint such Officers as may be necessary for the management and administration of the Waste Lands of the Crown, and for the survey thereof within the several Provinces of the Colony, and from time to time to make such changes and alterations and remove such Officers as he may think fit: And it is further provided by the said Act that it shall be lawful for the Governor, under his hand and the Public Seal of the Colony from time to time to delegate to the Superintendent of any Province, or to such other person as the Governor may think fit (amongst other powers and authorities), the before recited power and authority, subject or not to any limitations or restrictions as he may think fit, and in like manner to revoke such powers.

Now therefore, I, Sir George Grey, the Governor as aforesaid, in virtue of

he said recited powers. place, do hereby revoke the delegation issued by me in favor of James Alex-ander Robertson Menzies, Esquire, upon the second day of January, One thousand eight hundred and sixty-two: And in the second place, do hereby delegate to James Alexander Robertson Menzies, Esquire, the Superintendent of the Province of Southland, in the said Colony, (but so long only as he shall continue to hold the said office of Superintendent), all the powers and authorities vested in me by the said Act, subject to the following limitation, that is to say, that the Commissioner of Crown Lands for the Province of Southland shall be appointed only by the Governor. To have, hold and exercise such powers and authority subject to the limitation above set forth during the said period.

I have the honor to acknowledge the receipt of your letter, No. 60, of 15th February last, informing me my proposal for the continuance of this Office would be submitted to the General Assembly at its next Session.

Should the Governor decide in favor of Botanical Gardens at Kew. it, I beg to direct your attention to a matter that if carried out would, I believe, greatly tend to promote the interest of the Colony.

In the first the Colony, I venture to submit for the consideration of the Government the propriety of securing them after the Exhibibition is over, and of arranging them in one collection. Such a step would enable manufacturers and others to have access to specimens at all times, -the want of which is at present a great drawback. The expense of so doing would be nominal, should the Government retain these rooms, the one at present used for the Govern-ment maps, official documents, papers and use of colonists being upwards of 35 feet long could be arranged to contain all, without interfering with its present use. The cases now in service at the Exhibition, which must be paid for, would serve without further cost, for the preservation of the various articles; under these circumstances I believe I am justified in stating the expense would be triffing, while the opinion that it would be of an advantage to the Colony, is based on the remarks made to be by practical men who have seen the various articles at the Exhibition.

Learning that other parties were desirous to rent the present rooms upon my relinguishing them on the 30th proximo, I have thought it advisable to retain them until informed of the decision of the General Assembly and of the Government, respecting the present suggestion. If it is practicable and convenient to let me have this by return mail it would be of service.

PROVINCE OF OTAGO.

SCHEDULE of charges to be paid on packages of Gunpowder deposited in the Powder Magazine at Dunedin.

For each and every barrel or package containing 50lbs. of Gunpowder and upwards, for any period not exceeding four weeks 1

Ditto, ditto, above four weeks, per week

For each and every barrel or package containing less then 50lbs., for any period not exceeding four weeks

Ditto, ditto, above four weeks, per week 0

The expenses of conveying the keeper of the Magazine to and from Dunedin in all cases to be borne by the parties who store the Powder.

NEW ZEALAND MAIL STEAM SERVICES.

TENDERS are required by the Government of New Zealand for the performance of the undermentioned services.

1. A Steamer to leave Melbourne each month within 24 hours after the arrival of the European Mail contract boat, for Port Chalmers, Otago, calling at the Bluff: and thence calling at Lyttelton, Wellington, Picton and Nelson, to Sydney. To wait in Melbourne for the mail if detained for not more than four days after the due date. To remain in Port Chalmers three days; in Wellington, Lyttelton, and Nelson, two days each; and in Picton one day.

2. A steamer to leave Sydney on or about the 1st of each month for Nelson,

and thence calling at Picton, Wellington, Lyttelton, Port Chalmers, and the Bluff, carrying the homeward Mail from the Colony, to Melbourne. To be ready to leave Port Chalmers at 2 p.m., on the 18th of each month, except February, and then on the 16th.

The Steamers to be employed must be subject to the approval of the Government, and must be able to maintain an average speed of not less than 8 knots an hour on each voyage.

All Post Office Mails must be received on board and delivered to destination free

of charge.

Mails to be taken from and delivered on board of the European Mail Contract Steamer in Hobson's Bay at the expense of the Contractor.

A free chief cabin passage must be at the service of a clerk or agent of the Post Office, on the requisition of the Government.

The tender to state the amount of penalty recoverable for general non-performance of contract: a penalty of £100 per diem will be required for delay, in departure after the time fixed on each voyage, and an additional penalty of £300 for failure, after such delay in delivering the homeward Mail in Melbourne prior to the departure of the European Mail Contract Boat from that Port.

The tenders may state the sum for which the whole or any portion of the forementioned Services will be undertaken

The Contract to commence on the 1st January, 1863, or on any earlier date that may be agreed upon, to continue for the term of twelve successive trips each way, and to be determinable after that time by six months notice on either side.
