## ORDER IN COUNCIL.

*Authorising issue of £25,000 Treasury Bills.*

At the Government House, at Auckland, the Twenty-first day of November, 1862.

Present:—

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by the "Loan Act, 1862," power is given to raise in Great Britain a Loan of £500,000 for the Public Service of the Colony, and it is enacted that until the aforesaid sum of Five hundred thousand pounds shall be raised in Great Britain, it shall be lawful for the Colonial Treasurer, if thereunto authorised by an Order of the Governor in Council, from time to time to borrow and take up at interest at a rate not exceeding six pounds per centum per annum, payable out of the Ordinary Revenue, any sums of money not exceeding in the whole one hundred thousand pounds, on the security of Treasury Bills payable at the expiration of a term not exceeding twelve months from the date thereof.

Now, therefore, His Excellency the Governor of the Colony of New Zealand, with the advice and consent of the Executive Council of the said Colony, doth hereby authorise the Honourable Reader Gilson Wood, Colonial Treasurer of New Zealand, to borrow and take up a sum or sums of money not exceeding in the whole the sum of twenty-five thousand pounds sterling, and to issue Treasury Bills therefor on the terms and subject to the conditions before recited.

## ORDER IN COUNCIL

*Authorizing additional Postal Regulations.*

AT THE GOVERNMENT HOUSE, AT AUCKLAND,  
THE 22ND DAY OF NOVEMBER, 1862.

Present:—

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS, by the "New Zealand Post Office Act, 1858," power is given to the Governor in Council from time to time to make Rules and Regulations for the managing of the several Post Offices of the said Colony; for the receiving, despatching, conveying and delivering of Letters (including the imposition of Fees for private boxes and deliveries); for the detaining, opening and return, or other disposal of irregularly posted, unclaimed, and refused letters, or such as from any cause whatsoever cannot be delivered or forwarded, and the contents thereof respectively, and for the publication of the Lists of the same; for the making, custody, and sale of Postage Labels; for the receiving and paying of money in connection with the said Postal Service; and for the conduct of Post Officers; and any such Rules and Regulations at any time in force to alter, vary, or revoke: and, for the purpose of giving effect to the Rules and Regulations so to be made, further power is given to the Governor in Council by the said Act to impose any penalty not exceeding Ten Pounds for any one offence against such Rules and Regulations:

Now therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council of New Zealand, doth hereby make the following additional Post Office Regulation; and doth declare that the same shall be in force from and after the first day of

January, 1863, and that in addition and without prejudice to the Regulations published in the Government Gazette, No. 9, dated the 6th February, 1862.

*Regulation.*

Bankers' Parcels, containing only Bank Notes, Orders, Bills, and Promissory Notes, Cheques, Passbooks, or Bank Returns, sent by or to any Bank, or Banker, within the Colony, (provided such parcels are securely closed and sealed and contain no letter or communication in the nature of a letter and bear along with the address of such parcel, the words "Banker's Parcel, without Letter," subscribed by the sender of such parcel, with his name and address,) shall be received as Book Packets and shall be transmitted, within the Colony, at the same rates as Book Packets.

WARRANT.

*Altering times for holding District Courts at Lower Hutt and Greytown.*

By His Excellency SIR GEORGE GREY, Knight, Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies and Vice-Admiral of the same, &c., &c., &c.

WHEREAS, by the "District Courts Act, 1858," it is enacted that there shall be, within the colony, Courts of Record possessing Civil and Criminal Jurisdiction, to be called District Courts; and the Governor is empowered from time to time, by notification in the *New Zealand Gazette*, to fix the times and places within the District at which every such Court shall be held, and in like manner such times and places to alter or abolish, as he shall think fit, now, therefore, I, Sir George Grey, the Governor of the colony, do hereby, in pursuance and exercise of the said power and authority, fix that Sessions of the District Court of the Hutt shall be held as follows, viz.:—

At the Lower Hutt, on the third Monday of January, and of every alternate month thereafter; and

At Greytown, on the Thursday next after the day appointed for the sitting of the Court at the Lower Hutt.

TENDERS FOR THE PURCHASE OF TREASURY BILLS.

Treasury, Auckland,  
November 22nd, 1862.

NOTICE is hereby given that Tenders will be received at this Office up to one o'clock, p. m. of the 22nd December, 1862, from persons desirous of purchasing Treasury Bills to an amount not exceeding £25,000, bearing interest at 6 per centum, per annum, to be issued by the Colonial Treasurer of New Zealand, under the provisions of an Act passed during the last Session of the General Assembly, entitled "The Loan Act, 1862."

These Bills will be issued for sums of £50 or £100, and will be payable at the expiration of six months from the dates of issue, on presentation of the Bills at the Colonial Treasury at Auckland, or at the sub-Treasury in any other Province, together with the interest thereon.

Each Tender must state the amount in coin proposed to be given for each Treasury Bill of £50 or £100, as the case may be, and the number and amount of such Treasury Bills which the Tenderer proposes to take.

Tenders by the same person at various rates must be made out and delivered separately.

In case of equality of Tenders beyond the sum for which Tenders are invited, they will be subject to a *pro rata* diminution.

The Tenders will be opened and read before all Tenderers who may desire to be present, and the purchasers will be declared to be those who may offer the highest prices, not being under the minimum previously fixed, and which will be contained in a sealed paper placed on the table before the Tenders are opened.

The Treasury Bills so contracted for will be deliverable at the Colonial Treasury, Auckland, on the fifth day of January, 1863, between the hours of 11 a.m. and 2 p.m., upon payment of the amount tendered for; and all Treasury Bills not paid for on the day specified, will be re-allotted or disposed of as the Governor may direct.

OFFICIATING MINISTERS FOR 1863.

Registrar General's Office,

**T**HE attention of the person or persons within the Colony of New Zealand, in whom is vested ecclesiastical authority over any of the Religious Bodies, enumerated in “Schedule D,” annexed to an Act of the General Assembly of New Zealand, intituled “The Marriage Act, 1854,” and of all other persons concerned, is requested to the following extracts from the Act aforesaid:—

“42. Any Minister of Religion, whose name shall have been sent in to the Registrar General of Births, Deaths, and Marriages, or other Officer to be appointed by the Governor in that behalf, by the persons or person within the Colony in whom ecclesiastical authority shall for the time being be vested or reputed to be vested over any of the Religious Bodies enumerated in the “Schedule D” to this Act annexed, shall, subject to the conditions hereinafter mentioned, be an Officiating Minister within the meaning of this Act; and the name of every such Minister of Religion shall be certified under the hand or hands of the person or persons aforesaid, and shall be entered and published as hereinafter provided: *Provided always*, that any Minister of Religion not connected with any of the Bodies enumerated in the aforesaid Schedule to this Act annexed, who shall present to any Registrar a certificate signed by twenty-four householders resident in the District for which such Registrar shall be appointed, declaring that such Minister is their Officiating Minister, shall be entitled to have his name inserted in the list of officiating Ministers in the meaning of this Act: *Provided always*, that such certificate shall be attested by two Justices of the Peace, and such attested certificate shall be sent in to the Registrar General or other officer as aforesaid, anew in the month of December in every year, and no such attested certificate presented to any Registrar by any Minister as aforesaid, shall continue in force unless renewed in like manner.”

“44. The several ecclesiastical authorities as aforesaid of the respective Religious Bodies, shall send in to the said Registrar General, or other officer as aforesaid, a correct

list of such Officiating Ministers in the month of December in every year."

The following are the Religious Bodies enumerated in Schedule D, above referred to:—

- "The United Church of England and Ireland
- "The Church of Scotland
- "The Roman Catholic Church
- "The Free Church of Scotland
- "All Presbyterian Congregations
- "The Wesleyan Methodist Society
- "All Congregational Independents
- "Baptists
- "The Primitive Methodist Society
- "The Lutheran Church
- "All Hebrew Congregations
- "The Society of Friends."

I have therefore to request that, before the termination of the month of December next ensuing, the names of all Officiating Ministers be sent in to me duly certified, in order that such names may be entered in a list, a copy of which will be published in the *New Zealand Government Gazette* in the month of January 1863.
