By His Excellency Sir GEORGE GREY, Knight Commander of the Most Honourable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

W HEREAS by the "Militia Acts Amendment Act, 1862," the Governor is empowered from time to time to call out the whole or any part or number of any Regiment, Battalion, Corps, or Company of Militia in any District as he shall think fit. And it appears to me expedient to call out for training and exercise part of the Militia of the District of Auckland hereinafter specified. Now therefore I, Sir George Grey, the Governor as aforesaid, in pursuance of the said recited power, do hereby call out for training and exercise :

The First Class of the said Militia of the Auckland District.

And I order Colonel Thomas Rawlings Mould, C.B., the Officer commanding the said District, to carry into effect this direction.

NOTICE is hereby given that His Excellency the Governor has been pleased to make and issue the order hereunder set forth, and the same is now published in pursuance of the "Militia Acts Amendment Act, 1862." ALFRED DOMETT.

By His Excellency Sir GEORGE GREY, Knight Commander of the Most Honourable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same &c., &c., &c.

W HEREAS it is provided by the "Militia Acts Amendment Act, 1862," that the number of days and hours for the meeting of the Militia for any District for training and exercise shall be from time to time fixed by the Governor; and whereas it is deemed expedient to call out for training and exercise certain portions of the Militia-of the Militia District of Auckland; Now therefore in pursuatice and execution of this power and authority conferred upon me by the said recited Act, I do hereby fix the number of days and hours during which that portion of the Militia of the Auckland District which is called out for training and exercise by instrument of even date herewith, shall be trained and exercised, shall be two hours per day for fourteen days.

THE names of many persons resident in the Militia District of Auckland having been missed in the Rolls which have just been formed, the attention of Militimen is called to the following clause of the Law regulating the Militia:---

"Company or any other Commissioned Officer "appointed by him, shall enroll all the men "Inable to serve therein, and any man who "shall not, within three months, after his bar "coming liable to serve, give in this name, age," "and place of residence to with OK "and place of residence to such Officer, in "order to be enrolled, shall forfeit any sum " not exceeding five pounds."

Any person, personally or by post, giving in his name, age, and place of residence,

2nd Battalion, Onehunga, Or at the Office of Captain Walmsley, Ad-jutant, 3rd Battalion, Otahuhu,

will be treated as having complied with the Law.
