#### ORDER IN COUNCIL.

At the Government House, at Auckland, the 6th day of July, 1863.

Present:

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by the "Militia Act, 1858,"
the Governor is empowered to constitute throughout the Colony or in any part thereof, Militia Districts, and such Districts from time to time to vary and to designate the Militia of any such Districts by the name of a Regiment, Battalion, Corps or Company: And whereas in and by an Order in Council made on the 9th day of June, 1860, the Militia District of Wairarapa was constituted and defined:

Now, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth by this present Order, designate the Militia within the said District by the name of a Regiment.

# Wairarapa Militia Regulations.

PY virtue and in exercise of the authority in me vested by the "Militia Act, 1858" and the "Militia Act Amendment Act, 1860," I, Sir George Grey, K.C.B., the Governor of the Colony of New Zealand, do hereby make and issue the following orders for the Regulation of the Wairarapa Regiment of Militia:—

1. The Wairarapa Militia District shall not be divided, but the Wairarapa Regiment shall constitute one Battalion:

2. Such Battalion shall be divided into three Classes:

- 3. The First Class shall consist of all unmarried men and all widowers without children, between the ages of sixteen years and forty years both inclusive, who shall be called the First Class service men. The Second Class shall consist of all married men and widowers with children between the same ages, who shall be called Second Class service men. And the Third Class shall consist of all men between the ages of forty years and fifty-five years, who shall be called the Reserve men.
- 4. The men of each class shall be formed by the Senior Officer of the Battalion into one or more Company or Companies, he having regard in su h formation to secure as far as possible contiguity of residence of the men in each Company.

## NEW ZEALAND.

CONDITIONS upon which land situate between Omata and Tataraimaka, in the Province of Taranaki, will be granted to settlers:—

 Settlements will be surveyed and marked out at the expense of the Government.

2. Each settlement will comprise not less than 100 town allotments and 100 farm sections.

3. A stockade on the most eligible site in each settlement will be erected at the expense of the Government.

4. A town will be laid out around or as near as conveniently may be to the stockade in one acre allotments.

5. Farms will be laid out around, or as near as conveniently may be to the town, in sections of 50 acres each.

6. Every settler under these conditions will be entitled to one town allotment and one farm section.

7. Priority of choice will be determined by lot.

8. No man above the age of 45 years will be accepted, and every applicant will be subject to an examination by an officer appointed by the Governor, and must produce such certificates of good health, character, and general fitness for the service, as such officer shall require.

9. Each accepted applicant will be provided, at the expense of the Government, with a steerage passage to New Plymouth. Before embarkation, he will be required to sign a declaration and agreement to the effect that he understands and will be bound by and fulfil these conditions.

10. On arrival at New Plymouth, he will be enrolled and required to serve in the Taranaki Militia. He will be enritled to pay and rations accordingly until he is authorised by the Government to take possession of his land, when he will be relieved of "actual service."

11. After taking possession he will be entitled to receive rations, free of cost for twelve months, upon the same scale as supplied to Her Majesty's troops; he will be allowed to retain possession, as a militiaman, of his arms and accoutrements, and he will be supplied with ammunition for use according to militia regulations.

12. No settler after taking possession will be permitted during the first three years after his arrival at New Plymouth to absent himself from his settlement for more than one calendar month in any one year without the leave of the Governor first obtained.

13. During such three years he will be liable to be trained and exercised as other Militia men; and whenever a portion only of the Taranaki Militia shall be called out for actual service, each settler will be deemed to be a Volunteer Militiaman, and will be required to serve as such. During such service he will be be entitled to the same pay, rations and allowance as other Militiamen.

14. On the expiration of three years from the day of his arrival at New Plymouth each settler, having fulfilled the conditions, but not otherwise, will be entitled to a Crown Grant of the Town allotment and farm section allotted to him; and will thenceforth be subject only to the same Militia services as other colonists.

15. Any settler desiring to leave his settlement will be permitted to do so on providing a substitute approved of by the Government. Such substitute will be subject to the same liabilities and entitled to the same privileges as the settler whose place he takes.

16. In case of the death of any settler before he shall become entitled to his Crown Grant, the land allotted to him will be at the disposal of the Government for the location of another settler under these conditions or for any other purpose, but the value of any improvements made thereon by the deceased settler will be determined by valuation, and the amount paid by the Government to such person (if any) as the deceased settler shall have appointed by writing to receive the same.

FORM OF DECLARATION AND AGREEMENT.

I do hereby declare that I fully understand the "conditions" hereunto annexed, and I do engage and agree to be bound thereby, and punctually on my part to fulfil all the terms thereof.
