### A PROCLAMATION

Intimating Her Majesty's assent to a certain Bill passed by the General Assembly.

> By His Excellency Sir GEORGE GREY, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand, and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

WHEREAS by an Act passed in the Session of Parliament held in the fifteenth and sixteenth years of Her Majesty's reign, initiuled "An Act to grant a Representative Constitution to the Colony of New Zealand," it is amongst other things enacted that no Bill which shall be reserved for the signification of Her Majesty's pleasure thereon shall have any force or authority within the Colony of New Zealand until the Governor of the said Colony shall signify, by speech or message to the Legislative Council and House of Representatives of the said Colony, or by Proclamation, that such Bill has been laid before Her Majesty in Council, and that Her Majesty has been pleased to assent to the same.

And whereas a certain Bill passed by the Legislative Council and House of Representatives of the said Colony, intituled "An Act to alter the Civil List," was presented to the Governor of the said Colony for Her Majesty's Assent, and the said Bill was reserved for the signification of Her Majesty's pleasure thereon: Now therefore I, the Governor of New Zealand, in pursuance of the provisions of the said in part recited Act, do, by this Proclamation, signify and proclaim to all whom it may concern that the said Bill has been laid before Her Majesty in Council, and that Her Majesty has been pleased to assent to the same.

### A PROCLAMATION

Extending the Jurisdiction of the Resident Magistrate's Court at Wairarapa.

> By His Excellency Sir GEORGE GREY, Knight Commander of the Most Honourable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

W HEREAS by the "Resident Magistrates, Jurisdiction Extension Act, 1862," i<sub>t</sub> is enacted that every case of a claim for deb<sub>t</sub> or damages such as might at the passing of the said Act be lawfully tried in a Residen Magistrate's Court where the debt or damage claimed do not exceed Twenty pounds may be tried in any Resident Magistrate's Court with respect to which this Act shall be in operation when the debt or damages claimed do not exceed Fifty pounds.

do not exceed Fifty pounds. Now therefore I, Sir George Grey, the Governor of New Zealand, in pursuance of the said recited Act, and of an Order in Council dated the seventeenth day of December one thousand eight hundred and sixty-two, authorising the issue of Proclamations under the said Act, do hereby proclaim and declare that the provisions of the said recited Act, and especially the powers conferred by sections two and three thereof, shall be exercised to the limit of jurisdiction of fifty pounds in the Resident Magistrate's Court at Wairarapa, in the Province of Wellington; and I do further proclaim and declare that this proclamation shall take effect on and from the first day of August, one thousand eight hundred and sixty-three.

### ORDER IN COUNCIL

Defining a certain Reserve in the Province of Auckland.

### Present:-

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS, by the "Waste Lands Act, 1858," it is provided that it shall be lawful for the Governor in Council at any time and from time to time to except from sale and reserve to Her Majesty, or dispose of in such other manner as for the public interest may seem best, such of the Waste Lands of the Crown in any of the Provinces of New Zealand as may be required for the purposes of Military Defence, or for the construction of Trunk Lines of road, or as sites for Public Buildings for the use of the General Government, or for other purposes of public utility or convenience: Now therefore, His Excel-lency the Governor, with the advice and consent of the Executive Council of New Zealand, doth hereby except from sale, and reserve to the use of Her Majesty, the parcels of land described in the Schedule hereto annexed.

And His Excellency the Governor doth hereby notify to the Superintendent of the

Province of Auckland that the land defined in the Schedule hereto has been reserved in terms of the Act before cited.

### SCHEDULE.

All those allotments or parcels of land situate in the Parish of Puni, in the County of Eden, being the Allotments of the Town of Cameron numbered as follows on the plan of the said Town, viz., Allotments numbered One, Two, Three, Four, Five, and Six, of Section numbered Two, containing two acres two roods and one perch, be the same more or less; Allotments numbered Five, Six, Seven, and Eight, of Section numbered Three, containing one acre and sixteen perches, be the same more or less; and Section numbered Eleven, containing six acres one rood and one perch, be the same more or less.

Also, all that parcel of land adjoining the said Town, and containing three acres one rood, and ten perches, be the same more or less, bounded towards the North by a public road or street, towards the East by the Waikato and Mauku Tramway, towards the South by the North Bank of the Waikato River, and towards the West by the East bank of the Mauku Stream.

Also, all that other parcel of ground situate in the town of Cameron aforesaid, and being the Allotments numbered as follows on the plan of the said Town, viz., Allotments numbered Three, Four, Five, Six, Seven, Sixteen, and Seventeen, of Section numbered four, containing by admeasurement two acres and eight perches, be the same more or less.

### ORDER IN COUNCIL

To prohibit the wandering at large of Cattle in the Taupari and Kohekohe Hundred, Lower Waikato.

### Present:-

HIS EXCELLENCY THE GOVERNOB IN COUNCIL. WHEREAS by an Act of the General Assembly of New Zealand, intituled "The Native Districts Regulation Act, 1858," it is provided that it shall be lawful for the the Governor in Council from time to time to appoint Districts for the purposes of the said Act, being Districts over which the Native Title shall not for the time being have been extinguished:

And by the same Act it is provided that it shall be lawful for the Governor in Council. from time to time to make and put in force within any such District Regulations (among other things) for the prevention of Cattletrespass and of the wandering of Cattle at large, and for defining and prescribing the rights, duties, and liabilities in relation to damage done by Cattle-trespass and otherwise in relation thereto of all owners or occupiers of land, persons owning or having charge of cattle and other persons, and that any such Regulations shall be made, as far as possible, with the general assent of the Native population affected thereby, to be ascertained in such manner as the Governor may deem fitting : And whereas the Native Lands in the Hundreds of Taupari and Kohekohe have become infested with Cattle wandering at large to the great injury of agriculture and to the peril of all travellers through the said lands : And whereas it is expedient to make and put in force within the said hundreds the following regulations, and the general assent thereto of the Native population has been ascertained to the satisfaction of the Governor :

Now, therefore, His Excellency the Governor, by and with the advice and consent of his Executive Council, doth hereby make and put in force within the said Hundreds of Taupari and Kohekohe, the following regulations ; that is to say,

1. No person shall have any right of ownership in unbranded cattle more than one year old, wandering at large over Native lands.

2. No person shall have any right of ownersbip in wild or dangerous cattle which shall have been wandering at large over Native lands for more than one year.

THE following Circular Despatch from Her Majesty's Principal Secretary of State for the Colonies respecting the distress which still prevails among the Manufacturing Population of the Northern Counties of England, is published for general information.

### Downing Street, 11th April, 1863.

Sir,-The distress which still prevails among the Manufacturing Population of the Northern Counties, and the apparent probability of its continuance, make it necessary for Her Majesty's Government carefully to consider the several schemes which have been proposed for rescuing the people from their present condition, and for enabling them again to earn an independent livelihood. Among those schemes, as you are no doubt aware, Emigration occupies a pro-minent place. If the people in question had been accustomed to out-door labour, and their numbers were less excessive, there would be no room to doubt that Emigration would afford to them, as it has to others, an immediate escape, and that their transfer to other portions of the Empire would be as beneficial to the Colonies as to the people themselves; but these people are differently circumstanced; a large majority of them have been accustomed to in-door work only, and would probably be incapable at first of perfoming any considerable amount of hard

labour out of doors. Others have been employed in out-door, though not absolutely agricultural labour, and these might be expected to be at once useful; but the numbers of the whole class are so great, and comprise so large a portion of women and children, that some doubt must be felt as to the possibility of their ready absorption by the Colonies, even irrespective of their previous employments.

If, however, it should be decided to encourage or assist the Emigration of any portion of those people, it would be of great importance to Her Majesty's Government to know accurately to which of Her Majesty's Colonial possessions their Emigration might be directed with the best prospect of advantage to the people themselves and to the Colony. The information at present at my command does not enable me to answer this question with confidence. think it better, therefore, to refer at once to you, and to request you to furnish me with the best information in your power upon the subject. You will understand that the people are destitute, and that they must therefore earn their living by working for wages, not by occupying or cultivating land on their own account. It is obvious that land is of no use to men who have not the means of living till they can raise a crop. In reporting on the subject I would request you to state what is the opening in the Colony for each class of the persons to whom I have referred ; that is, for married men with families, who have been accustomed to out-door though not agricultural labour ; for the same class who have been employed in in-door labour only; for single men of average health and strength who have been employed in out-door and in-door labour respectively; and for young women of good character who have been employed in the mills, but who may have had some experience of domestic service or might seem capable of undertaking it.

You will of course, however, not restrict yourself to the above points, if there are any others matters connected with the subject which it appears to you important that Her Majesty's Government should know.

I need hardly add, in conclusion, that I should be anxious to receive your answer to this despatch at your earliest convenience. I have &c,

### PROCLAMATION

Admitting Cattle into the Province of Otago from Queensland, Tasmania, and Twofold Bay, in New South Wales.

By the Honourable JOHN HYDE HARRIS, Esquire, Superintendent of the said Province

WHEREAS by a Proclamation dated the 5th day of June, 1862, the Superintendent of the Province of Otago, by virtue of the powers delegated to him under the "Diseased Cattle Act, 1861." did proclaim and declare that after the date of the said Proclamation all Districts, Places, and Ports wheresoever, out of the main land of the North and Middle Islands of New Zealand, should be deemed to be Infected Districts within the meaning and for the purposes of the said Act:

AND WHEREAS the Governor in Council hath, by Warrant under his hand, delegated to me, JOHN HYDE HARRIS, so long as I shall hold the office of Superintendent of the Province of Current the construction the Province of Otago, the several powers vested in the Governor by the second, fourth, fifth, seventh, ninth, and tenth sections of the said Act, subject to be rescinded as in the said Act is provided, and subject to the Regulations issued by the Governor in Council on the 1st day of October, 1861: And whereas by the 4th of the said Regulations it is provided that in the exercise of the powers delegated under the 9th Section of the said Act the Superintendent of any Province may from time to time, by

Proclamation in the Government Gazette of the Province, rescind any Proclamation of an Infected District, wholly, or as to any part thereof :

Now therefore, I, the said John Hyde Harris, by virtue of the powers vested in me in this behalf, do hereby Proclaim and Declare that I do hereby rescind the aforesaid Proclamation of the 5th day of June, 1862, so far as the same relates to the Colony of Queensland, the Colony of Tasmania, and the Port and District of Twofold Bay, in the Colony of New South Wales, and I do hereby declare that the said Districts shall not, from the date hereof until further notice, be deemed to be Infected Districts within the meaning and for the purposes of the above-mentioned Act :

And I do hereby further declare that it shall be lawful for me, the said Superintendent, to allow Cattle to be landed from vessels from the Chatham Islands, subject to such conditions and restrictions as I may deem expedient and the circumstances of any case may require.
