### A PROCLAMATION

certain Districts under the Appointing Marriage Act Amendment Act, 1858."

> By His Excellency Sir GEORGE GREY, Knight Commander of the Most Honourable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

WHEREAS by the "Marriage Act Amendment Act, 1858," it is enacted that it shall be lawful for the Governor at any time, by Proclamation in the New Zealand Gazette, to divide the Colony of New Zealand, for the purposes of the said Act, into such and so many Districts as he may think fit, and that every such District shall be called by a distinct name, and shall be a Registrar's District; and it is provided that the Governor may at any time revoke the whole or any part of such Proclamation, and issue a new Proclamation dividing the Colony, or any part of it, into Districts, or increasing the number or altering the boundaries of Districts as from

time to time he may think requisite. Now, therefore, I, Sir George Grey, Governor of the said Colony of New Zealand, in pursuance of the power and authority in me vested by the said recited Act, do hereby revoke every Proclamation at any time heretofore issued appointing or dividing Registrar's Districts under the said Act, so far as such Proclamations relate to Districts within the Provinces of Otago and Southland respectively; and do hereby proclaim and declare that on the West by the Taieri River.

the said Provinces shall be and are hereby divided for the purposes of the said Act into eleven Districts in the Province of Otago and three Districts in the Province of Southland, the names and boundaries whereof respectively shall be as follows:-----

PROVINCE OF OTAGO.

Dunedin District,

Comprises all that area bounded on the North by the Waihemo Creek, Blueskin Bay and the ocean; on the East and South by the Abbott's Creeks; thence by the watershed of the Kaikorai, Flagstaff, and Swamp Hill Ranges, to the source of the Waihemo Creek.

#### Waikouaiti District,

Comprises all that area bounded on the North by the Oamuru District; on the East by the ocean; on the South by Dunedin Dis-trict, thence by the watershed of the Silverpeak Hills to the source of Allen Creek, thence by the Allen Creek, Taieri, and Sutton, to Lammerlaw; and on the West by the watershed of Lammerlaw and Rough-ridge Ranges to Mount Ida.

#### Dunstan District,

Comprises all that area bounded on the North by Oamura District; on the East by Waikouaiti District; on the South by the Minzion Burn, Clutha, and an East and West line to Mount Benger; and on the West by the watershed of Mount Benger, Obelisk, Carrick, Double Rock Ranges to Mount Pisa.

# East Taieri District,

Comprises all that area bounded on the North by Waikouaiti District; on the East by Dunedin District; on the South by the Ocean; and

#### West Taieri District,

Comprises all that area bounded on the North by Waikouaiti District; on the East by East Taieri District; on the South by the Waipori Lake and River to Lammerlaw.

### Tokomairiro District,

Comprises all that area bounded on the North by East and West Taieri Districts; on the East by the ocean; on the South by the Clutha River and North branch; and on the West by the Waitahuna and Dullburn to Mount Stuart, thence by the watershed of Mount Stuart, Round Hill, and Waitahuna Ranges to the Waipori River.

#### Tuapeka District,

Comprises all that area bounded on the North by Dunstan and West Taieri Districts; on the East and South by Tokomairiro District and on the West by the Clutha.

#### Warepa District,

Comprises all that area bounded on the North by Wakatip and Dunstan Districts; on the East by Tuapeka and Tokomairiro Districts; on the South by the ocean; and on the West by the Mataura.

#### Oamaru District,

Comprises all that area bounded on the North by the Province of Canterbury; on the East by the ocean; on the South by the Horse, Kakanui Hawkden Ranges; and on the West by Mount St. Bathans, and the continuation of the Dunstan Mountains to the Province of Canterbury.

#### Wanaka District,

Comprises all that area bounded on the North by the Province of Canterbury; on the East by Oamaru District; on the South by the Dunstan District, thence by the Tinwald to Mount Pisa; on the West by the watershed of the Mount Pisa and Earnslaw Ranges to the Province of Canterbury.

#### Wakatip District,

Comprises all that area bounded on the North by the Province of Canterbury and the Wanaka District; on the East by the Dunstan District; on the South by Warepa District, by the Province of Southland, and by the ocean; and on the West by the ocean.

#### PROVINCE OF SOUTHLAND.

### Campbelltown District,

Bounded on the East by the Mataura; on the South by the ocean; on the West by the estuary of the New River; and on the North by the Mokomoko inlet and a right line from the South-east corner thereof drawn East to cut the Mataura.

#### Invercargill District,

Bounded on the East by the Mataura; on the South by the Campbelltown District and the occan; on the West by the Waimatuku River to its source; thence by a right line North-west to cut the Aparima, thence by the Aparima to the junction of Hamilton Burn, thence by a right line North to the Oreti,

thence by the Oreti to the junction of Wind-ley River; and on the North, the North boundary of the Province.

#### Riverton District,

Bounded on the East by Invercargill District; on the South by the ocean; on the West by the Waiau; and on the North by the North boundary of the Province.

And I do declare that this Proclamation shall come into operation and take effect on and from the first day of September, one thousand eight hundred and sixty-three.

> By His Excellency Sir GEORGE GREY, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand, and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

W HEREAS by the "Registration Act, 1858," it is enacted that it shall be lawful for the Governor at any time by Pro-clamation in the New Zealand Gazette to divide the Colony of New Zealand for the purposes of the said Act into such and so many Districts as he may think fit, and that every such District shall be called by a distinct name and shall be a Registrar's District, and it is provided that the Governor may at any time revoke the whole or any part of such Proclamation, and issue a new Proclamation dividing the Colony or any part of it anew into Districts or increasing the number or altering the boundaries of Districts as from

time to time he may think requisite: Now, therefore, I, Sir George Grey, the Governor of the said Colony of New Zealand, in pursuance of the power and authority in me vested by the said recited Act do hereby revoke every Proclamation at any time heretofore issued appointing or dividing Registrars Districts under the said Act so far as such Proclamations relate to Districts within the Pro-vinces of Otago and Southland respectively and do hereby proclaim and declare that the said Provinces shall be and are hereby divided for the purposes of the said Act into eleven Districts in the Province of Otago, and three Districts in the Province of Southland, the

#### PROVINCE OF OTAGO. **Dunedin** District

North by the Waihemo Creek, Blueskin Bay, and the Ocean, on the East and South by the Ocean, and on the West by Kaikorai and Abbott's Creeks, thence by the Watershed of the Kaikorai, Flagstaff, and Swamp Hill Ranges to the source of the Waihemo Creek.

#### <sup>7</sup>aikouati District

Comprises all that area bounded on the North by Oamaru District, on the East by the Ocean, on the South by Dunedin District, thence by the Watershed of the Silverpeak Hills to the source of Allen Creek, thence by the Allen Creek, Taieri, and Sutton to Lam-merlaw, on the West by the Watershed of Lammerlaw, and Rough-ridge Ranges to Mount Ida.

#### **Dunstan** District

Comprises all that area bounded on the North by Oamaru District, on the East by Waikouati District, on the South by the Min-zion Burn, Clutha, and an East and West line to Mount Benger, and on the West by the watershed of Mount Benger, Obelisk, Carrick, Double Rock ranges to Mount Pisa.

#### East Taieri District

Comprises all that area bounded on the North by Waikouaiti District, on the East by Dunedin District, on the South by the Ocean, and on the West by the Taieri River.

#### West Taieri District

Comprises all that area bounded on the North by Waikouaiti District on the East by East Taieri District, on the South by the Waipori Lake and river to Lammerlaw.

#### Tokomairiro District

Comprises all that area bounded on the North by East and West Taieri Districts, on the East by the Ocean on the South by the Clutha River and North branch, and on the West by the Waitahuna and Dullburn to Mount Stuart, thence by the Watershed of Mount Stuart, Round Hill, and Waitahuna Ranges to the Waipori River.

#### Tuapeka District

Comprises all that area bounded on the North by Dunstan and West Taieri Districts, on the East and South by Tokomairiro Dis-trict, and on the West by the Clutha.

#### Wharepa District.

Comprises all that area bounded on the North by Wakatip and Dunstan Districts, on the East by Tuapeka and Tokomairiro Dis-tricts on the South by the Ocean, and on the West by the Mataura.

#### **Oamaru** District

Comprises all that area bounded on the North by the Province of Canterbury, on the East by the Ocean, on the South by the Horse, Kakanui, Hawkdun ranges, and on the West

Canterbury.

#### Wanaka District

Comprises all that area bounded on the Comprises all that area bounded on the North by the Province of Canterbury, on the East by Oamaru District, on the South by the Dunstan District, thence by the Tinwald to Mount Pisa, on the West by the Watershed of the Mount Pisa and Earnslaw Ranges to the Province of Canterbury.

#### Wakatip District

Comprises all that area bounded on the North by the Province of Canterbury and the Wanaka District, on the East by the Dunstan District, on the South by Warepa District, by the Province of Southland, and by the Ocean, and on the West by the Ocean.

# Cambelltown District

Bounded on the East by the Mataura, on the South by the Ocean, on the West by the estuary of the New River, and on the North by the Mokomoko inlet and a right line from the South East corner thereof drawn East to cut the Mataura.

#### Invercargill District.

Bounded on the East by the Mataura, on the South by the Campbelltown District and the Ocean, on the West by the Waimatuku river to its source, thence by a right line North West to cut the Aparima, thence by the Aparima to the junction of Hamilton Burn, thence by a right line North to the Oreti, thence by the Oreti to the junction of Winley river, and on the North, the North boundary of the Province.

#### Riverton District.

Bounded on the East by Invercargill District, on the South by the Ocean, on the West by the Waiau, and on the North by the North boundary of the Province.

And I do declare that this Proclamation shall come into operation and take effect on and from the 1st day of September, One thousand eight hundred and sixty-three.

By His Excellency Sir GEORGE GREY, Knight Commander of the most Honourable Order of the Bath, Governor and Commanderin-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice Admiral of the same, &c., &c.

TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETING:-

WHEREAS by an Act of the General Assembly, intituled "The Regulation of Elections Act, 1858," it is enacted that it shall be lawful for the Governor by Warrant under his hand from time to time, to appoint Polling Places for each Electoral District within or without the limits thereof, and to appoint any one of such places to be the Principal Polling Place for the District, and all or say of ruch Polling Places at any time to abolish, and to appoint other Polling Places in lieu thereof. And whereas by another Act of the General Assembly, initialed "The Provincial Elections Act, 1858," it is enacted that, subject to certain provisions therein contained, every Election of the Superintendent or of a Momber of the Provincial Council of a Province shall be conducted in the manner prescribed by "The Regulation of Elections Act, 1858," aforesaid, and all the provisions of the said last mentioned Act shall apply to the Elections of Members of Provincial Councils.

THE following Despatch from Lieut,-General Cameron, C.B., is published for general information,

Alfred Domett.

Head Quarters, Queen's Redoubt,

July 13th, 1863.

SIR,-I have the honor to inform Your Excellency, that at daybreak yesterday morning, I crossed the Mangatawhiri with the head quarters of the 2nd Battalion 14th, and a detachment of the 12th regiment, amounting together to 380 men. It was necessary to descend the stream for about half a mile from the termination of the new road; and the left bank where we crossed was so steep that the troops had great difficulty in ascending it. They are now encamped on the Koheroa, about 500 yards from the river; and a redoubt will be constructed immediately which will command the navigation of the river, and secure the communication between the Queen's Redoubt, and the Stockade on the Waikato.

The Troops were conveyed down the river in the cutter of H.M.S. *Harrier*, and a few other boats, manned by a party of men from the *Harrier*. Capt. Sullivan, R.N., was kind enough to superintend the embarkation and landing of the troops. The boats above mentioned, and Capt. Sullivan's gig. were brought overland the day previous—those of the *Harrier* from Drury, and the others from Auckland; and were carried from the Queen's Redoubt down to the river during the night. The whole of these arrangements were under Capt. Sullivan's immediate direction and supervision.

I have also to inform Your Excellency that Colonel Wyatt marched from Drury with 300 men of the 65th Regiment yesterday afternoon, and reached Tuakau this morning. On their approach, the Natives abandoned the Settlement, and retired in boats across the river.

The detachment is now encamped on a height overlooking the Waikato, and commanding its navigation, and a redoubt for 150 men will be constructed there.

#### Head Quarters, Queen's Redo

Queen's Redoubt, July 18th, 1863.

SIR,—I have the honor to inform your Excellency, that at eleven o'clock, yesterday morning, Lieut.-Colonel Austen, 2nd Batt. 14th Regiment, commanding the camp at the Kohiroa, having observed a large body of Natives collecting on the hills in his front, instantly ordered his Battalion to get under arms and moved with praiseworthy promptitude against them, followed by detachments of the 12th and 70th Regiments, which had just arrived at the Camp as a reinforcement, the whole force amounting to about 500 men.

A report of the circumstances reached me

as I was on my way to the Kohiroa, and I hastened towards the column, which I overtook on its march. After we had proceeded in skirmishing order about two miles the rebels opened fire upon us, and as we advanced upon them they retired along the narrow crest of the hills towards the Maramarua, making a stand on every favourable position which the ground presented. Some of their positions, which had been recently fortified by lines of rifle-pits, and which from the nature of the ground could not be turned, they defended with great obstinacy, and as we had no artillery in the field they could only be dislodged from them by successive attacks with the bayonet, which were executed by the 2nd Batt. 14th, with great gallantry and success.

We pursued them from one position to another, a distance of about five miles, until we drove them in great confusion across the mouth of the Maramarua, some escaping up the Waikato in canoes, and others along its right bank, after swimming across the Maramarua. A considerable portion of them, however, before reaching the Maramarua escaped down a gully to the left, seeking shelter in a swamp, and suffered severely from the fire of our men on the heights. As we had no means of crossing the Maramarua, I ordered the troops to return to camp.

All the troops behaved remarkably well. I am greatly indebted to Lieut.-Colonel Austin, 2nd Battalion 14th Regiment (who was wounded in the arm); to Major Ryan, commanding detachment 70th Regiment; and Brevet Major Miller, commanding detachment of the 12th Regiment, for the manner in which they led and directed the movements of the men under their respective commands.

Among the Officers conspicuous for their forwardness in the attack were Captain Strange 14th Regt., who commanded the leading company of the column, Captain Phelps who greatly distinguished himself at the head of his company when charging a line of rifle pits, and Lieutenants Glancy and Armstrong also of the 2nd Batt. 14th Regiment.

Colonel Mould, C.B., Royal Engineers, was with the column during the engagement and ready to give his valuable services if required.

I enclose a list of our casualties, which are small, considering the time the engagement lasted, and the nature of the ground, which was exceedingly favourable for defence.

The enemy must have had fully three hundred men in the field, almost the whole of them belonging to tribes of the Waikato. There can be no doubt his loss was considerable, upwards of twenty dead having been counted by us on the ground, several of whom were Chiefs of consequence, and among others an uncle of the king.

#### Head Quarters, Queen's Redoubt, July 13th, 1863.

SIR,-I have the honor to forward for the information of your Excellency the copy of a report from Captain J. Ring, 2nd Batt. 18th Regiment, of on attack made by the rebel natives upon an escort under his charge not far from Mr. Martin's farm on the road 'between this and Drury. The conduct of Captain Ring and the small detachment under his command, attacked as they were by a vastly superior force and under the most unfavourable circumstances reflects the greatest credit upon them.

I have also to forward a copy of a Report from Colonel Murray detailing his movements upon a body of rebels at Keri Keri, and the capture of prisoners.

Camp, Drury, 17th July, 1863.

SIR,-I have the honor to report for your information that on my march from the Queen's Redoubt to Drury this day, my escort &c, as per margin\* were fired upon by the Natives at Stone Depôt, near Baird's Farm The fire was opened on my advance guard on both flanks, and my right flank and rear was immediately fired upon, the fire took effect on the centre of the convoy, one driver and two horses of his escort fell, which, dividing the convoy, &c., was taken advantage of by the Natives, who, dashing in force across the road, opened fire on the left flank, thus exposing my rear guard, consisting of prisoners and escort, to a severe fire from the bush from each flank and right rear. I immediately retired with as many, men as I could concentrate, and firing kept the enemy from surrounding my very small party, though in skirmishing order. During the contest the fire of the enemy was well returned, and I personally saw five or six Natives fall; they came out on the open but a charge quickly drove them into the bush, finally their attempting to surround my party obliged me to retire to Mr. Martin's house, which I occupied until reinforced.

SIR,-I have the honor to report for the information of the Lieut.-General Commanding that in obedience to his orders, I moved off this morning at 3 30 a.m., with a force as per mar-gin,\* and proceeded to Kirikiri for the purpose of arresting as many of the natives of that village as I could find. The mounted force having proceeded to the front, I telegraphed to His Excellency the Governor requesting the ser vices of the Volunteer Cavalry under Colonel Nixon, arranging that they should meet me at On Papakura at 4 a.m., which they did. arriving at the place just as day broke, I ascertained that the natives had retired up the hill about half a mile off, where they had a settle-ment in the bush. I accordingly divided my force into two bodies; the 65th Regiment, under the command of Captain Gresson, proceeded up the right by a track leading to the summit of the hill, where the natives were supposed to be most numerous. At the same time I directed Colonel Nixon, commanding Volunteer Cavalry, to send a part of his force with them, and which he led himself. The second party, under command of Captain Noblett, 2nd Battalion 18th Regiment, proceeded along the Wairoa road (which leads to the left from Kirikiri, and crosses the line through the bush) with instructions to take up a post to cut off the retreat by that road, reserving at the same time the remainder of Colonal Nixon's force at the foot of the hill to act as circumstances might require.

So quietly and expeditiously were these movements made that, on Captain Gresson's party reaching the spot to which it was directed, it came at once upon the Chief Isaac and his perty situated at the edge of the bush, all of whom were made prisoners before any resistance could be offered, amounting in all to 13 men, 7 women, and 3 children. A number of arms, accoutrements, and ammunition (as per list enclosed) also fell into our possession, the whole of which, together with the prisoners, are at present in the Camp at Drury, awaiting instructions from His Excellency the Governor as to their final dispusal. The main body of the Natives were encamped in the bush, of which I was not made aware in time to push on the 18th far enough; they, however, suc-

General's notice the very orderly conduct of the troops engaged. Officers and men bore with cheerfulness the fatigues of the long and harassing march, under heavy rain, through roads knee-deep in mud.

To Lieut. Reid, R.A., I am indebted for able assistance, that officer having volunteered to accompany me with four of his men, and whose services in conveying orders were of great use to me. I trust that the result of the movement such as it has been, will meet the Lieut.-General's approval.

I cannot speak too highly of the promptness with which Colonel Nixon's force turned out, having only received orders at a very late hour of the night to join me at Papakura, at 4 o'clock in the morning, as well as their orderly and efficient appearance under arms, which I think it due to Colonel Nixon, to bring to the particular notice of the Lieut.-General.
