#### A PROCLAMATION

Declaring certain articles contraband of War.

> By His Excellency Sir GEORGE GREY, Knight Commander of the most Honourable Order of the Bath, Governor and Comander-in-Chief in and over Her Majesty's Colony of New Zealand, and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

WHEREAS by the "Arms Act, 1860," it is enacted that it shall be lawful for the Governor by Proclamation published in the *New Zealand Gazette* from time to time to declare what articles shall be considered as warlike stores for the purposes of the said Act and also for the purposes of an Ordinance of the Lieutenant Governor and Legislative Council of New Zealand passed in the sixth session of the said Council intituled "An Ordinance to empower the Governor of New Zealand to regulate the Importation and sale of Arms, Gunpowder and other Warlike stores."

New therefore I Sir George Grey the Governor of the said Colony in pursuance and exercise of the said power and authority do hereby proclaim and declare that the undermentioned articles shall (amongst others) be considered as Warlike stores for the purposes above-mentioned that is to say :--

Firearms of every description,

Accoutrements for such arms,

Gunpowder of every description in cartridge or otherwise,

Percussion caps, Flints,

Lead, Zinc and Copper, manufactured or otherwise,

Shot, Ball, Bullets, Marbles,

- Saltpetre, Bayonets, Pikes, Hay-forks, Scythes, Swords, Tomahawks, Adzes, and all other edged tools of whatever description soever capable of being used as weapons,
- Iron of all kinds capable of being converted into weapons.

W HEREAS by the "Registration Act, 1858," it is enacted that it shall be lawful for the Governor at any time by Proclamation in the New Zealand Gazette to divide the Colony of New Zealand for the purposes of the said Act into such and so many Districts as he may think fit, and that every such District shall be called by a distinct name and shall be a Registrar's District, and it is provided that the Governor may at any time revoke the whole or any part of such Proclamation, and issue a new Proclamation dividing the Colony or any part of it anew into Districts or increasing the number or altering the boundaries of Districts as from time to time he may think requisite :

#### Wairau District.

Bounded on the North by the Southern boundary of Picton District from the range of hills dividing White's Bay from Robin Hood's Bay to Mount Richmond, thence by a line running Northerly to the red hills, thence by the Eastern boundary of the Nelson District to the Wairau Gorge, thence to the summit of the Watershed between the Gorge and Barefell's Pass, thence to the Upper Gorge of the Clarence, thence in a Southeasterly direction to the summit of the Gorge, thence along the range by the summits to Mounts Freya and Thor, thence to the junction of the first branch of the Clarence, thence down the Clarence to its mouth, thence following the Sea Coast to the aforesaid range of hills dividing White's Bay from Robin Hood's Bay.

And I do declare that this Proclamation shall come into operation and take effect on and from the fourteenth day of September, One thousand eight hundred and sixty-three.

HEREAS by the "Marriage Act Amendment Act, 1858," it is enacted that it shall be lawiul for the Governor at any time by Proclamation in the New Zealand Gazette to divide the Colony of New Zealand for the purposes of the said Act into such and so many Districts as he may think fit, and that every such District shall be called by a distinct name and shall be a Registrar's District; and it is provided that the Governor may at any time revoke the whole or any part of such Proclamation and issue a new Proclamation dividing the Colony or any part of it anew into Districts, or increasing the number or altering the boundaries of Districts as from time to time he may think requisite :

Now, therefore, I Sir George Grey, the Governor of the said Colony of New Zea-land, do hereby revoke every Proclamation

heretofore issued, so far as they relate to the constitution of the Districts at present designated the District of Wairau and the District of Awatere, and do proclaim and declare that the territory hitherto comprised within such Districts shall be and is hereby constituted for the purposes of the said Act into One District, the name and boundaries whereof shall be as follows :-

#### WAIRAU DISTRICT.

Bounded on the North by the Southern boundary of Picton District, from the range of hills dividing White's Bay from Robin Hood's Bay to Mount Richmond, thence by a line running Northerly to the Red Hills, thence by the Eastern boundary of the Nelson District to the Wairau Gorge, thence to the summit of the Watershed between the Gorge and Barefells Pass, thence to the upper Gorge of the Clarence, thence in a South-Easterly direction to the summit of the Gorge, thence along the range by the summits to Mounts Freya and Thor, thence to the junction of the first branch of the Clarence, thence down the Clarence to its mouth, thence following the sea coast to the aforesaid range of hills dividing White's Bay from Robin Hood's Bay.

And I do declare that this Proclamation shall come into operation and take effect on and from the Fourteenth day of September, One thousand eight hundred and sixtythree.

Report of Detachment, 2 Officers, 4 Petty Officers, and 37 Men of the Naval Volun-

Officers, and 37 Men of the Naval Volunteers, accompanied by Mr. Puckey and 25 Natives, on Service in Manukau Harbour.

Saturday July 18th. Left Auckland and arrived at Onehanga at 2 p.m., finding no boats ready remained there the night. Sunday July At 6 a.m. muster and told off boats 19th. crews No. 1, cutter Lizzie in charge of myself, No. 2, cutter Tam O'Shanter charge of Sub-Lieut. Stephenson, natives divided on the boats. At 1 p.m. proceeded to Mangarie, being too late for tide returned on board. Monday, July 20. At 7. a.m. manned boats and landed at Mangarie. Self and Mr. Puckey went to the Settlement, and the natives made no objection to our taking the Canoes. Our natives launched 3 canoes, and the boats crew towed them to Geddes' Basin, and marked them No. 1. Sent an armed party round Mangarie in search of canoes but found none. At 2 p.m. weighed and proceeded to Puponga. Tuesday at 7 a m. weighed and proceeded to Papakura Creek, blowing strong from S.W., could not land at Ihumata, Arrived at Papakura Creek at  $10\frac{1}{2}$  a.m. and searched the creeks; found 6 cances At 12 p.m. took an armed party with the natives and launched the canoes, and dropped down to H.M.S, Harrier.

Wednesday, 6 a.m., received provisions from H. M. S. *Harrier*, 7 a.m. proceeded up Papakura Creek, when a party informed me there was an attack made on the settlers, immediately landed Sub-Lieutenant Stephenson and 12 men, and returned for more men, leaving I Petty Officer and 6 men in charge of the vessels. At 11 proceeded and took a

position on high ground, near the chapel. Detached a petty officer and 20 men out skirmishing, who returned at 5 p.m., sentries were then placed, and at 10 p.m. they were relieved by Volunteer Militia, and my men went on patrol until 2 a.m. and then proceeded to the vessels.

Thursday 7 a.m. weighed and proceeded to Pukohe, at 31 p.m. searched the creeks and found 4 cances, 8 p.m. returned to the vessels and weighed.

Friday 6 a.m.,boats manned and proceeded to Ihumata and Oruronga found 4 cances, weighed and proceeded to Onehunga.

Saturday 4 s.m. arrived at Onehunga with 14 cances and put them in the Basin. 10 a.m. marched for Auckland and arrived at noon.

I am happy to report that with one exception the conduct of the officers and men was highly satisfactory, also that the natives were well conducted obedient to orders, and did everything in their power to carry out the object of the expedition.

I have also to report that there are a quantity of canoes broken up, but some of them are still repairable.
