A PROCLAMATION

For the Naturalization of certain persons.

By His Excellency Sir GEORGE GREY, Knight Commander of the most Honourable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same, &c., &c.

WHEREAS by the "Naturalization Act, 1862," it is enacted that every person who shall be declared to come within the operation of that Act by any Proclamation to be issued in that behalf by His Excellency the Governor, shall as from the time in such Proclamation specified, be deemed and taken until the termination of the next Session of the General Assembly to be and to have been from such specified time a natural born subject of Her Majesty within the Colony of New Zealand, as fully to all intents and purposes as if his name had been inserted in the Schedule to that Act annexed. Provided always that every such Proclamation shall contain the description, occupation or calling, of every person therein named, and his place of residence at the date of such Proclamation.

Now, therefore, I, Sir George Grey, the Governor of New Zealand, in pursuance of the power and authority in me vested by the said Act, do hereby proclaim and declare that the persons hereinafter mentioned shall come within the operation of the said Act, from the dates hereinafter specified, viz.:-

OTTO WIESENHAVERN,

From the Twenty-fifth day of June, One thousand eight hundred and sixty-three—Native of Hanover—Tobacconist—Residence, Nelson, in the Province of Nelson.

CHARLES PARKER,

From the Twenty-third day of July, One thousand eight hundred and sixty-three—Native of Sweden—Labourer—Residence, Wellington, in the Province of Wellington.

FRIEDRICH TUMMEL,

From the First day of July, One thousand eight hundred and sixty-one—Native of Prussia—Leaseholder—Residence, Napier, in the Province of Hawke's Bay.

EDWARD FRANCK,

From the First day of April, One thousand eight hundred and sixty-two—Native of Prussia—Merchant—Residence, Dunedin, in the Province of Otago.

DANIEL MCFARLANE,

From the First day of January, One thousand eight hundred and sixty-three—Native of United States of America—Settler—Residence, Auckland, in the Province of Auckland.

RICHARD BECK,

From the First day of August, One thousand eight hundred and sixty-three—Native of Germany—Watchmaker—Residence, Auckland, in the Province of Auckland.

JOHN AUGUST RICHTER,

From the Eight day of January, One thousand eight hundred and sixty-three—Native of Germany—Miller—Residence, near Invercargill, in the Province of Southland.

MARIA RICHTER,

Wife of the above John August Richter.

JOHN ERNEST RICHTER,

From the Eight day of January, One thousand eight hundred and sixty-three—Native of Germany—Carpenter—Residence, near Invercargill, in the Province of Southland.

For the Naturalization of Gustavus Ferdinand Von Tempsky.

By His Excellency Sir GEORGE GREY, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

From the Twenty-fourth day of August, One thousand eight hundred and sixty-three, —Native of Prussia,—Digger,—Residence, late of Coromandel, now Drury, in the Province of Auckland.

HIS Excellency the Governor directs the publication of the following Act passed by the Imperial Parliament entitled "An Act to alter the Boundaries of New Zealand."

ALFRED DOMETT.

An Act to alter the Boundaries of New Zealand.

WHEREAS by the Eightieth Section of an Act of the Fifteenth Year of Her Majesty, Chapter Seventy-two intituled *An Act to grant a Representative Constitution to the Colony of New Zealand*, it was provided, that for the Purposes of that Act the said Colony should be held to include the Territories therein mentioned: And whereas it is expedient to alter the Limits of the said Colony as declared by the said Act: Be it therefore enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Authority of the same as follows:

1. So much of the Eightieth Section of the aforesaid Act of Parliament as declares the Limits of the Colony of *New Zealand* for the Purposes of the said Act is repealed.

2. The Colony of *New Zealand* shall for the purposes of the said Act and for all other

purposes whatever be deemed to comprise all Territories, Islands, and Countries lying between the One hundred and sixty-second Degree of East Longitude and the One hundred and seventy-third Degree of West Longitude, and between the Thirty-third and Fifty-third Parallels of South Latitude.

NOTICE.

ON and after the 1st of June, 1863, a FLOATING LIGHT-SHIP will be moored inside the *Little Basses Reef*:—The centre of Rocks bearing S. b. W. $\frac{1}{2}$ W., distant about one-third of a mile.

It will exhibit a FLASHING LIGHT between the hours of sunset and sunrise, at intervals of one minute and a half.

It is 33 feet above the Sea, and from the horizon dips at 7 miles; to a ship within that distance, in fine weather it does not entirely

disappear; and is visible 11 miles from a ship's deck of 18 feet elevation.
