#### GREETING :

WHEREAS it has been proposed that an Exhibition of Agricultural and Industrial Products and Manufactures of our Colony of New Zealand, and such Products and Manufactures of other Countries as may in the opinion of the Commissioners be eminently calculated to be useful in the development of our said Colony, should be held at Dunedin, in the Province of Otago, in our said Colony: And whereas it has been further proposed that a Commission should be appointed for the purpose of devising and carrying out such Exhibition:

Now know you that we, reposing special trust and confidence in your knowledge and ability, have thought fit to constitute and ap-

point and by these presents do constitute and appoint you, the Superintendent for the time being of the said Province of Otago, President of the said Commission; the Colonial Secretary for the time being of the said Colony, the Colonial Treasurer for the time being of the said Colony, the Native Minister for the time being of the said Colony, the Superintendents for the time being of the other Provinces of the said Colony, Christopher William Rich-mond, Esquire, and Major John Larkins Cheese Richardson, Vice-Presidents of the said Commission ; and James Hector, Thomas Dick, Thomas Bannatyne Gillies, James Paterson, William Mason, Edward Bowes Cargill, John Cargill, Richard Bowden Martin, James Rattray, Alfred Eccles, Henry Clapcott, Richard Seaward Cantrell, William Hunter Reynolds, and Julius Vogel, Esquires, to be our Commissioners to devise and carry out the details necessary to facilitate the Ex-hibition in Dunedin, in our Colony of New Zealand, of articles the produce and manufacture of our said Colony, and of such other Countries as you may determine: And for the purpose of aiding you in the execution of the premises, we hereby appoint our trusty and well-beloved Thomas Dick aforesaid to be Honorary Treasurer to this our Commis-sion, and our trusty and well-beloved Alfred Eccles aforesaid to be Honorary Secretary to this our Commission: And we do by these presents give and grant to you or any three or more of you full power and authority to carry into effect the purposes of this our Commission by all lawful ways and means whatsoever : And we do hereby authorise the Superintendents respectively of the Provinces of our said Colony to appoint in the several Provinces local Committees of such persons as each said Superintendent may consider it expedient to appoint for the purpose of en-couraging the production of articles to be exhibited, of transmitting them to Dunedin, and of conducting communication between Exhibitors and the Commissioners : And we do by these presents ordain that this our Commission shall continue in full force and virtue, and that you our said Commissioners, or any three or more of you, shall and may from time to time, and at any place or places, proceed in the execution thereof, and of every matter and thing therein contained, although the same be not continued from time to time by adjournment:

In testimony whereof we have caused these our letters to be made patent, and the seal of our said Colony to be hereunto affixed :

IIS Excellency the Governor has been pleased to direct the publication, for general information, of the following Conditions upon which land situated in the Northern Island of New Zealand, will be granted to settlers willing to perform the after mentioned Military services.

# ALFRED DOMETT.

#### NEW ZEALAND.

CONDITIONS upon which land in the Northern Island of New Zealand, will be granted to settlers willing to perform the after mentioned Military services :--

1. No man above the age of 40 years will be accepted, and every applicant will be subject to an examination by an officer appointed by the Governor, and must produce such certificates of good character, health, and general fitness for the service, as such officer shall require.

2. Each accepted applicant, if not already in the Northern Island, will be provided with a free passage to a port to be designated by an agent of the Governor. Before embarkation, he will be required to sign a declaration and agreement to the effect that he understands and will be bound by and fulfil these conditions.

3. On arrival the men will be enrolled in the Militia for service in the Northern Island of the Colony, and formed into companies; constituted as nearly as may be as follows:—

- 1 Captain,
- 1 Subaltern,
- 5 Sergeants,
- 5 Corporals,
- 100 Privates.

4. Each man according to his rank will be entitled to pay, rations, and allowances, until he is authorised by the Government to take possession of his land, when he will be relieved from "Actual service."

5. Settlements will be surveyed and marked out at the expense of the Government, in such localities, in the Northern Island as the Government may select for that purpose.

6. Each settlement will comprise not less than 100 town allotments, and 100 farm sections.

7. A stockade on the most eligible site in each settlement will be erected at the expense of the Government.

8. A town will be laid out around, or as

near as conveniently may be to the stockade in one acre allotments.

9. Farms will be laid out around, or as near as conveniently may be to the town. The size of the farm section allotted to each will be according to his rank in the Militia.

10. Every settler under these conditions, who upon being relieved from actual service, receives a certificate of good conduct, will be entitled to one town allotment and one farm section.

11. Priority of choice for each rank will be determined by lot.

12. After taking possession he will be entitled to receive rations, free of cost for twelve months, upon the same scale as supplied to Her Majesty's troops; he will be allowed to retain possession, as a militiaman, of his arms and accoutrements, and he will be supplied with ammunition for use according to militia regulations.

13. No settler after taking possession will be permitted during the first three years after his enrolment in the Militia to absent himself from his settlement for more than one calendar month in any one year without the leave of the Governor first obtained.

14. During such three years he will be liable to be trained and exercised as other militiamen; and whenever a portion only of the Militia shall be called out for actual service, each settler will be deemed to be a Volunteer Militiaman, and will be required

to serve as such anywhere that may be required in the Northern Island of the Colony. During such service he will be entitled to the same pay, rations and allowances as other Militiamen.

15. On the expiration of three years from his enrolment, each settler, having fulfilled the conditions, but not otherwise, will be entitled to a Crown Grant of the town allotment and farm section alloted to him; and will thenceforth be subject only to the same Militia services as other colonists.

16. Any settler will be permitted to dispose of his land to any person approved of by the Government; and such person undertaking to be subject to the same liabilities will be entitled to the same privileges as the settler whose place he takes.

17. In case of the death of any settler, before he shall have become entitled to his Crown Grant, the land to which he is entitled, will be granted to his wife or children, or to such other person as he shall by writing appoint; or it may be taken for the location of another settler under these conditions, or for any other purpose, but the value thereof in such latter case will be determined by valuation, and the amount paid by the Government to the settler's widow or children, or other person appointed as aforesaid.

#### FORM OF DECLARATION AND AGREEMENNT.

I do hereby declare that I fully understand the "Conditions" hereunto annexed, and I do engage and agree to be bound thereby, and punctually on my part to fulfil all the terms thereof.

Alteration in Rates of Postage via Marseilles.

> General Post Office, Auckland, 1st September, 1863.

THE following Despatch respecting alteration in the rates of Postage via Marseilles is published for general information.

READER GILSON WOOD.

#### Downing-street, 27th May, 1863.

SIR,-I have the honor to transmit to you copy of a letter which has been received from the Postmaster-General respecting the inconvenience which has hitherto resulted from the operation of the rule under which the French portion of the postage, chargeable upon all letters forwarded via Marseilles to India, China, and Australia, is collected by the

quarter ounce scale, while the remainder of the postage is chargeable according to the scale applicable to British Inland Letters.

You will learn that in consequence of the representation which has been made to him on the subject, the Director-General of the French Post Office has consented to a modification of this provision, and that from the 1st of June next, the rate of postage will be altered in accordance with the charges exhibited in the Table enclosed in the copy of the letter which is annexed.

You will therefore take the necessary steps to bring the new scale of charges into operation as regards letters sent to the United Kingdom as soon as possible.

SIR,-I am directed by the Postmaster-General to acquaint you, for the information of the Duke of Newcastle, that much inconvenience has long been felt from the operation of the rule under which the French portion of the postage, chargeable upon all letters forwarded via Marseilles to India, China, Australia, &c., is collected by the quarter ounce scale, while the remainder of the postage is chargeable according to the scale applicable to British Inland Letters.

This rule has been rendered necessary by an article of the postal convention with France which provides that "the foreign rate to be levied on each letter, and for each quarter of an ounce, or fraction of a quarter of an ounce, that such letter may weigh in addition to the that such letter may weign in addition to the territorial rate referred to, shall not exceed the fourth part of the rate per ounce, or per 30 grammes which is fixed by the preceding Articles 19, 20, and 21."

With some difficulty the Postmaster-General has at length induced the Director-General of the French Post Office to consent to a modification of this provision, and this Department is no longer bound to adhere to the quarter ounce scale in collecting the French rate.

On the 1st June next, therefore, it is intended to collect the whole postage on letters forwarded from the United Kingdom to India, China, Australia, &c., through France, entirely by the scale in operation for letters forwarded via Southampton, and instead of three-pence per quarter ounce, to levy four-pence up to the weight of half an ounce, to cover the payment made to France.

#### Notice to Coroners and Justices of the Peace holding Inquests.

Registrar General's Office,

Auckland, 8th September, 1863.

THE attention of Coroners and Justices of the Peace is requested to the following racts from "The Registration Act, Extracts from 1858" :--

#### SECTION XIII.

"In case any new-born child or any dead body shall be found exposed, a Constable of the District shall forthwith inform the Registrar thereof, and of the place where such child or dead body was found; and where an inquest shall be held on any dead body, the Coroner or Justice of the Peace holding the same shall notify to the Registrar of the District the Verdict of the Jury, with all other particulars required to be registered concerning the Death, and such Registrar shall make the entry in his be signed by the Coroner or Justice of the Peace, by whom the information has been given." Register Book accordingly, and the same shall

#### SECTION XX.

Every Registrar, immediately upon regsitering any death, or as soon thereafter as he shall be required so to do, shall without fee or reward deliver to the person giving informa-tion, or to the undertaker or other person hav-ing charge of the funeral, a certificate under his hand according to the form in Schedule C, hereto annexed, that such death has been duly registered; and such Certificate shall be delivered by such undertaker or other person to the minister or officiating person who shall be required to bury or perform any funeral or religious service for the burial ; and if any dead body shall be buried, for which no certificate shall have been so delivered, the person who shall bury the same, or perform any funeral or religious service for the burial, or who shall in any other way dispose of the body, shall forthwith give notice of the facts to the Registrar : Provided always, that the Coroner or Justice of the Peace holding any inquest upon any dead body for which no Certificate shall have been delivered as aforesaid, may order the body to be buried, if he shall think fit, before registration ; and shall in such case give a certificate of his order in writing under his hand in the form in Schedule D, hereto annexed, to the undertaker or other person having charge of the funeral.

#### BLUFF HARBOUR AND INVERCAR-GILL RAILWAY AND EXTENSION.

**TOTICE IS HEREBY GIVEN** that application will be made at the ensuing session of the General Assembly of the Colony, for leave to bring in a bill to em-power the Superintendent of the Province of Southland to take and purchase compulsorily, for the purpose of the Bluff and Invercargill Railway, authorised to be constructed under and by virtue of the Bluff Harbour and Invercargill Railway Ordinance, 1863, of the Provincial Council of the said Province of Southland, certain lands lying and being within the line of the said railway, and the limits of deviation thereof; and also to authorise the said Superintendent to make and maintain extensions of the said railway as follows, that is to say

1. An extension, leaving the present line of railway at a distance of four chains northwest from its intersection with the eastern The following is the form of the Certificate boundary of Section 17, Block 7, Campbelltown District, and skirting the line of beach with a radius of forty chains, will be carried along it, parallel to and in close proximity with the line shown on the Campbelltown plan, as the exterior boundary of Nore-street, to a point opposite the north-west corner of Block No. 5, Campbelltown, from which point it will be continued with a radius of forty chains to a point opposite the northeast corner of Block No. 4, from which point it will be continued along the beach, parallel to and in close proximity with the line shown

as the exterior boundary of Gore-street to the termination of this extension at the line shown on the Campbelltown plan as Palmer's Boundary. On this extension there will be one gradient only, descending at an inclination not exceeding one vertical to 150 horizontal to the level of four feet above the level of high water spring tides.

2. An extension, leaving the present line of railway twenty chains south of the southern town belt, and entering Annan-street, by reverse curves of forty chains radius, will be continued down the centre of that street, and crossing Crinan, Ettrick, Tweed, and Findhorn Streets, on the level, will be continued in the reserve distinguished on the town plans as the Public Esplanade, to the site of the proposed Goods Station in that reserve, at the back of the Government buildings in Dee-street.

There will be no gradients in this extension.

And notice is hereby further given, that copies of the said bill will be deposited in

the Private Bill Office, in pursuance of the standing orders of the General Assembly of New Zealand relative to Private Bills, within fourteen days from the commencement of the said session.

And, further, that the plans, sections, and books of reference, relating to so much of the land proposed to be taken for the said undertaking as are Crown lands and tidal land, will be deposited before the commencement of the said session in the office of the Colonial Secretary of the Colony.

And that the plans, sections, and books o reference relating to other lands proposed to be taken for the said undertaking, will be deposited in the office of the Registrar of Deeds at Invercargill, in the said Province of Southland, within twenty days from this date.
