WHEREAS by an Act made and enacted in the Imperial Parliament, holden in the fifteenth and sixteenth years of the reign of Her Majesty Queen Victoria, intituled "An Act to grant a Representative Constitution to the Colony of New Zealand," it is amongst other things enacted that whenever any Bill shall have been assented to by the Superintendent as in the said Act provided, the Superintendent shall forthwith transmit to the Governor an authentic copy thereof, and it shall be lawful for the Governor at any time within three months after any such Bill shall have been received by him to declare by Proclamation his disallowance of such Bill, and that any such disallowance shall make void and annul the same from and after the day of such Proclamation or any subsequent day to be named therein;

And Whereas the Ordinances hereinafter specified have been enacted by the Superintendent of the Province of Canterbury, with the advice and consent of the Provincial Council thereof, and the said Ordinances were received by the Governor on the sixth day of November, One thousand eight hundred and sixty-three:

A PROCLAMATION,

For the Naturalization of certain Persons.

By His Excellency Sir GEORGE GREY, Knight, Commander of the most honorable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

WHEREAS by the "Naturalization Act, 1863," it is enacted that every person who shall be declared to come within the operation of that Act by any Proclamation

to be issued in that behalf by His Excellency the Governor shall, as from the time in such Proclamation specified, be deemed and taken, until the termination of the next session of the General Assembly, to be and to have been from such specified time a natural-born subject of Her Majesty within the Colony of New Zealand, as fully to all intents and purposes as if his name had been inserted in the Schedule to that Act annexed : Provided always that every such Proclamation shall contain the description, occupation or calling of every person therein named and his place of residence at the date of such Proclamation :

Now therefore I, Sir George Grey, the Governor of New Zealand, in pursuance of the power and authority in me vested by the said Act, do hereby proclaim and declare that the persons hereinafter mentioned shall come within the operation of the said Act from the dates hereinafter specified, viz.—

FRIEDERICH SCHMIDT.

From the twenty-fifth day of October, one thousand eight hundred and fifty-seven, native of Hanover, farmer ; residence Rangiora, in the Province of Canterbury.

CHARLES MORLAND.
