# A PROCLAMATION

Intimating Her Majesty's Assent to certain Bills passed by the General Assembly.

By His Excellency Sir George Grey, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colonies of New Zealand and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

WHEREAS by an Act passed in the Session of Parliament held in the fifteenth and sixteenth years of Her Majesty's reign, intituled "An Act to grant a Representative Constitution to the Colony of New Zealand," it is amongst other things enacted that no Bill which shall be reserved for the signification of Her Majesty's pleasure thereon shall have any force or authority within the Colony of New Zealand until the Governor of the said Colony shall signify by speech or message to the Legislative Council and House of Representatives of the said Colony, or by Proclamation, that such Bill has been laid before Her Majesty in Council, and that Her Majesty has been pleased to assent to the same:

And whereas a certain Bills passed by the Legislalative Council and House of Representatives of the said Colony, intituled—

"An Act to amend the Laws now in force for the Sale, Letting, Occupation, and Disposal of Waste Lands of the Crown within the Province of Otago,"

"An Act to impose a Tax upon all Rural Lands in the Province of Otago to be sold under the 'Otago Waste Lands Act, 1863,' and to make certain provisions respecting lands heretofore sold under conditions for the improvement thereof,"

were presented to the Governor of the said Colony for Her Majesty's assent, and the said Bills were reserved for the signification of Her Majesty's pleasure thereon: Now, therefore, I, the Governor of New Zealand, in pursuance of the provisions of the said in part recited Act, do, by this Proclamation, signify and proclaim to all whom it may concern, that the said Bills have been laid before Her Majesty in Council, and that Her Majesty has been pleased to assent to the same.

# A PROCLAMATION

Disallowing certain Ordinances passed by the Superintendent and Provincial Council of the Province of Otago.

> By His Excellency Sir George Grey, Knight Commander of the most Honorable Order of the Bath, Governor and Commanderin-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

WHEREAS by an Act made and enacted in the Imperial Parliament, holden in the fifteenth and sixteenth years of the reign of Her Majesty Queen Victoria, intituled "An Act to grant a Representative Constitution to the Colony of New Zealand," it is amongst other things enacted that whenever any Bill shall have been assented to by the Superintendent, as in the said Act provided, the Superintendent shall forthwith transmit to the Governor an authentic copy thereof, and it shall be lawful for the Governor, at any time within three months after any such Bill shall have been received

by him, to declare, by Proclamation, his disallowance of such Bill, and that any such disallowance shall make void and annul the same, from and after the day of the date of such Proclamation, or any subse-

quent day to be named therein:

And whereas the Ordinances hereinafter specified have been enacted by the Superintendent of the Province Otago, with the advice and consent of the Provincial Council thereof, and the said Ordinances were received by the Governor on the Fifteenth day of July, One Thousand Eight Hundred and Sixty

And whereas is is expedient that the said Ordi-

nances should be disallowed:

Now, therefore, I, the Governor of New Zealand, in pursuance of the authority vested in me in that behalf by the said recited Act of Parliament, do hereby proclaim and declare my disallowance of the following Ordinances passed by the Superintendent and Provincial Council of the Province of Otago,

"The Criminals Ordinance, 1864"

"The Licensed Hawkers' Ordinance, 1864"

"The Bush Fires Ordinance, 1864"
"The Medical Practitioners' Ordinance, 1864."

# ORDER IN COUNCIL,

Establishing Regulations for the granting of Gold Mining Leases in the Province of Otago.

G. GREY, Governor.

At the Government House, at Auckland, this fourteenth day of September, 1864.

Present:

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS it is provided by the "Gold Fields Act, 1862," that it shall be lawful for the Governor in Council from time to time to make such Regulations, not being contrary to the provisions of the said Act, as he shall think fit, for regulating the granting of Leases for mining purposes, and the terms and conditions on which such Leases shall be granted, and such Regulations from time to time to alter and abolish:

And whereas by an Order in Council made on the Fifteenth day of September, 1863, certain Regulations were made for Gold Mining within the Otago Gold Fields, and it was thereby provided that appli-cations might be made for Gold Mining Leases on the payment of a deposit of Twenty pounds (£20), and on the performance of certain things in the said Order set forth, such Leases might be granted as

therein mentioned:

And whereas much inconvenience has arisen in consequence of persons making applications for leases

and subsequently abandoning the same:

Now, therefore, His Excellency the Governor, in pursuance and exercise of the said recited power and authority, doth hereby, with the advice and consent of the Executive Council of the Colony of New Zealand, make the following additional Rule for the granting of Leases for Gold Mining within the District of the Otago Gold Fields:—

Out of the sum of Twenty Pounds (£20) deposited by any person making application for a Gold Mining Lease, shall be deducted the sum of Five Pounds (£5) in addition to the previously authorised costs and expenses, in case such person shall withdraw his application, or forfeit or abandon his claim, or not accept the lease, within one month after notice by the Warden.

And doth further declare that this Order shall

take effect from the day of date hereof.

#### ORDER IN COUNCIL.

Regulations respecting Delegation of powers to Superintendents under "Diseased Cattle

G. GREY, Governor.

At the Government House, at Auckland, the fourteenth day of September, 1864.

Present:

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

HEREAS by Warrants under the hand of His Excellency the Governor, bearing date this fourteenth day of September, One thousand eight hundred and sixty-four, the Governor has, with the advice and consent of the Executive Council of New Zealand, delegated to the Superintendents respectively of the Provinces of Auckland, Taranaki, Wellington, Hawke's Bay, Nelson, Marlborough, Canterbury, Otago and Southland, certain powers conferred on him by the "Diseased Cattle Act, 1861," subject to certain Regulations to be made by the Governor in Council under the said recited Act:

Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council of New Zealamd, by virtue of the authority given to him by the 14th Section of the above recited Act, doth hereby make and ordain the following Regulations.

1. The delegation of powers under the said warrants shall continue to be in force for the period of one year from this date, subject to be rescinded according to the provisions of the above recited Act.

2. Each Superintendent shall, immediately after exercising any of the delegated powers, notify the same to the Governor, and he shall transmit to the Governor particulars of all appointments and copies of all Regulations made by him.

He shall, so soon as conveniently can be, notify all Regulations made by him to the Colonial Secretary or Chief Secretary of each of the Australian

Colonies, and cause the same to be published in England in the "Times" Newspaper.

4. In the exercise of powers delegated under the 9th section of the said Act, the Superintendent of any Province, may, either in the first instance, or afterwards, from time to time, by Proclamation in the Government Gazette of the Province, except out of any district proclaimed as infected under the said Act, any Port or Place within the limits of such district, and every such excepted Port and Place shall be deemed not to be within the proclaimed district, and the Superintendent may also from time to time by Proclamation as aforesaid, rescind any Proclamation of an infected district, wholly or as to any part thereof, and also the Proclamation of any such exception as aforesaid.

5. In the exercise of powers delegated under the 10th section of the Act, the Superintendent of any Province may prohibit the importation, either by land or by sea, of cattle into such Province from any other Province, or any particular port or place in any

other Province, or across the borders of a Province

or any particular part thereof.

6. In all such last-mentioned cases such Superintendent shall cause notice as speedily as possible of such prohibition to be given to the Superintendent of the Province from which the importation shall be prohibited, and also to the Governor.

7. The Superintendent of any Province may in his discretion suspend or forbear to exercise all or any of the powers delegated to him under the said Act.

8. The Superintendent of each Province shall, as soon as can be after the commencement of each sitting of the Provincial Council of such Province, lay before such Council copies and particulars of all the Appointments, Regulations, Acts, and Proceedings whatever, issued, made, or done by him under the delegated powers of the said Act.

9. If the Provincial Council of any Province shall by resolution declare their dissent from all or any of such Appointments, Regulations, Acts and Proceedings, such Resolution shall be forthwith transmitted by the Speaker to the Governor for his consideration.

# Directions for entering Tauranga Harbor.

Large Vessels making Tauranga Harbor, would do well to keep to the Eastward of the course (S. by E.) as given in the New Zealand Pilot, making for the rocks off the North end of Mongonui Mount until within a quarter of a mile of them, and then skirting the Mount at a distance of a cable and a half; they would thereby carry deeper water over the bar, or shoal water at the entrance, where there is often considerable swell.

On nearing Stoney Point, a Red Buoy will be observed 1\frac{3}{4} cables West by N. \frac{1}{2} N. from the Iron Beacon on Stoney Point; this buoy is placed in 3 fathoms, off a shoal running out a cable's length from the Mount, having little more than 2 fathoms at low water, apparently rock, and with an ebb tide should be given a berth of at least a ship's length. When well past it, and not before, the Island of Motu Otau is seen over the sandy spit to the Southward of Monganui, and between it and the hill to the Eastward of the Mount, bearing N.E. by E.  $\frac{1}{2}$  E., the Eastward of the Mount, bearing hand sharp round for the beacon on Stoney Point; haul sharp round within a few fathoms. Three this may be passed within a few fathoms. Three wooden stakes, with iron beacons on top, will then be seen on the starboard hand, and may be passed in succession within half a cable's length, they being necessarily placed in 6 feet water within the edge of the bank, the deepest water being midway between necessarily placed in 6 feet water within the edge of the bank, the deepest water being midway between them and low water mark. Keep the same distance from the shore until abreast of Maketu Mound, and when the Red Buoy, which is placed in 3 fathoms at the necessarily placed in 6 feet water within the edge of the North boundary line of Wales & Co.'s claim, distant 139 links from the N.W. corner peg, thence by a line bearing N. 7° 21' E. a distance of 497 links, thence by a line bearing E. 11° 26' S. a distance of the junction of the channels leading to Otumoiti

and Te Papa is on with Mission Point, S.  $\frac{1}{2}$  W.; steer for the buoy on this bearing, anchoring between it and Maketu Mound.

Vessels drawing not more than 15 feet may proceed at high water up to Te Papa, by passing between the buoys which mark the channel close to the Eastern shore, leaving the black buoys on the starboard, and the white buoys on the port hand.

The tide at Stoney Point runs out for an hour after low water, and sets with considerable force towards the buoy, after which is the best time for entering the harbor.
