A PROCLAMATION

*Disallowing certain Otago Provincial Ordinances.*

By His Excellency Sir GEORGE GREY, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

**WHEREAS** by an Act made and enacted in the Imperial Parliament, holden in the fifteenth and sixteenth years of the reign of Her Majesty Queen Victoria, intituled "An Act to grant a Representative Constitution to the Colony of New Zealand," it is amongst other things enacted that whenever any Bill shall have been assented to by the Superintendent, as in the said Act provided, the Superintendent shall forthwith transmit to the Governor an authentic copy thereof, and it shall be lawful for the Governor, at any time within three months after any such Bill shall have been received by him, to declare, by Proclamation, his disallowance of such Bill, and that any such disallowance shall make void and annul the same, from and after the day of the date of such Proclamation, or any subsequent date to be named therein :

And whereas the Ordinances hereinafter specified have been enacted by the Superintendent of the Province of Otago, with the advice and consent of the Provincial Council thereof, and the said Ordinances were received by the Governor on the Fifth day of September, One Thousand Eight Hundred and Sixty-four :

And whereas it is expedient that the said Ordinances should be disallowed :

Now, therefore, I, Sir George Grey, the Governor of New Zealand, in pursuance of the authority vested in me in that behalf by the said recited Act of Parliament, do hereby proclaim and declare my disallowance of the following Ordinances passed by the Superintendent and Provincial Council of the Province of Otago, viz. :—

- "Education Reserves Ordinance, 1864,"
- "Hawksbury Roads Lands Ordinance, 1864,"
- "Southern Trunk Road Lands Ordinance, 1864,"
- "Kaikorai District Roads Lands Ordinance, 1864,"
- "Anderson's Bay District Roads Lands Ordinance, 1864,"
- "Tokomarairo District Roads Lands Ordinance, 1864,"
- "Taieri Districts Roads Lands Ordinance, 1864,"
- "Northern Trunk Road Lands Ordinance, 1864,"
- "Caversham and Green Island Districts Roads Lands Ordinance, 1864."

**WHEREAS** by the "Naturalization Act, 1863," it is enacted that every person who shall be declared to come within the operation of that Act by any Proclamation, to be issued in that behalf by His Excellency the Governor, shall, as from the time in such Proclamation specified, be deemed and taken, until the termination of the next Session of the General Assembly, to be, and to have been from such specified time, a natural-born subject of Her Majesty

within the Colony of New Zealand, as fully to all intents and purposes as if his name had been inserted in the Schedule to that Act annexed: Provided always that every such Proclamation shall contain the description, occupation, or calling of every person therein named and his place of residence at the date of such Proclamation:

Now therefore, I, the Governor of New Zealand, in pursuance of the power and authority in me

vested by the said Act, do hereby proclaim and declare that the persons hereinafter mentioned shall come within the operation of the said Act from the dates hereinafter specified, viz:—

HENRY KUSABS,

from the first day of January, one thousand eight hundred and sixty-three, native of Prussia, carpenter; residence, Auckland, in the Province of Auckland.

JEAN DESIRE FÉBAUD,

from the first day of January, one thousand eight hundred and sixty-four, native of Venice, in France, wine and spirit merchant; residence, Clyde, in the Province of Otago.

MAXIMILIAN ALEXANDER,

from the 1st day of January, one thousand eight hundred and sixty-four, native of Prussia, jeweller and watchmaker; residence, Blenheim, in the Province of Marlborough.

LUEIS BERLINER,

from the first day of September, one thousand eight hundred and sixty-four, native of Poland, draper; residence, Christchurch, in the Province of Canterbury.

ANDREW SANDER,

from the fifth day of September, one thousand eight hundred and sixty-four, native of Sweden, sailor; residence, Christchurch, in the Province of Canterbury.

EARNEST SYDLE,

from the sixth day of September, one thousand eight hundred and sixty-four, native of Germany, settler; residence, Onehunga, in the Province of Auckland.

proclaim and declare that the person hereinafter mentioned shall come within the operation of the said Act from the date hereinafter specified, viz:—

from the first day of January, one thousand eight hundred and sixty-three, native of Genoa, carpenter; residence, Blenheim, in the Province of Marlborough.

#### ORDER IN COUNCIL.

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by an Act of the General Assembly of New Zealand, intituled "The Native Districts Regulation Act, 1858," it is provided that it shall be lawful for the Governor in Council from time to time to appoint districts for the purposes of the said Act, being districts over which the Native Title shall not for the time being have been extinguished:

Now, therefore, His Excellency the Governor, by and with the advice and consent of his Executive Council, doth hereby order, appoint, and declare that the territory hereafter described shall be a district for the purposes of the said Act, that is to say: All territory lying within a boundary line commencing at Ngakuriawaare (to the north of Katikati), proceeding thence by a line running in a westerly direction to the summit of Te Aroha-auta; thence in a southerly direction along the Aroha ranges to Mangatawa; thence by a line to the summit of Otanewainuku, thence by a direct line to the mouth of the Wairakei stream on the sea coast; thence by the coast line (including the Island of Teehu) to the commencing point. And doth appoint and declare that the said district shall be called the Native District of Tauranga.

And doth declare that this Order shall take effect from and after the Twenty-ninth day of September, 1864.

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

**W**HEREAS by an Act of the General Assembly of New Zealand, intituled, "The New Zealand Native Reserves Act, 1856," certain powers therein specified are vested in the Commissioners under the said Act; and whereas, by another Act of the General Assembly of New Zealand, intituled "The Native Reserves Amendment Act, 1862," all the powers and authorities which by "The New Zealand Native Reserves Act, 1856," are given to or vested in, or which may be exercised by Commissioners appointed or to be appointed under that Act, shall vest in, and may be exercised by the Governor, and it is by the said Act further enacted, that the Governor may, by Order in Council, from time to time, delegate all or any of the powers competent to the Commissioners under the said Act unto any person or persons for any period, and subject to any regulations or stipulations as may be specified in such Order. Now, therefore, His Excellency Sir George Grey, in exercise of the power and authority so vested in him as Governor as aforesaid, doth by this Order in Council delegate, until this Order shall be revoked, to

ALEXANDER MACKAY, Esquire,  
Resident Magistrate, all the powers competent to Commissioners under the said first recited Act, without any restrictions or stipulations whatever.

*Costs of Management of the Marlborough Gold Fields,  
to be regulated by Acts of Provincial Council.*

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

**W**HEREAS by an Act of the General Assembly of New Zealand, intituled the "Gold Fields' Act, 1862," it is provided that it shall be lawful for the Governor in Council, under his hand and the Public Seal of the Colony, from time to time to delegate to the Superintendent of any Province, or to such person as the Governor may deem fit, all or any of the powers vested in the Governor, or the Governor in Council by the said Act, except the powers conferred by Sections Nineteen, Thirty-one, Thirty-two, Thirty-three, and Sixty-one thereof, subject or not to any limitations or restrictions as he may think fit, and in like manner to alter or revoke any such powers:

And whereas it is further provided that whenever the Governor shall have delegated to the Superintendent of any Province all or any of the aforesaid powers, it shall be lawful for the Governor, by Order in Council, to appoint and declare that all costs, charges, and expenses incident to the management and administration of the Gold Fields within such Province shall be regulated by Acts or Ordinances to be passed by the Superintendent and Provincial Council of such Province:

And whereas by an instrument in writing, of even date herewith, issued under the Seal of the Colony, the Governor, with the advice and consent of the Executive Council of the Colony, and in exercise of the before recited power, hath delegated to

ARTHUR PENROSE SEYMOUR, ESQUIRE,  
as Superintendent of the Province of Marlborough, in the said Colony, all the aforesaid powers, excepting those before recited to be excepted, to hold and exercise the said powers within the Province of Marlborough aforesaid:

Now, therefore, His Excellency the Governor, in pursuance and exercise of the power and authority for this purpose by the said Act conferred, doth hereby, with the advice and consent of the Executive Council of the Colony, appoint and declare that all the costs, charges, and expenses incident to the management and administration of the Gold Fields within the Province of Marlborough, shall be regulated by Acts to be passed by the Superintendent and Provincial Council of the said Province.

*Delegation of the Governor's Powers, under the "Gold Fields' Act, 1862," to the Superintendent of Marlborough.*

**W**HEREAS by an Act of the General Assembly of New Zealand, entitled "The Gold Fields' Act, 1862," it is provided that it shall be lawful for the Governor in Council, under his hand and the Public Seal of the Colony, from time to time to delegate to the Superintendent of any Province, or to such other person as the Governor may deem fit, all or any of the powers vested in the Governor or in the Governor in Council by the said Act, except the powers conferred by Sections Nineteen, Thirty-one, Thirty-two, Thirty-three, and Sixty-one thereof, subject or not to any limitations or restrictions as he may think fit, and in like manner to alter or revoke any such powers:

Now, therefore, I, Sir George Grey, the Governor as aforesaid of the said Colony, with the advice and consent of the Executive Council thereof, and in exercise of the power and authority for this purpose in me vested, do hereby delegate unto

ARTHUR PENROSE SEYMOUR, ESQUIRE,  
as Superintendent of the Province of Marlborough, all the powers vested in me under or by virtue of the "Gold Fields' Act, 1862," except the powers contained in Sections Nineteen, Thirty-one, Thirty-two, Thirty-three, and Sixty-one of the said Act, to have, hold, and exercise within the Province of Marlborough the said powers hereby given the said Arthur Penrose Seymour, so long as he shall continue and remain Superintendent of the said Province, and no longer:

Provided always that copies of all Rules and Regulations made under the Delegation aforesaid, shall be forthwith transmitted to the Colonial Secretary, in order that the same may be laid before the General Assembly, in accordance with the provisions of the Sixty-third Clause of the "Gold Fields' Act, 1862."

*Delegation of the Governor's powers under the "Gold Fields Act, 1862," to the Superintendent of Marlborough.*

By His Excellency Sir GEORGE GREY, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

WHEREAS, by section 19 of an Act of the General Assembly of New Zealand, intituled "The Gold Fields' Act, 1862," it is enacted that it shall be lawful for the Governor, by order in Council, from time to time to constitute for any Gold Field, or for any part thereof, Wardens' Courts for the administration of justice therein, and to appoint Wardens as Judges of such Courts, with power to act alone, or with Assessors or Juries, and in such manner and to exercise all or any of the powers thereinafter mentioned as the Governor shall think fit to direct:

And whereas, by the 5th section of an Act of the General Assembly intituled "The Gold Fields' Act Amendment Act, 1863," it is enacted that it shall be lawful for the Governor in Council, under his hand and the Public Seal of the Colony, from time to time to delegate to the Superintendent of any Province or to such other person as the Governor may deem fit, and under such restrictions as he shall think fit, all or any of the powers vested in the Governor, or the Governor in Council, by section 19 of the said Act, and to alter or revoke by said delegation.

Now, therefore, I, Sir George Grey, the Governor as aforesaid of the said Colony, with the advice and consent of the Executive Council thereof, and in pursuance of the power and authority for this purpose in me vested, do hereby delegate unto

ARTHUR PENROSE SEYMOUR, Esquire,

as Superintendent of the Province of Marlborough, all the powers vested in me by the 19th section of the "Gold Fields' Act, 1862," to have, hold, and exercise within the Province of Marlborough the said powers hereby given the said Arthur Penrose Seymour so long as he shall continue and remain Superintendent of the said Province, and no longer, and to have, hold, and exercise such powers subject to the Regulations hereunder written namely:—

REGULATIONS.

All acts and appointments done and made by the said Superintendent under the foregoing Delegation shall be provisional until the same shall have been confirmed and allowed by the Governor; and the Governor shall have power to disallow the same.

The Superintendent shall report without delay to the Governor all such acts and appointments.

The Superintendent shall lay before the Provincial Council of the said Province every such act and appointment at the Session of the said Council next following.

The Provincial Council of the said Province may, through their Speaker, transmit to the Governor any resolutions respecting any such act or appointment.

Now, therefore, in exercise of the powers in me vested by the said recited Act, I, Sir George Grey, the Governor of the Colony of New Zealand, do hereby remove from the office of Trustee of the Savings' Bank established at New Plymouth, every person who has been appointed Trustee, and who now holds the said office. And I do hereby nominate and re-appoint each of the persons hereinafter named, to be a Trustee of the said Bank, namely:—

*Colonial Defence Force Regulations.*

The pay of the Force will be as follows :—

The men will be expected to bear the whole expense of subsistence for themselves and their horses, of providing and maintaining their uniform, equipments (except arms and ammunition), and horses; and will be liable to the Mutiny Act and Articles of War, and such regulations as may from time to time be authorised by the Government.

When forage and provisions cannot be otherwise obtained, the Government will supply the regulated Military ration of each, and the men will be placed under a stoppage, to be fixed from time to time by a Board of Officers appointed by the Government for that purpose, but until the 1st January next to be Three Shillings per diem.

Should the men desire to purchase their horses from the Government, or to obtain advances for the purchase of horses, or saddlery, uniform, &c., they will be permitted to do so, refunding the amount by monthly instalments—which may vary at their own option, from £2 10s. to £5 per month.

When convenient, working passes, and furloughs, will be granted to men of good character, on their private affairs. While so absent, if for more than three days in any one month, they will receive half-pay only.

Men will not be discharged with less than three months' notice, except as an indulgence at their own request, or unless physically unfit for service or of a bad character. They will be enlisted for any period for which they may be required, not exceeding three years, and will be liable to serve, if required, in any part of New Zealand.

On being attested for the force, the men will sign the engagement attached hereto.

*Declaration.*

**I**, hereby engage to serve in the Colonial Defence Force, for the daily pay of Seven Shillings and Sixpence, in any part of New Zealand, and for such period as the Government may require my services, not exceeding three years; to bear the whole expense of providing my uniform, saddlery, equipment, and maintaining them in a state of efficiency;

of providing my own provisions; of providing, feeding, and maintaining a horse, subject to the approval of my Commanding Officer; and, should my horse become non-effective, I engage to replace it at my own cost, unless captured, injured, or killed by the enemy, in which case Government will bear the cost of replacing the animal.

I fully understand that, while serving in the above Force, I render myself liable to the Mutiny Act and Rules and Articles of War, for the time being in force in this Colony, and to such Laws, Rules, and Regulations as may be authorized for the better government of the Force.

Furthermore, I understand that, if under exceptional circumstances, or in the field, I am unable to obtain supplies of provisions and forage, the Govern-

ment will supply these requisites at a price to be fixed, from time to time, by a Board of Officers appointed by the Governor for that purpose; that if I absent myself without permission, or am sentenced to imprisonment by Court Martial, my pay will cease during such period of absence or confinement; that I shall be entitled to half pay only when absent on leave or furlough, while undergoing minor punishment by order of my Commanding Officer, or, if my horse becomes non-effective, until it is recovered or replaced.

SIR,—In a letter dated the 18th ultimo, I informed you, with reference to a previous communication to

the Government of New Zealand, that, on the 1st instant, the postage of letters sent by packet from the United Kingdom to the Australian Colonies and New Zealand, *vid* Southampton, would be raised from sixpence to one shilling—a corresponding increase of charge being made on letters sent *vid* Marseilles.

Simultaneously it was intended to reduce, from sixpence to fourpence, the postage of letters forwarded to those Colonies by private ship.

I am now directed by the Postmaster-General to acquaint you that, in consequence of the objections which have been strongly urged by the Colonies, to the proposed augmentation of the postage, it has been determined, until there has been time for further communication on the subject with the Australian Colonial Government, to suspend the measure.

The old rates of postage will, therefore, continue for the present to be collected in this country.
