ORDER IN COUNCIL,

Proclaiming certain Lands under "New Zealand Settlements Act, 1863."

G. GREY, Governor.

At the Government House, at Auckland, the thirtieth day of January, 1865.

Present:-

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by the "New Zealand Settlements Act, 1863," it was enacted amongst other things that whenever the Governor in Council should be satisfied that any Native tribe or section of a tribe or any considerable number thereof have, since the first day of January, 1863, been engaged in rebellion against Her Majesty's authority, it should be lawful for the Governor in Council to declare that the districts within which any land, being the property or in the possession of such tribe or section or considerable number thereof should be situate, should be a district within the provisions of the said Act, and the boundaries of such district in like manner to define and vary as he should think fit.

And whereas the Governor in Council is satisfied that certain Native tribes or sections of tribes, having respectively as their property or in their possession the lands in the district hereunder described, have been engaged in rebellion against Her

Majesty's authority.

Now, therefore, His Excellency the Governor, in exercise of the power vested in him by the said recited Act, doth hereby, with the advice and consent of the Executive Council of the Colony, declare that from the date hereof the land described in each of the two schedules to this Order shall be a district within the provisions of the "New Zealand Settlements Act, 1863," and shall be designated by the name mentioned in such schedule, and doth declare that the said lands are required for the purposes of the said Act, and are subject to the provisions thereof, and doth order that the said lands shall be and the same are hereby set apart and reserved as sites for settlement and colonization, agreeably to the provisions of the said Act.

SCHEDULE.

EAST WAIROA BLOCK.

All that Land known as East Wairoa Block: Bounded on the North by the Wairoa River and the Northern boundary of the lands intended to be confiscated, as set forth in the Proclamation of 17th December, 1864; on the East by the Eastern boundary of such confiscated lands; on the South by the Maungatawhiri River, from the Surrey Redoubt to the Eastern boundary of the Pokeno Block, as described in Proclamation of 29th December, 1864; and on the West, by the said Pokeno Block.

SCHEDULE.

WEST PUKEKOHE BLOCK.

All that Land known as the West Pukekohe Block, supposed to contain 1133 acres: Bounded on the North by Lot No. 38, Parish of Pukekohe, 7,100 links; on the East, by the Pukekohe Native Reserve, 30,084 links; on the South by Lot 44, Parish of Pukekohe, 2,160 links; and on the West by Lot No. 78, Parish of Pune, 2,640 links, and 4,660 links, and by a Road 28,030 links to commencing point.

And whereas the Governor in Council is satisfied that certain Native Tribes, or sections of Tribes, having landed properties and possessions in the lands described in the Schedule hereunder written, have been engaged in rebellion against Her Majesty's

authority:

Now therefore I, Sir George Grey, the Governor as aforesaid, in excercise of the power vested in me by the said recited Act, do hereby, with the advice and consent of the Executive Council of the Colony, declare that from the date hereof, the lands described in the Schedule to this Proclamation, being a district within which there are situate lands the property or in the possession of such Tribes, or sections of Tribes, as expressed, shall be a district within the provisions of the said New Zealand Settlements Act, 1863, and shall be designated by the name of Middle Taranaki.

SCHEDULE.

Middle Taranaki.

All that Block of Land at Taranaki, bounded on the North and West by the sea, on the East by th^t Waitara river from its mouth, to the junction of the Manganui river, and by the Manganui from the Waitara to the crossing place of the Kairoa and Waimate road, thence on the South by the said road to its junction with the Wanganui and Taranaki coast road, and thence by a straight line from the said junction of roads to the sea at its nearest point. Excepting all lands within the said boundaries held under Grant from the Crown.

And it is further enacted that it shall be lawful forthe Governor in Council, from time to time, to set apart within any such District eligible sites for settlement for colonization, and the boundaries of such settlements to define and vary; and it is further enacted that for the purpose of such settlements the Governor in Council may from time to time reserveor take any land within such District, and that such land shall be deemed to be Crown Land freed and discharged from all title, interest, or claim of any person whomsoever as soon as the Governor in Council shall have declared that such land is required for the purposes of the said Act, and is subject tothe provisions thereof:

And whereas by a Proclamation of even date herewith, in exercise of the powers vested in the Governor by the said Act, the Governor hath declared that certain Lands, within which the lands hereinafter described are situate, shall be a District within the provisions of the said "New Zealand Settlements Act, 1863," and shall be designated by the name of Middle Taranaki:

Now, therefore, I, Sir George Grey, the Governor as aforesaid, in further exercise of the power vested in me by the said recited Act, do hereby, with the advice and consent of the Executive Council of the Colony, set apart, as an eligible site for settlement for colonisation, the Land described in the Schedule to this Proclamation, being Land within the said Proclaimed District of Middle Taranaki; and the Governor doth declare, that the Lands described in the said Schedule are required for the purposes of the said Act, and are subject to the provisions thereof, and doth reserve and take such Lands for such purposes as aforesaid.

SCHEDULE.

Waitara South.

All that block of land at Taranaki, bounded on the North by the sea; on the East by the Waitara River, from its mouth to the junction of the Manganui River; on the South by a straight line from the junction of the Manganui and Waitara Rivers to Tururutongi, on the Waiongona River; and on the

West by a straight line to the sea at Waitaha.

Excepting lands within the above described boundaries held under Grants from the Crown.

WHEREAS by the "New Zealand Settlements Act, 1863," it was enacted amongst other things, that whenever the Governor in Council shall be esatisfied that any native tribe or section of a tribe, or any considerable number thereof have since the first day of January, 1863, been engaged in rebellion against Her Majesty's authority, it shall be lawful for the Governor in Council to declare that the District within which any land being the property or in the possession of such tribe or section or considerable number thereof shall be situate, shall be a District within the provisions of the said Act, and the boundaries of such District in like manner to define and vary as he shall think fit.

And it is further enacted that it shall be lawful for the Governor in Council from time to time to set apart within any such District eligible sites for settlements for colonization, and the boundaries of such settlements to define and vary; and it is further enacted that for the purpose of such settlements the Governor in Council may from time to time reserve or take any land within such District, and that such land shall be deemed to be Crown Land, freed and discharged from all title interest or claim of any person whomsoever, as soon as the Governor in Council shall have declared that such land is required for the purposes of the said Act and is subject to the provisions thereof:

And whereas, by a Proclamation of even date herewith, in exercise of the powers vested in the Governor by the said Act, the Governor hath declared that certain lands within which the lands hereinafter described are situate shall be a District within the provisions of the said "New Zealand Settlements Act, 1863," and shall be designated by the name of Middle Taranaki.

Now therefore, I, Sir George Grey, the Governor as aforesaid, in further exercise of the power vested in me by the said recited Act, do hereby, with the advice and consent of the Executive Council of the Colony, set apart as an eligible site for settlement for colonization, the land described in the Schedule to this Proclamation, being land within the said proclaimed District of Middle Taranaki, and the Governor doth declare that the lands described in the said Schedule are required for the purposes of the said Act, and are subject to the provisions thereof, and doth reserve and take such lands for such purposes as aforesaid.

SCHEDULE.

Oakura.

Bounded on the North by the sea, on the East by the Omata block, from the sea to where the boundary of the Omata block is cut by the Native path running between the Patua and Pouakai Ranges, thence by a straight line running between the two above mentioned Ranges till it cuts the Hangatahua River, thence by the Hangatahua to the sea, except the Block of land known by the name of the Tataraimaka Block.

PROCLAMATION.

Proclaiming that a certain Block of Land be withdrawn from the Gold Field, Coromandel, to be reserved for sale under the Waste Land Regulations.

> By His Excellency Sir George Grey, Knight Commander of the most Honorable Order of the Bath, Governor and Commanderin-Chief in and over Her Majesty's Colony of New Zealand, and its dependencies, and Vice-Admiral of the same, &c., &c., &c.

WHEREAS by an Act of the General Assembly of New Zealand, intituled the "Gold Fields Act, 1862," it is enacted that it shall be lawful for the Governor at any time subsequent to the Proclamation of a Gold Field to reserve or withdraw for purposes of sale any Waste Land or Lands within any portion of a Gold Field over which a Pastoral License does not exist, or has been cancelled or suspended, and which he may deem necessary for settlement, public purposes, or roads, which Land shall then be dealt with under the Waste Land Regulations of the Province in which such Gold Field shall be declared:

And whereas by Proclamation, dated 15th day of September, 1863, the District of Coromandel, in the Province of Auckland, was constituted a Gold Field under the aforesaid Act, and it is expedient that the portion of the same hereinafter described be withdrawn for purposes of sale in manner aforesaid:

And whereas the Governor in Council did duly delegate to the Superintendent of the Province of Auckland the aforesaid power of reservation and withdrawal, but subject to the Governor's power to revoke such delegation:

Now therefore I, Sir George Grey, the Governor in Council as aforesaid, do revoke the said delegation only so far and to such extent as may be inconsistent with the present Proclamation.

And I do further, in pursuance of the said power and authority, hereby proclaim and declare all that Block hereinafter described to be withdrawn from the Gold Field of Coromandel, and reserved for purposes of sale under the Waste Land Regulations of the Province of Auckland, that is to say:—

of the Province of Auckland, that is to say:—
All that Block of Land situated at Coromandel, and named Whakanekeneke, the boundaries whereof are as follows—commencing at Te Awa Peka in the Whangarahi Creek; thence by a right line bearing 80°, one thousand one hundred and seventy-nine (1,179) links; thence by a right line bearing 160° 30′, three thousand three hundred (3,300) links; thence by a right line bearing 250° 30′, one thousand and twenty (1,020) links; thence by a small stream to the Whangarahi Creek; thence following the Whangarahi Creek to the commencing point.

And I declare that this Proclamation shall come into operation and take effect on and from the day of the date hereof.

Proclamation declaring Districts under "Registration Act, 1858."

A PROCLAMATION

By His Excellency Sir George Grey, Knight Commander of the Most Honorable Order of the Bath, Governor and Commanderin-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same, &c., &c., &c.

WHEREAS by the "Registration Act, 1858," it is enacted that it shall be lawful for the Governor at any time, by Proclamation in the New Zealand Gazette, to divide the Colony of New Zealand for the purposes of the said Act into such and so many Districts as he may think fit, and that every such District shall be called by a distinct name and shall be a Registrar's District; and it is provided that the Governor may at any time revoke the whole or any part of such Proclamation and issue a new Proclamation, dividing the Colony or any part of it anew into Districts, or increasing the number or altering the boundaries of Districts as from time to time he may think requisite:

And whereas by two Proclamations duly made and issued, bearing date respectively the Sixth day of July, 1859, and the Ninth day of August, 1860, the Governor, in pursuance of the said recited power and authority, did create certain Districts:

And whereas it is expedient to alter the boundaries of some of those Districts and to increase the number thereof:

Now, therefore, I, Sir George Grey, the Governor of the said Colony, do hereby, in pursuance and further exercise of the power and authority vested in me by the said recited Act, revoke the said two Proclamations so far as they relate to the territory comprised in the Districts of Auckland, Drury, Raglan, Thames, Tauranga, Turanga and Rangiaowhia, and do proclaim and declare that such territory shall be divided for the purposes of the said Act into Eight Districts, the names and boundaries whereof shall be as follows:—

AUCKLAND DISTRICT.

Bounded on the North by the mid-channel of the Kaipara Harbour by the Tapora mid-channel to the Hoteo River, and by the Hoteo River to its junction with the Kaitote River, by a line thence southward to the South-west corner of the Ahuroa Block, thence by a line to the source of the Pukapuka Creek, thence by the centre of that Creek to Mahurangi Harbour, North Head; on the East by the sea from Mahurangi North Head to the Wairoa River; on the South by the Wairoa River, by Hewling's line, by the eastern and northern boundaries of the village of Papakura, by the centre of the Papakura Creek, and by the North shore of Manukau Harbour from Papakura Creek to the Heads; and on the West by the sea from Manukau to Kaipara Heads, the point of commencement, including the islands of Rangitoto, Motutapu, Waiheke, Ponui, Pakihi, Brown's Island, Motuihi (or Taylor's Island), Tiritirimatangi, Motuwhora, Motuketa, Motuaireka, Te Kawau, the Great and Little Barriers, Weeks' Island, and all islands lying on the West side of the Frith of the Thames; with the Fanal Islands and Saddle Islands.

DRURY DISTRICT.

Bounded on the North by the waters of the Manukau Harbour, and by the centre of the Papakura Creek, by the northern and eastern boundaries of the village of Papakura, by Hewling's line to the Wairoa River, crossing the Wairoa River it follows that river down to the sea; on the East by the Gulf of the Thames by the Piako River to the junction of the Tahunatapu Creek; on the South by a straight line from the mouth of the Tahunatapu Creek to Puketakauri on the Waikato River, thence across that river in a straight line to the South shore of the Wangape Lake, and thence in a straight line running Westsouth-west to the West Coast; on the West by the sea from the last mentioned point to Manukau Heads the point of commencement.

RAGLAN DISTRICT.

Bounded on the North by the southern shore of the Wangape Lake and by a straight line running West-south-west from the western angle of the Wangape Lake to the West Coast; on the West by the sea southward to the Mokau River; on the South by the Mokau River, from the mouth to the source; and on the East by a straight line from the source of the Mokou River to the summit of Pirongia, and by a straight line from the summit of Pirongia to the Wangape Lake at the point of commencement.

THAMES DISTRICT.

Bounded on the North by the sea from the mouth of the Piako River to the mouth of the Wangamata Harbour; on the East by a straight line from the mouth of the Wangamata Harbour to the summit of Te Aroha, thence by a straight line to Mata Mata; on the South by a straight line from Mata Mata to the junction of the Waitakururu Creek with the Piako River; on the West by the Piako River to the sea at the point of commencement, including Whanga nui, Waimate, Motutaupiri, and Rangipuke Islands.

TAURANGA DISTRICT.

Bounded on the North by the sea; on the East by the Wakatane River to its source and thence in a straight line running South to the southern boundary of the Province; on the South by the boundary of the Province to the Upper Waikato River; and on the West by the Upper Waikato River and eastern shore of Taupo Lake and by the Waikato River northward to the junction of the Orakeikorako stream, then by a straight line to Mata Mata, thence by a straight line to the summit of Te Aroha, and thence by a straight line to the mouth of the Wangamata Harbour, including all the islands in the Bay of Plenty, East of Tuhua, and Motu Taiko in Taupo Lake.

TURANGA DISTRICT.

Bounded on the North by the sea; on the West by the Wakatane River and by a straight line running South from the source of Wakatane River to the southern boundary of the Province of Auckland; on the South by the Southern boundary of the Province of Auckland; and on the East by the sea, including East Island.

ALEXANDRA DISTRICT.

Bounded on the North by a line from the southern shore of the Wangape Lake to the Waikato River at Puketakauri, by the Waikato River to Puketa; on the East by a line from Puketa to Kihikihi and a line from Kihikihi to the most western point of the shore of Taupo Lake, thence by the western shore of Taupo Lake and Upper Waikato River to the southern boundary of the Province; on the South by the boundary of the Province; on the West by the western boundary of the Province from the

Wanganui River to the source of the Mokau River thence by a straight line to the summit of Pirongia, and thence by a straight line to the Wangape Lake at the point of commencement.

CAMBRIDGE DISTRICT.

Bounded on the North by a straight line from Puketakauri on the Waikato River to the junction of the Tahunatapu Creek with the Piako River; on the East by the Piako River southward to the Waitakururu Creek, thence by a straight line to the junction of the Orakeikorako stream with the Waikato River, and by the Waikato southward to Taupo Lake; on the South by the northern shore of Taupo Lake; and on the West by a straight line from the most westerly point of the Taupo Lake to Kihikihi, and thence by a straight line to Puketa on the Waikato River, and thence by the Waikato River to Puketa Kauri the point of commencement.

And I do declare that this Proclamation shall come into operation and take effect on the 15th day of February, 1865.

Proclamation declaring Districts under Marriage Act.

By His Excellency Sir George Grey, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over Majesty's Colony of New Zealand and its Dependencies and Vice Admiral of the same, &c., &c., &c.

WHEREAS by the "Marriage Act Amendment Act, 1858," it is enacted that it shall be lawful for the Governor at any time, by Proclamation in the New Zealand Gazette, to divide the Colony of New Zealand, for the purposes of the said Act, into such and so many Districts as he may think fit, and that every such District shall be called by a distinct name, and shall be a Registrar's District; and it is provided that the Governor may at any time revoke the whole or any part of such Proclamation, and issue a new Proclamation, dividing the Colony, or any part of it, anew into Districts, or increasing the number or altering the boundaries of Districts, as from time to time he may think requisite:

And whereas by two Proclamations, duly made and issued, bearing date respectively, the sixth day of July, 1859, and the ninth day of August, 1860, the Governor, in pursuance of the said recited power and authority, did create certain Districts:

And whereas it is expedient to alter the boundaries of some of those Districts, and to increase the number thereof:

Now, therefore, I, Sir George Grey, the Governor of the said Colony, do hereby, in pursuance and further exercise of the power and authority vested in me by the said recited Act, revoke the said two Proclamations, so far as they relate to the territory comprised in the Districts of Auckland, Drury, Ragian, Thames, Tauranga, Turanga, and Rangiaowhia, and do proclaim and declare that such territory shall be divided, for the purposes of the said Act, into Eight Districts; the names and boundaries whereof shall be as follows:—

AUCKLAND DISTRICT.

Bounded on the North by the mid-channel of the Kaipara Harbour, by the Tapora mid-channel to the Hoteo River, and by the Hoteo River to its junction with the Kaitoto River, by a line thence southward to the south-west corner of the Ahuroa Block, thence by a line to the source of the Pukapuka Creek, thence by the centre of that Creek to Mahurangi Harbour, North Head; on the East, by the sea from Mahurangi North Head to, the Wairoa River; on the South, by the Wairoa River, by Hewling's line, by the Eastern and Northern boundaries of the Village of Papakura, by the centre of the Papakura Creek, and by the North shore of Manukau Harbour, from Papakura Creek to the Heads; and on the West by the sea from Manukau to Kaipara Heads, the point of commencement, including the Islands of Rangitoto, Motutapu, Waiheke, Ponui, Pakihi, Brown's Island, Motuihi (or Taylor's Island), Tiritirimatangi, Motuwhora, Motuketa, Motuaireka, Te Kawau, the Great and Little Barriers, Weeks' Island, and all Islands lying on the West side of the Frith of the Thames, with the Fanal Islands and the Saddle

DRURY DISTRICT.

Bounded on the North by the waters of the Manukau Harbour, and by the centre of the Papakura Creek, by the Northern and Eastern boundaries of the Village of Papakura, by Hewling's line to the Wairoa River, crossing the Wairoa River, it follows that river down to the sea; on the East, by the Gulf of the Thames, by the Piako River to the junction of the Tahunatapu Creek; on the South, by a straight line from the mouth of the Tahunatapu Creek to Puketakauri, on the Waikato River, thence across that river in a straight line to the South shore of the Wangape Lake, and thence in a straight line running west-south-west to the West Coast; on the West by the sea from the last mentioned point, to Manukau Heads, the point of commencement.

RAGLAN DISTRICT.

Bounded on the North by the southern shore of the Wangape Lake, and by a straight line running west south-west from the western angle of the Wangape Lake to the West Coast; on the West by the sea, southward to the Mokau River; on the South by the Mokau River, from the mouth to the source; and on the East by a straight line, from the source of the Mokau River to the summit of Pirongia, and by a straight line from the summit of Pirongia, to the Wangape Lake, at the point of commencement.

THAMES DISTRICT.

Bounded on the North by the sea, from the mouth of the Piako River, to the mouth of the Wangamata Harbour; on the East by a straight line, from the mouth of the Wangamata Harbour, to the summit of Te Aroha, thence by a straight line to Mata Mata; on the South by a straight line from Mata Mata, to the junction of the Waitakururu Creek with the Piako River; on the West by the Piako River to the sea, at the point of commencement, including Whanganui, Waimate, Motutaupiri, and Rangipuke Islands.

TAURANGA DISTRICT.

Bounded on the North by the sea; on the East by the Wakatane River to its source, and thence in a straight line running South, to the southern boundary of the Province; on the South by the boundary of the Province, to the Upper Waikato River; and on the West by the Upper Waikato River and Eastern shore of Taupo Lake, and by the Waikato River northward, to the junction of the Orakeikorako

Stream, then by a straight line to Mata Mata, thence by a straight line to the summit of Te Aroha, and thence by a straight line to the mouth of Wanga-mata Harbour; including all the Islands in the Bay of Plenty, East of Tuhua, and Motu Taiko, in Taupo

TURANGA DISTRICT.

Present :-HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by the "Appropriation Act, 1863" it is enacted that in order to provide means in advance of the receipt of the Ordinary Revenue for defraying any expenditure which may be necessary for carrying out a Resolution of the House of Secretary by the Claimant, if residing in the Colony,

Representatives passed on the 26th day of November 1863, it shall be lawful for the Colonial Treasurer if thereunto authorised by an Order of the Governor in Council from time to time to berrow and take up money on the security of Treasury Bills carrying interest at a rate not exceeding six per centum per annum, and payable out of the Ordinary Revenue, at the expiration of a term not exceeding two years from the date thereof. Provided that the total amount of Principal money owing on the security of such Treasury Bills, for the time being in circulation shall not at any time exceed Fifty thousand pounds (£50,000.)

Now therefore, His Excellency the Governor of the Colony of New Zealand, by and with the advice and consent of the Executive Council of the said Colony, doth hereby authorise the Honorable William Fitzherbert, Colonial Treasurer of New Zealand, to borrow and take up a sum or sums not exceeding in the whole the sum of Fifty Thousand pounds (£50,000) sterling, and to issue Treasury Bills therefor on the terms for the purpose, and subject to the conditions hereinbefore recited.

Notification to Claimants for Compensation under authority of "The New Zealand Settlements Act, 1863."

WHEREAS, by an Order in Council made on the 29th day of December, 1864, under the authority of Sections 3 and 4 of "The New Zealand Settlements Act, 1863," His Excellency the Governor did declare that certain lands thereunder described, or referred to, in the District of Waikato, belonging to the Waikato and other Rebellious Tribes, were required for the purposes of the said Act, and were subject to the provisions thereof: And whereas it is provided by the said Act that compensation shall be granted to all persons who shall have any title, interest, or claim to any Land taken under the said Act, provided always that no compensation shall be granted to any of the persons following that is to say, to any person,

(1) Who shall, since the 1st of January, 1863, have been engaged in levying or making war, or carrying arms against Her Majesty the Queen, or

Her Majesty's Forces in New Zealand; or
(2) Who shall have adhered to, or aided, assisted,

or comforted, any such persons as aforesaid; or
(3) Who shall have counselled, advised, induced, enticed, persuaded, or conspired with any other person to make or levy war against Her Majesty, or to carry arms against Her Majesty's Forces in New Zealand, or to join with or assist any such persons as are before mentioned in sub-sections (1) and (2); or.

(4) Who, in furtherance or in execution of the designs of any such persons as aforesaid, shall have been, either as principal or accessory, concerned in

any outrage against person or property; or,
(5) Who, on being required by the Governor, by
Proclamation to that effect in the Government Gazette, to deliver up the arms in their possession, shall refuse or neglect to comply with such demand after a certain day to be specified in such Proclamation.

And it is further provided that compensation shall be granted according to the nature of the title, interest, or claim of the person requiring compensation, and according to the value thereof: Provided always

within six months, and if not residing within the Colony then within eighteen months, after the Land in respect of which the claim is made has been proclaimed under Section 4 as required for the purposes of this Act.

Now, therefore, it is hereby notified, that such claims for compensation arising prior to the taking of any of the Lands comprised within the limits referred to in the said Order in Council, and hereunder described or referred to, shall be sent in to the Colonial Secretary, addressed to him at Wellington, within the periods respectively prescribed, as before mentioned.
