ORDER IN COUNCIL.

G. GREY, Governor.

Approved in Council this twenty-third day of March, one thousand eight hundred and sixty-six. Present:

THE PRESIDENT AND OTHER MEMBERS OF THE EXECUTIVE COUNCIL.

WHEREAS by "The Diseased Cattle Act Amendment Act, 1865," it is provided that the Governor may, by Order in Council, from time to time, annul, make void, or alter or vary and make anew any Orders in Council, Regulations, Appointments, or prohibitory or other Declarations, made and published by the Governor under the authority of "The Diseased Cattle Act, 1861," or this Act, or by the Superintendent of any Province under or in pursuance of any power delegated to him under any of the powers of delegation contained in the said "Diseased Cattle Act, 1861," or this Act, and that either with reference to the whole or any part of any proclaimed district:

Now therefore His Excellency the Governor, in exercise of the power for this purpose so vested in him as aforesaid, doth hereby, with the advice and consent of the Executive Council of the Colony, vary the prohibitory declarations contained in the Proclamations issued by the Superintendent of Canterbury on the twelfth day of March one thousand eight hundred and sixty-six, and published in the Provincial Gazette of the said Province on the thirteenth day of the said month of March, by striking out the words "Colony of New Zealand" wherever they occur in the Regulations contained in the said Proclamations, and by substituting in lieu thereof the words "Province of Canterbury;" and doth hereby so far, and so far only, revoke the delegation of the powers which, by the fourth section of the said Amendment Act, the Governor in Council is authorized to delegate, and which were, by Order in Council referred to in the New Zealand Gazette, of the twenty-fifth of November, one thousand eight hundred and sixty-five, delegated to the said Superintendent, and doth declare that this Order in Council shall take effect from and after the second day of May, one thousand eight hundred and sixty-six.
