G. GREY, Governor. A PROCLAMATION.

WHEREAS by an Act of the General Assembly of New Zealand intituled "The New Zealand Post Office Act, 1858," it is enacted that it shall be lawful for the Governor in Council, from time to time, by Proclamation to be published in the New Zealand Gazette, to fix, alter, and abolish the rates of Postage at any time payable within the Colony for the transmission of letters and newspapers by post, either between places within New Zealand, or to or from places beyond seas, and at what time the same shall be paid, and that the postage so made payable shall be charged and paid accordingly; and whereas by a Proclamation duly made and issued, bearing date the twenty-ninth day of December, one thousand eight hundred and sixty, the Governor in Council did, in pursuance of the said recited power and authority, fix certain rates of postage, and the times at which the same respectively should be paid; and whereas by a Proclamation duly made and issued, bearing date the twenty-third day of May, one thousand eight hundred and sixty-six, the Governor in Council did, in further exercise of the said recited power and authority, alter the rates of postage for the transmission of all letters, newspapers, and packets by post via Panama to or from the countries mentioned in the Schedule to such Proclamation, and fix such rates of postage according to the rates mentioned in such

Schedule; and whereas it is expedient to alter the rates so fixed, and to substitute other rates in lieu thereof:

Now therefore, in exercise of the said recited power and authority, I, Sir George Grey, Governor of New Zealand, with the advice and consent of the Executive Council thereof, do hereby alter the rates of postage payable within the Colony for the transmission of all letters, newspapers, and packets by post via Panama to or from the countries mentioned in the Schedule hereto, and in lieu thereof do fix the rates of postage so payable according to the rates mentioned in the following Schedule; and do hereby proclaim and declare that such alteration and substitution shall take effect from and after the twenty-sixth day of June, one thousand eight hundred and sixty-six.

Given under the hand of His Excellency Sir George Grey, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, at the Government House, at Wellington, and issued under the seal of the Colony this twenty-sixth day of June, in the year of our Lord, one thousand eight hundred and sixty-six.

THE following Articles of Agreement with the Panama, New Zealand, and Australian Royal Mail Company (Limited), for conveyance of Mails between Sydney and Auckland, are published for general information.

JAMES PATERSON, Postmaster-General.

ARTICLES OF AGREEMENT made this thirty-first day of May, in the year of our Lord one thousand eight hundred and sixty-six, between the Panama, New Zealand, and Australian Royal Mail Company (Limited), hereinafter styled the Contractors, of the one part, and Her Majesty's Postmaster-General of without charge to the Government, take care of, and

the Colony of New Zealand, in pursuance of the provisions of "The New Zealand Post Office Act, 1858," of the other part, witness that for the considerations hereinafter mentioned the said Constant of the consideration of the consideration of the constant tractors covenant with the said Postmaster-General and his successors in office, as follows:

1. The steamships "Prince Alfred" and "Auckland" shall, at the commencement of the Contract Service hereby provided for, and during the continuance of the same, be tight, staunch, and strong, properly manned and equipped for sea, and shall be employed as hereinafter mentioned, in the mail service between Sydney, in the Colony of New South Wales, and Auckland,

in the Colony of New Zealand.

2. One of the said steamships shall, within twenty-four hours after the arrival of the European mails at the port of Sydney aforesaid, in each month, leave that port for Auckland aforesaid, and shall deliver the mails at Auckland within one hundred and eighty hours from the hour of departure from Sydney: Provided that neither of the said steamships shall be required to wait at Sydney for the European mail more than ninety-six hours after its due date for arrival there, and that one of the said steamships shall leave Sydney for Auckland at the expiration of that time, unless detained at Sydney by the said Postmaster-General or his agent, to wait the arrival of the English mail there, for any time not exceeding a further period of ninety-six hours.

3. One of the said steamships shall leave Auckland on the thirtieth day of each month, not earlier than

two p.m. in the day.

4. All Post Office mails shall be shipped, transhipped, and landed as may be required either at Sydney or Auckland, by and at the expense of the Contractors, in a suitable and seaworthy boat for the purpose, to be furnished with effectual covering for the mails, and properly provided, manned, and equipped by the Contractors, to the satisfaction of the Post Office agent hereinafter mentioned.

5. That when so required by the Postmaster-General, the Contractors shall receive and allow to remain on board each of the vessels while employed in the performance of this contract, and also while remaining at Sydney, whether with or without mails on board, an agent or clerk of the New Zealand

Post Office.

6. That saloon fare, with a suitable first-class cabin, with appropriate bed, bedding, and furniture, shall, at the cost of the Contractors, be provided and appropriated by them for the exclusive use and accommodation of the said agent or clerk; and also (to the satisfaction of the Postmaster-General) a safe and proper place of deposit for the mails, and proper accommodation, including lighting, for enabling the mails to be sorted on board the said vessels, and that the crew of each of the said vessels shall, whenever so required, assist in conveying the mails between the mail-room and the sorting-room.

7. The sum of one hundred pounds shall be paid by the Contractors to the said Postmaster-General or his successors in office, if, on any occasion, either of the said steamships shall not sail at the appointed time, and an additional sum of one hundred pounds shall be in like manner paid for every delay of twenty-four hours in sailing after the appointed

8. In the event of either of the said steamships becoming disabled, the Contractors shall immediately at their own cost and charge, replace the same by another good and efficient vessel, to be approved of by the said Postmaster-General, of similar tonnage

and power, obtained by hire or otherwise.

9. If there be no Post Office agent or clerk on board, the masters of the said steamships shall,

the Contractors shall be responsible for, the receipt, safe custody, and delivery of the mails according to

the terms of this contract.

10. The Contractors and all officers of their vessels, when employed in the performance of this contract, and all seamen and servants of the Contractors, shall at all times punctually attend to the orders and directions of the said Postmaster-General, and of any of the officers or agents of the said Post Office, as to the receiving, landing, and delivery of the mails, &c.

11. All sums of money hereinbefore stipulated to be forfeited or paid by the Contractors, shall be considered as stipulated or ascertained damages, and may, at the option of the said Postmaster-General, or his successors in office, be deducted and retained by him or them, out of any money payable to the Contractors under this contract, or payment thereof may be entered as a debt due by the

Contractors to Her Majesty, with full costs of suit.

12. In case of habitual negligence or wilful default by the Contractors in the performance of this contract the said Postmaster-General, or his successors in office, may, by writing under his or their hand or hands, give to the Contractors one month's notice of an intention to determine this contract, and at the expiration of the said month this contract shall end and determine accordingly. But the Contractors shall be and continue subject to any liability which they may have incurred previously to such determination, and as though this contract had not been determined.

13. Any notice which the said Postmaster-General or his successors in office shall require to serve on the said Contractors, shall be deemed to be duly served when the same is delivered at the office of the said Company in Wellington, or to the master of either of the said steamships employed or used by

the Contractors under this contract.

14. For the faithful performance of all the covenants, stipulations and agreements hereinbefore contained, the Contractors bind themselves in the sum of four thousand pounds sterling, to be paid to our Sovereign Lady the Queen, Her heirs and successors, by way of stipulated or ascertained damages in manner following, that is to say—The sum of two thousand pounds in case of wilful failure or default on the part of the Contractors in the due performance of this contract or any part thereof, in respect of each or either of the said mail services hereby contracted for, that is to say—the service from New Zealand to Sydney, and the service from Sydney to New Zealand.

15. And in consideration of the due and faithful performance by the said Contractors of all the services hereby contracted to be performed by them, the said Postmaster-General, on behalf of the Colony of New Zealand, hereby covenants with the said Contractors to pay to them, or to their agent in New Zealand, for the said services, at the rate of two thousand eight hundred and fifty pounds for six months, by equal monthly instalments or payments of four hundred and seventy-five pounds, at the Colonial Treasury in Wellington, on the first day of each month, and also the further sum of eight pounds for each and every hour during which either of the steamships employed under this contract shall have been detained at Sydney by the said Postmaster-General or his agent, under the provisions of the second clause hereof.

16. It is lastly agreed by and between the said parties hereto that the service hereby contracted for commence on the first day thousand eight hundred and of June, shall one thousand eight hundred and sixty-six, and shall be carried on, and this contract shall continue in force until determined by notice under the provisions of the twelfth clause hereof, or until of dates, as hereinafter mentioned.
