WHEREAS by "The New Zealand Post Office Act, 1858," it is enacted that it shall be lawful for the Governor from time to time, by writing under his hand, to delegate to the Postmaster-General all or any of the powers vested in the Governor by this Act, except such powers as are conferred upon the Governor in Council and such powers as are conferred by clause XXII. of the said Act, and such delegation from time to time to alter or revoke as he shall think fit:

Now therefore I, Sir George Grey, the Governor as aforesaid, in pursuance and exercise of the said power and authority, do hereby delegate to the

Honorable JOHN HALL,

Postmaster-General of New Zealand, all the powers vested in me by the said in part recited Act except the powers conferred upon the Governor in Council and the powers conferred by clause XXII. of the said in part recited Act, to be held and exercised by him from time to time as he shall think fit, so long as he shall hold the said office of Postmaster-General.

W HEREAS by an Act of the General Assembly of New Zealand, intituled "The New Zealand Native Reserves Act, 1856," certain powers therein specified are vested in the Commissioners under the said Act; and whereas by another Act of the General Assembly of New Zealand, intituled "The Native Reserves Amendment Act, 1862," all the powers and authorities which by "The Native Reserves Act, 1856," are given to or vested in or which may be exercised by Commissioners appointed or to be appointed under that Act, shall vest in and may be exercised by the Governor; and it is by the said Act further enacted that the Governor may by Order in Council from time to time delegate all or any of the powers competent to the Commissioners under the said Act unto any person or persons, for any period, and subject to any regulations and restrictions or stipulations as may be specified in such Order:

Now therefore, His Excellency Sir George Grey, in exercise of the power and authority so vested in him as Governor as aforesaid, doth by this Order in Council delegate, until this Order shall be revoked, to

ALFRED ROWLAND CHETHAM STRODE, Esq., of Dunedin, all the powers competent to Commissioners under the said first recited Act, without any restrictions or stipulations whatever.

HIS EXCELLENCY THE GOVERNOE IN COUNCIL. WHEREAS by an Order in Council dated the seventeenth day of January, one thousand eight hundred and sixty-six, a certain district, designated as the Bay of Plenty District, was constituted a district within the provisions of "The New Zealand Settlements Act, 1863," and the lands within that district were reserved and taken for the purposes of settlement, and declared to be subject to the provisions of the said Act from the day of the date of such Order.

And whereas the boundaries of the said Bay of Plenty District, as specified in the Schedule to the said Order, were by mistake incorrectly stated; and it is expedient that the boundaries of the said district should be so amended and varied as to include the district intended to be included in the Order in Council of the seventeenth day of January, one thousand eight hundred and sixty-six:

Now therefore, His Excellency the Governor, in exercise of the power vested in him by the said Act, doth hereby, with the advice and consent of the Executive Council of the Colony of New Zealand, declare that the boundaries of the said Bay of Plenty District shall be the boundaries described in the Schedule hereto, instead of the boundaries described in the Schedule to the said Order in Council, and that from the day of the date hereof all the district the boundaries whereof are described in the Schedule the boundaries whereon are described in the Schedule hereto shall be a district within the provisions of "The New Zealand Settlements Act, 1863," and shall be designated by the name of the Bay of Plenty District, and doth hereby reserve and take the lands within the said district, as defined by this Order, for the purposes of settlements, and doth hereby declare that all such lands are required for the purposes of the said Act, and are subject to the provisions thereof from the day of the date hereof.

All that land bounded by a line commencing at the mouth of the Waitahanui River, Bay of Plenty, and running due south for a distance of twenty miles, thence to the summit of (Mount Edgecombe) Putanaki, thence by a straight line in an easterly direction to a point eleven miles due south from the entrance to the Ohiwa Harbour, thence by a line running due east for twenty miles, thence by a line to the mouth of the Aparapara River, and thence following the coast line to the point of commencement at Waitahanui. at Waitahanui.
