WHEREAS by "The Protection of Certain Animals Act Amendment Act, 1866," it is amongst other things enacted that the Act shall not come into force in any Province until proclaimed by the Governor in the New Zealand Gazette, and in the Gazette of the Province in which it shall be designed that it shall be brought into force, and only from a date to be fixed therein:

Now therefore, I, Sir George Grey, the Governor of the Colony of New Zealand, in exercise of the power and authority so vested in me by the above recited 'Act, do hereby proclaim and declare that "The Protection of Certain Animals Act, 1866," shall come into force in the Province of Otago, on and from the first day of February, one thousand eight hundred and sixty-seven.

WHEREAS by Proclamation bearing date the fourth day of September, one thousand eight hundred and sixty-five, I, Sir George Grey, Governor of the Colony of New Zealand, did proclaim and declare that Martial Law would be exercised throughout the Districts of Opotiki and Whakatane, from the date of the said Proclamation until the said Proclamation should be duly revoked. And whereas

it appears unto me expedient that the said Proclamation should be revoked:

Now therefore, I, Sir George Grey, the Governor as aforesaid of the said Colony, in pursuance and exercise of all powers and authorities in this behalf enabling me, do hereby proclaim and declare the aforesaid Proclamation of the fourth day of September, one thousand eight hundred and sixty-five, to be and the same is hereby revoked.

And I do further proclaim and declare that this Proclamation shall take effect on and from the twenty-sixth day of January, one thousand eight hundred and sixty-seven.

WHEREAS by "The Marriage Act Amendment Act, 1858," it is enacted that it shall be lawful for the Governor at any time, by proclamation in the New Zealand Gazette, to divide the Colony of New Zealand, for the purposes of the said Act, into such and so many districts as he may think fit, and that every such district shall be called by a distinct name, and shall be a Registrar's District; and it is provided that the Governor may at any time revoke the whole or any part of such proclamation, and issue a new proclamation, dividing the Colony or any part of it anew into districts, or

districts, as from time to time he may think

And whereas by a proclamation duly made and issued, bearing date the thirtieth day of November, one thousand eight hundred and sixty-five, the Governor, in pursuance of the said recited power and authority, did, amongst others, constitute a district for the purposes of the said Act, called the "East Taieri District," the boundaries whereof were therein set forth, which said proclamation came into operation and took effect on the first day of February, one thousand eight hundred and sixty-six.

And whereas it is expedient to revoke so much of the said proclamation as relates to the said district, and to divide anew the territory formerly comprised

within such district:

Now therefore, I, Sir George Grey, the Governor of the said Colony, in pursuance and exercise of the power and authority vested in me by the said recited Act, do hereby revoke the said proclamation so far as relates to the said district, and do proclaim and declare that the territory formerly comprised within such district shall be and is hereby divided for the purposes of the said Act into two districts, the names and boundaries whereof shall be as follows:

NORTH TAIERI DISTRICT

Comprises all that area bounded towards the North by the Waikouaiti Registration District; towards the East by the Dunedin Registration District to the south-eastern corner of Block IV. Dunedin and East Taieri Survey District; towards the South by a line round the southern boundary of the said block to the boundary line between sections numbered respectively 1 and 7, Block XIII. East Taieri Survey District; thence along that boundary line and its continuation in the same direction to the road line between Block VIII. and Irregular Block; thence along that road line to another road line between Block XIX. and Irregular Block; thence along that road line and its continuation to the Taieri River; and towards the West by the Taieri River.

EAST TAIERI DISTRICT

Comprises all that area bounded towards the North by the North Taieri Registration District; towards the East by the Dunedin Registration District; towards the South by the ocean; and towards the West by the Taieri River.

And I do declare that this proclamation shall come into operation and take effect on the eleventh day of February, one thousand eight hundred and sixty-

seven.

WHEREAS by "The Registration Act, 1858," it is enacted that it shall be lawful for the Governor at any time by proclamation in the New Zealand Gazette, to divide the Colony of New Zealand for the purposes of the said Act into such and so many districts as he may think fit, and that every

And whereas by a proclamation duly made and issued, bearing date the thirtieth day of November, one thousand eight hundred and sixty-five, the Governor, in pursuance of the said recited power and authority, did, amongst others, constitute a district for the purposes of the said Act, called the "East Taieri District," the boundaries whereof were therein set forth, which said proclamation came into opera-tion and took effect on the first day of February, one thousand eight hundred and sixty-six.

And whereas it is expedient to revoke so much of the said proclamation as relates to the said district, and to divide anew the territory formerly comprised

within such district:

Now therefore, I, George Grey, the Governor of the said Colony, in pursuance and exercise of the power and authority vested in me by the said recited Act, do hereby revoke the said proclamation so far as relates to the "East Taieri District," and do proclaim and declare that the territory formerly comprised within such district shall be and is hereby divided for the purposes of the said Act into two districts, the names and boundaries whereof shall be as follows:

WHEREAS by "The Intestate Estates Act, 1865," it is amongst other things enacted, that it shall

be lawful for the Governor in Council, from time to time, and as occasion may require, to appoint for each Province in the Colony a fit and proper person to act as Curator of Estates of Deceased Persons, and in like manner to remove such Curator or any successor in office of such Curator. And whereas by "The Intestate Estates Act Amendment Act, 1866, it is enacted that it shall be lawful for the Governor by proclamation published in the New Zealand Gazette from time to time to divide the Colony for the purposes of the said "Intestate Estates Act, 1865," and the said "Intestate Estates Act Amendment Act, 1866," into such and so many lines. into such and so many districts as he shall think fit, and every such district shall be called by a distinct name, and shall be a Curator's District, and in like manner from time to time and as he shall think fit, to abolish any such district, or alter or vary the boundaries of any district, or increase the number of such districts, provided that the Provinces of the Colony for which Curators have before the passing of the last-mentioned Act been appointed, shall be deemed to be districts defined pursuant to that Act, subject in every respect for the purposes of "The Intestate Estates Act, 1865," and "The Intestate Estates Act Amendment Act, 1866," to be abolished or to be varied or altered as if defined under the said last-mentioned Act, and the term "Province," wherever used in the said "Intestate Estates Act, 1865," shall mean "Curator's District," and the Curators appointed for such Provinces shall be deemed to have been appointed under and pursuant to the said "Intestate Estates Act Amendment Act, 1866." And whereas by an Order in Council bearing date the ninth day of May, one thousand eight hundred and sixty-six, Robert Pollock, Esquire, of Nelson, was appointed to act as Curator of Estates of Deceased Persons in and for the Province of Nelson: And whereas it is expedient to include the Province of Marlborough in the district to which the said Robert Pollock hath been appointed as aforesaid. therefore I, Sir George Grey, the Governor of the Colony of New Zealand, in pursuance and exercise of the power in me vested for this purpose, do hereby appoint that the Provinces of Nelson and Marlborough shall form one district for the purposes of the said Acts, and be called the District of Nelson and Marlborough, and that the said Robert Pollock, shall, for the purposes of the said Acts, be Curator of Estates of Deceased Persons in and for the said District of Nelson and Marlborough.

N pursuance of instructions in this behalf received by me from Her Majesty's Principal Secretary of State for the Colonies, I, Sir George Grey, the Governor of the Colony of New Zealand, do hereby appoint that all vessels belonging to or permanently appoint that all vessels belonging to or permanently in the service of the Colony, but not commissioned as vessels of war under "The Colonial Naval Defence Act, 1865," of the Imperial Parliament, shall bear a Blue Ensign with the following badge in the fly thereof, namely:—The letters "N. Z." in red, each letter to extend over an area of not less than eight inches high by eight inches broad, and to have its inches high by eight inches broad, and to have its lines not less than two inches broad, and surrounded by a margin of white not less than one inch in breadth, thus making the letters ten inches high over all, and four inches broad in the lines over all.—These dimensions are for a ten foot ensign, and are to vary in proportion with the dimensions of a larger or smaller flag.
