THEREAS by an Act made and enacted in the Imperial Parliament holden in the fifteenth and sixteenth years of the reign of Her Majesty Queen Victoria, intituled "An Act to grant a Representative Constitution to the Colony of New Zealand," it is amongst other things enacted, that whenever any Bill shall have been assented to by the Superintendent, as in the said Act provided, the Superintendent shall forthwith transmit to the Governor an authentic copy thereof, and it shall be lawful for the Governor, at any time within three months after any such Bill shall have been received by him, to declare by proclamation his disallowance of such Bill; and that any such disallowance shall make void and annul the same from and after the day of the date of such proclamation, or any subsequent day to be named therein.

And whereas the Ordinances hereinafter specified have been enacted by the Superintendent of Otago, with the advice and consent of the Provincial Council thereof, and the said Ordinances were received by the Governor on the twenty-first day of January, one thousand eight hundred and sixty-seven:
