G. GREY, Governor. A PROCLAMATION.

WHEREAS by an Act of the General Assembly of New Zealand, intituled "The Supreme Court Act, 1860," it is provided that there shall be held Circuit Courts for the despatch of civil and criminal business of the Court before one of the Judges thereof, at such times and places as the Governor in Council may from time to time appoint; and whereas by a proclamation dated the thirteenth day of April, one thousand eight hundred and sixtythree, Circuit Courts were appointed to be held for the middle district of the said Colony, at the town of Nelson and at the town of Napier, on the several days therein respectively mentioned, and it is expedient that the times so appointed for the holding of such Courts at Napier aforesaid should be altered as hereafter set forth:

Now therefore I, Sir George Grey, the Governor of the Colony of New Zealand, by and with the advice and consent of the Executive Council of the said Colony, do hereby, in pursuance and exercise of the power and authority in me vested for this purpose, proclaim and appoint that Circuit Courts for the Middle District of the said Colony shall be held, for the despatch of criminal and civil business of the Court, before the Judge thereof to whom the said district has been assigned, at the town of Napier, on the eighth day of May and the eighth day of November, in every year, or as soon after the said days respectively as conveniently may be; and in case any one of the said days so fixed as aforesaid shall happen to be a Sunday or holiday, then the Court appointed for such day shall be holden on the day following.

Given under the hand of His Excellency Sir George Grey, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, at the Government House, at Wellington, and issued under the Seal of the said Colony, this seventh day of October, in the year of our Lord one thousand eight hundred and sixty-seven.

WHEREAS by "The Gold Fields Act, 1866," it is provided that it shall be lawful for the Governor at any time subsequent to the proclamation of a Gold Field, to withdraw by proclamation there-from any Crown Lands which he may deem it necessary to withdraw.

ATHEREAS by "The Gold Fields Act, 1866, it is amongst other things enacted that it shall be lawful for the Governor, by Order in Council, from time to time to constitute for any Gold Field, or for any part thereof, Wardens' Courts, for the administ tration of justice therein, and to appoint Wardens of such Courts with power to act alone or with assessors, and in such manner and to exercise all or any of the powers thereinafter mentioned as the Governor shall think fit to direct:

Now therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council of the Colony doth hereby, in pursuance and exercise of the power and authority vested in him for this purpose, appoint

ALLAN BAILLIE, Esq.,

to be a Warden of all Wardens' Courts now constituted or hereafter to be constituted within the Gold Fields of the Province of Aucklaud, with power to him to act alone or with assessors, and to exercise all or any of the powers vested in or imposed on Judges of Wardens' Courts.

Now the condition of the above-written obligation s such that if the said from time to time, so long as he shall continue and be employed in the said office, shall duly perform the duties of the said office, and duly account for and pay over all moneys which shall come to the possession, or be under the control of himself or his agents, by reason of or by virtue of the said office or employment; and shall from time to time observe and keep all such orders and instruc-tions as he shall receive from the Governor of New Zealand for the time being touching the due performance and execution of the said office; and shall from time to time, and at all times hereafter, so long as he shall hold the said office, well and truly, faithfully and honestly, to the best of his skill and ability, exercise, obey, discharge, and perform all the duties thereof, and also all the powers, directions, duties, and obligations given to, conferred upon, or to be per-formed and discharged by him under any law for the time being relating to the said office; and shall, when thereunto required, deliver up all books, deeds, orders and decrees of the Judges of the District Court or of the Supreme Court, vouchers, and other papers relating to the said office, and also such commission, warrant, or authority as he hath received or shall receive from the Governor, to such person as the Governor shall direct and appoint to receive the same, then this obligation to be void and of none effect, or else to remain in full force and virtue: provided always that no more than the sum of two hundred and fifty pounds shall be recoverable from each of them the said sureties by virtue of the abovewritten obligation.

WHEREAS by "The District Court Act, 1858," V it is provided that there shall be within the Colony Courts of Record, possessing civil and criminal jurisdiction, to be called District Courts, and the Governor is empowered from time to time, by notification in the New Zagland Capatte to fin by notification in the New Zealand Gazette, to fix the times and places within the district at which every such court shall be held; and whereas, by a notification, bearing date the nineteenth day of March, one thousand eight hundred and sixty-seven, certain times and places were fixed for holding sittings of the District Court of Westland, and it is expedient to alter the same and to appoint other times and places in lieu thereof:

Now therefore, I, Sir George Grey, the Governor of the Colony of New Zealand, do hereby, in pursuance and exercise of the said power and authority in me vested for this purpose, fix that sittings of the District Court of Westland shall be held at Hokitika, in the Province of Canterbury, in the Supreme Court House there, for the despatch of civil and criminal business, on the following days, that is to say—on the first Tuesday in January, the third Tuesday in March, the first Tuesday in May, the Tuesday in March, the first Tuesday in May, the first Tuesday in July, the third Tuesday in September, and the second Tuesday in December in every year; at Greymouth, in the said Province of Canterbury, in the Resident Magistrate's Court House there, for the despatch of civil business only, on the following days, that is to say-on the third Tuesday in January, the second Tuesday in March, the second Tuesday in May, the third Tuesday in July, the first Tuesday in October, and the first Tuesday in December in every year; and, at Westport, in the Province of Nelson, in the Resident Magistrate's Court House there, for the despatch of civil and criminal business, on the following days, that is to say—on the second Tuesday in February, the first Tuesday in June, the third Tuesday in August, and the third Tuesday in November, in every year.
