WHEREAS by "The Native Lands Act, 1867," it is among other things provided that in any case where under the said Act ("Native Lands Act, 1867,") the Court would not have had jurisdiction, it shall be competent to the said Court to inquire into and determine any question affecting the sub-division of or any title to or interest in any Native Reserve which may be referred to it by the Governor. And whereas it is expedient that it should be ascertained who are the Natives interested in the Native Reserves mentioned in the Schedules hereunto attached, and that the said Reserves should be subdivided accordingly, being Reserves in respect of which the assent of the aboriginal inhabitants to the bringing of the said Reserves under the operation of "The Native Reserves Act, 1856," has been

Now therefore, I, Sir George Grey, the Governor of the Colony of New Zealand, in exercise of the powers vested in me in that behalf, do hereby refer to the Mitive Lands Court to determine who are the Natives terested in each of the Reserves hereunder described, and to order the subdivision of the same among those Natives who may be so interested in such manner as to the said Court shall seem fit, and to order certificates to be issued according to the plan of such subdivision in such or like manner as is provided in the seventeenth section of "The Native Lands Act, 1867."

Given under the hand of His Excellency Sir George Grey, Knight Commander of the Most Honorable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, at the Government House, at Wellington, this second day of November, in the year of our Lord one thousand eight hundred and sixty-seven.

SCHEDULE A.

All that piece of land situate at Porirua, commencing at Te Urukahika by the stream running into Porirua Harbour, thence running inland to Pokawhenua, thence to Rangituhi, thence to the

Takapuwahia stream, thence to Hamutawa, thence to the Huhikarito stream, and down the stream to the Porirua Harbour, thence along the beach and joining at Te Urukahika.

SCHEDULE B.

All that piece of land situate at Porirua, District of Wellington. The boundary commences at Ngapekerere, thence to Hamutawa, thence along the boundary of the land previously given up to the Commissioner to Rangituhi, thence along the said boundary to Te Urukahika, thence to Putaputa (the boundary of Ellison's land), thence along that boundary to Ngapekerere where it joins.

SCHEDULE C.

All that piece of land situate at Porirua, District of Wellington, the boundaries of which commence at Paparaumu, thence along the southern boundary of Ellison's land (section 109,) to Putaputa, thence along the hills to Te Rata; here it turns and goes along the boundary of the Queen's land to the Arataura on the sea coast, thence it is bounded on West by the respect to Paparaumu. SCHEDULE D.

All that piece of land situate at Porirua, Wellington, bounded North, by section 101; East by boundary between Native and Crown Land; South by the Aotea stream to its source, and thence in a straight line to the eastern boundary; and West by the Porirua Harbour, containing about 300 acres, more or less.

SCHEDULE E.

All that piece of land situate at Porirua, bounded towards the North by the Aotea stream, and by the surveyed line of Wi Parata's land; East and South by the Kenepuru stream to its mouth, and by Crewn Land; West by Porirua Harbour.

THE following sections of "The Native Lands Act 1867," relating to Interpreter's certificates and Surveyor's licenses, are published for general information.

7. The Governor or the Chief Judge of the court, may grant certificates to such persons as they respectively think fit, authorizing them to act as respectively think fit, authorizing them to act as interpreters under the said Act and this Act, or may revoke the same, and no person shall act as interpreter under the said Act or this Act, either in court, or ander the thirty-first section of this Act, who does not hold such certificate.

30. A fee of five pounds shall be payable in respect of every surveyor's license or warrant heretofore or

of the said Act, and such fee shall be payable to the Inspector of Surveys, who shall endorse a receipt of the same upon the license, and shall remit the same to the Colonial Treasurer; and no license heretofore granted shall be valid after the first day of January one thousand eight hundred and sixty-eight, unless such endorsement shall have been made upon it.
